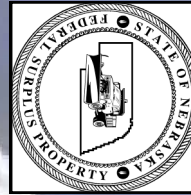

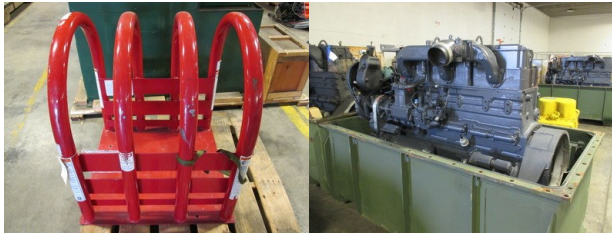

What is the “Federal Surplus Property Program”?

Personal property no longer needed by the Federal Government is available for donation to eligible organizations through the Federal Surplus Property Program. Property is screened nationwide & even overseas, & donated to your organization through our agency. Participants are assessed a service charge covering shipping, handling & administrative expenses. Usually, the charges are considerably less than the original cost of the property.



Why Surplus Makes Sense

The Federal Government generates useable property excess to their needs. To insure maximum utilization of such property, excess items are made available to other federal level, surplus items are then made available to Federal Surplus Property Agencies for screening. The goal of the Nebraska Federal Surplus Property Agency is to make property available to eligible organizations, within the State of Nebraska, on a fair & equitable basis. With consideration given to eligible donees relative resources, needs & ability to utilize the property within the limits of the Nebraska State Plan of Operation.

Is My Organization Eligible to Receive Federal Property?

Typically Eligible Organizations:
Public Agencies
Nonprofit Educational or Public Health Institutions



Nonprofit & Public Programs & Veterans Organizations



Service Educational Activities

What Restrictions Are Placed on the Donee?

Generally, the donee must agree to place the property into use within their state & within one year of the acquisition & to continue the property's use for:

- One year - for property with a unit acquisition value of less than \$5,000
- Eighteen months - for passenger motor vehicles or any item of property having a unit acquisition value of \$5,000 or more,
- Five years - for aircraft & vessels 50 feet or more in length
- In perpetuity - for combat-configured aircraft & firearms.



What Restrictions Are Placed on the Property?

- All property must be placed into use within one year.
- Property must be used for a period of 12 to 18 months depending on the value.
- Property is restricted to organizational use only.
- Property cannot be sold, loaned, leased, traded or transferred during its compliance period.
