Nebraska.gov offers numerous services that are available all year. The following is a list of services that are only offered during specific times during the year.

### Secretary of State

Foreign and Domestic Corporation Tax Reports have a filing deadline of March 1, with the extended period for filing until April 15. This is the first year that this service is offered online.

### Corporation Tax Reports

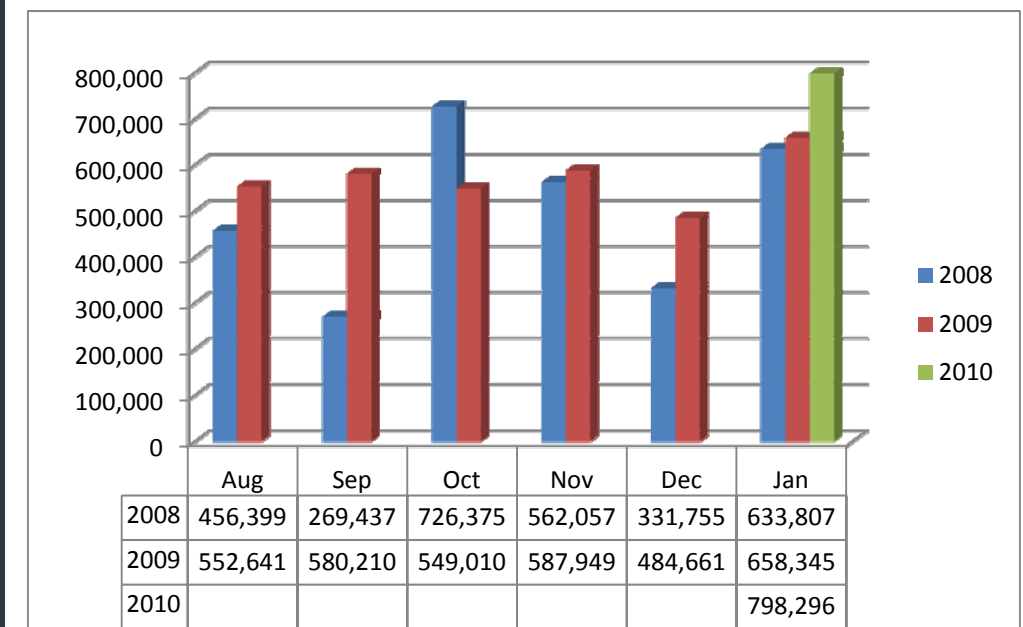
The newest online service for the Secretary of State has been available for the past month.

After one month, there have been 1,641 Foreign Corporation Tax reports filed and 768 Domestic Tax reports filed online.

The Secretary of State's office saves 10-12 minutes for each Foreign report and 8-10 minutes for each domestic report that is filed online. This is a great savings in personnel processing time.

For January 2010, \$338,284 was collected in taxes using the online filing system.

It is time for the 2010 Nebraska Spirit Art Contest!

### Just Completed...

#### Court E-filing

An enhancement for the Court E-filing system has been completed. This has created more efficiency, as it has eliminated a manual process for the Courts.

#### Payment System

Nebraska.gov has completed transitioning all agencies to the upgraded payment system. This has created time savings for the agencies when reconciling the transactions and deposits.

### Coming soon...

#### Driver License Renewals and Duplicates

Nebraska.gov and the Department of Motor Vehicles are developing a system that will give people the ability to renew their driver license online. One will also be able to request duplicate driver license and State ID cards with this system.
