The Commission, on its own motion, opened this proceeding to adopt Reverse Auction and Wireless Registry rules and regulations in Title 291, Chapter 16, in accordance with Legislative Bill 994 [2018]. The Commission proposed to amend Title 291, by adding Reverse Auction and Wireless Registry Rules and Regulations which were attached to its Order opening the docket. Subsequently, at the hearing on May 7, 2019, commenters recommended that the Commission schedule a workshop to discuss modifications to the rule amendments.
