

LICENSING AGREEMENT

I, Julie Tracy, hereby state and declare:

I am the Licensee of Family Child Care Home I, known as Julie Tracy, License #FI5295, located at 1411 N. Lincoln, Lexington NE 68850. Under the terms of my license, I am allowed to serve a maximum of 10 children, ages 6 weeks to 13 years, 24 hours, Monday through Sunday.

I have read, understand and agree to comply with all the Regulations Governing Licensure of Family Child Care Home I's, Title 391, Chapter 1 (CSL001) as long as I am licensed by the State of Nebraska to provide child care services.

I understand that this agreement is based on a complaint inspection conducted on June 6, 2016., in which the following violations were noted:

391 NAC 1-006.01 Licensee Qualifications: "The Family Child Care Home I licensee must: #7. Be in compliance with all regulations whenever any children are in care."

391 NAC 1-006.22 Food Safety: "The licensee must store, prepare, protect, serve, and dispose of food in a safe and sanitary manner, as follows: #8. All food preparation areas must be easily cleanable and in good repair; #10. All utensils, equipment, and food storage areas must be kept clean and in good repair."

391 NAC 1-006.24 Environmental Services: "The licensee must provide child care in a safe, clean, comfortable environment. Every area and building on the same premises used for child care must comply with these regulations."

391 NAC 1-006.24A Housekeeping and Maintenance: The licensee must provide the necessary housekeeping and maintenance to protect the health and safety of children in care. The child care home and grounds must be kept clean, safe, and in good repair. #2. Rooms, walls, floors, and ceilings must be kept clean, in good repair, and free of odor resulting from sewage, mold, mildew, or other environmental or biological hazards or unsanitary conditions."

391 NAC 1-006.24B Maintenance of Equipment, Fixtures, Furnishings, and Toys: 1. The licensee must keep equipment, fixtures, furnishings, and toys used in the child care program clean, safe, and in good repair."

391 NAC 1-006.25 Environmental Safety: "The licensee is responsible for maintaining a safe and hazard-free environment."

391 NAC 1-007 Physical Plant Standards: "The child care home must be maintained in a manner that is safe, clean, and functional for child care. The following regulations apply to all areas of the child care home used for child care."

391 NAC 1-007.03 Outdoor Play Areas: An outdoor play area must be available. "The area must: #2. Be kept clean and safe and contain no accident hazards, debris, or stagnant water."

I agree and understand that all food storage areas, floors, countertops, and tables in the home will be kept clean by providing the necessary housekeeping and maintenance such as vacuuming, sweeping, and mopping the floors, putting away items not being used by the daycare children, and keeping all areas free of clutter (tables, countertops, floors, and food storage areas), and regularly sanitizing the surfaces of all countertops and tabletops.

I agree and understand that the outside play area will be free of any items that would provide a possible hazard or would not be safe for children in care.

I agree that this Licensing Agreement will be prominently posted with my Family Child Care Home I License so that it is clearly visible to parents and agency representatives.

I understand that Children's Services Licensing staff shall conduct announced or unannounced visits to my program to determine compliance with this Agreement. Any violation of this Agreement may be grounds for further negative action or discipline as the Nebraska Department of Health and Human Services, Division of Public Health, Children's Services Licensing may deem appropriate.

This Agreement shall be effect from the signing of this Agreement for a period of six months at which time it will be reviewed by the Department to determine if the Agreement should be amended, modified or terminated. Should the Family Child Care Home I change of address occur, this Licensing Agreement may transfer to the new address if appropriate to the conditions of the Licensing Agreement.
