I, hereby state and declare:

1. I am the owner/registered agent of the above-mentioned childcare program.
2. I have read, understand and agree to comply with all the Regulations Governing Licensure of Family Child Care Home Is, Title 391, as long as I am licensed by the State of Nebraska to provide child care services. Specifically,

391 NAC 3-006 STANDARDS OF OPERATION AND CARE: "To provide adequate protection to children in care and to comply with state law, a childcare center must meet the following standards."

391 NAC 3-006.01 Licensee Requirements: "The licensee must ... 2. Maintain compliance with all applicable state statutes and childcare center regulations

391 NAC 3-006.02 Director Requirements: "The director is responsible for managing the day-to-day operations of the child care center. The director must report to the licensee all matters related to the maintenance, operation, and management of the childcare center and be directly responsible to the licensee or to a person delegated governing authority by the licensee. The director must 1. Be responsible for the center's compliance with rules and regulations;" ...

391 NAC 3-006.15B Staffing Requirements

- “1. All staff must be awake and alert to the needs of the children at all times, including napping/sleeping times.
2. Each room where children are receiving care must have a teacher who is involved with the direct care of children” ...

391 NAC 3-006.19 Supervision of Children: Adequate and appropriate supervision must be provided to children at all times children attend, including during outdoor play. Ultimate responsibility for supervision rests with the licensee.

3. I understand and agree with the following:

- A. I understand all children in the facility must be supervised at all times, and a teacher must be in rooms where children are receiving care at all times.
 - B. I acknowledge that this Agreement is the result of self-reported events on March 8, 2018. On March 8, 2018, a staff member left a room to take children to the lunchroom for snack, and one child was left alone in the room. Another staff person was in the hallway, and noticed the child in the room and brought the child down to snack. The director estimates the child was left alone for approximately one minute.
 - C. This Licensing Agreement will be prominently posted with the current license so it is clearly visible to parents and Department representatives.
 - D. I understand that Children's Services Licensing staff shall conduct announced or unannounced visits to my program to determine compliance with this Agreement
4. Any violation of this Agreement may be grounds for further negative action or discipline.
5. This Agreement shall be in effect from the signing date for 6 months. Should the license be amended because of a change of address, this Agreement may transfer to the new address if appropriate to the conditions of this Licensing Agreement.

LICENSING AGREEMENT

I, Connie Hilker, Board President, and designated signee, Loving Hearts Child Development Center, 4710 North 10th Street, Lincoln, Nebraska, 68521, hereby voluntarily state and declare:

I have read and understand the Child Care Center Standards (CRED-PB-365).

I agree to comply with each of the Child Care Center Standards as long as I am licensed by the State of Nebraska to provide child care services.

Licensee agrees that it and its representatives have the authority to enter into this Licensing Agreement.

I understand and agree to comply with 391 NAC 8-020.06 which states: "Locked storage is provided solely for drugs." (Standard 40, Page 16)

I agree and understand that on July 7, 2011 and December 29, 2011, the program was found in violation of locked storage for drugs as documented by an inspection conducted by Children's Services Licensing.

I also agree that this Agreement will be prominently posted with the Child Care Center license so it is clearly visible to parents and Department representatives.

I understand that Children's Services Licensing staff shall conduct announced or unannounced visits to the facility to determine compliance with this Agreement.

Any violation of this Agreement may be grounds for further negative action or discipline as the Department of Health and Human Services, Division of Public Health, Children's Services Licensing may deem appropriate.

This Agreement shall be in effect from the signing of this Agreement until six months after the signing of this agreement. Should the Child Care Center license be amended because of a change of address, this Licensing Agreement may transfer to the new address if appropriate to the conditions of the Licensing Agreement.
