Licensing Agreement

I, Lisa Cumberledge, 5816 N. 104th St. Omaha, NE 68134 hereby voluntarily state and declare:

I have read and understand the Nebraska Administrative Code and Regulations governing Licensure of Child Care Home I's.

I agree to comply with each of the Child Care Home I Regulations as long as I am licensed by the State of Nebraska to provide child care services.

Licensee agrees that it and its representatives have the authority to enter into this Licensing Agreement.

I understand that this revised Licensing Agreement is a result of David Cumberledge being in the home during the hours of operation. The Licensing Agreement that was signed on 9-19-13 stated that David Cumberledge was not to be on the premises during the hours of operation due to a conviction in Iowa for Misdemeanor Drug Possession of a Controlled Substance and Misdemeanor Possession of Drug Paraphernalia on August 8, 2013.

On 3-21-17 the Department became aware that David Cumberledge has been in the home during the hours and days listed on the Family Child Care Home I license. This resulted in the violation of the following regulations:

391 NAC 1-006.03C Household Members: "3. Not allow any household member who engages in behavior injurious to or which may endanger the health or morals of children to provide care or be on the premises."

391 NAC 1-006.01 Licensee Qualifications and Requirements: "14. Not knowingly allow any individual to be on the premises if s/he has been convicted of, admitted to, or there is substantial evidence of, crimes involving intentional bodily harm, crimes against children, crimes involving the illegal use of controlled substances, or crimes involving moral turpitude."

I understand and agree that under no circumstances, because of his criminal history, will David Cumberledge, household member, be allowed on the child care premises during the hours and days listed on my Family Child Care Home I license. Premises is defined as "the home, including areas of the home not used for child care/preschool, all attached and all outbuildings, and all areas included within the lot boundaries."

I agree to provide information in writing to the Department within ten calendar days from the signing of this Agreement, the name and address and telephone of the primary location of David Cumberledge and where he will stay if he is unable to be at the primary location and where he will stay should he be ill.

Information shall be sent to: Stef Sellers, Child Care Inspection Specialist, Children's Services Licensing, Licensure - Division of Public Health, 1313 Farnam St., 3rd floor, Omaha, Nebraska, 68102.

In addition, I agree to notify all parents of children enrolled in my program and parents of future enrollees by providing the Department a copy of the Acknowledgment of Licensing Agreement signed by the parent(s) of all children in care within ten calendar days from the signing of this Agreement. Acknowledgments from parents of future enrollees are due to the Department within fifteen calendar days from the date of enrollment. A copy of this Acknowledgment is attached to this Agreement. These Acknowledgments will be sent to the Department, Attn: Stef Sellers, at the above address.

I understand that Children's Services Licensing staff shall conduct announced or unannounced visits to my program to determine compliance with this Agreement.

I agree that this Licensing Agreement will be prominently posted with my Family Child Care Home I License so that it is clearly visible to parents and agency representatives.

Any violation of this Agreement may be grounds for further negative action or discipline as the Nebraska Department of Health and Human Services, Division of Public Health, Licensure, Children's Services Licensing may deem appropriate.

This Agreement shall be effective from the signing of this Agreement for as long as David Cumberlandge is a household member, or until 8-8-18 (5years from conviction). In addition, should a change of address occur or should I reapply for a different type of child care license, this Licensing Agreement may transfer to the new license and/or address if appropriate to the conditions of this Licensing Agreement.

I understand that this Licensing Agreement nullifies the previous Licensing Agreement signed on 9-19-13 by Lisa Cumberlandge.

LICENSING AGREEMENT

I, Lisa Cumberledge, 5816 N. 104th St. Omaha, NE 68134 hereby voluntarily state and declare:

I have read and understand the Nebraska Administrative Code and Regulations governing Licensure of Child Care Home I's.

I agree to comply with each of the Child Care Home I Regulations as long as I am licensed by the State of Nebraska to provide child care services.

Licensee agrees that it and its representatives have the authority to enter into this Licensing Agreement.

I understand that this Licensing Agreement is a result of David Cumberledge being convicted in Iowa for **Misdemeanor Drug Possession of a Controlled Substance and Misdemeanor Possession of Drug Paraphernalia**. This resulted in the violations of the following regulations:

1-006.03C Household Members: For each household member, the licensee must:

3. Not allow any household member who engages in behavior injurious to or which may endanger the health or morals of children to provide care or be on the premises.

1-006.01 Licensee Qualifications and Requirements: The Family Child Care Home I licensee must:

14. Not knowingly allow any individual to be on the premises if s/he has been convicted of, admitted to, or there is substantial evidence of crimes involving intentional bodily harm, crimes against children, crime involving the illegal use of controlled substances, or crimes involving moral turpitude.

POST-SIGNATURE REQUIREMENT

I understand and agree that Lisa Cumberledge will develop a written plan to address the violation of the regulations and to ensure that David Cumberledge is not on the premises during the hours and days listed on the license. At the signing of this licensing agreement, Mr. Cumberledge is employed outside of the child care home. This plan is to be submitted, for approval, to Stef Sellers, Child Care Inspection Specialist, Children's Services Licensing, Licensure – Division of Public Health, 1801 North 73rd Street, Omaha, Nebraska, 68114. This plan must be submitted to Ms. Sellers by September 20, 2013.

- I understand and agree that once the plan is approved, it is my responsibility to ensure that I follow it.

I agree that this Licensing Agreement will be prominently posted with my Child Care license so it is clearly visible to parents and Department representatives.

I agree to have each enrolled family sign a statement that they have received a copy of this licensing agreement and it shall be part of the child's file for department review.

I understand that Children's Services Licensing staff shall conduct announced or unannounced visits to my home to determine compliance with this Agreement.

Any violation of this Agreement may be grounds for further negative action or discipline as the Department of Health and Human Services, Division of Public Health, Children's Services Licensing may deem appropriate.

This Agreement shall be in effect from the date of signature, and throughout the duration of my licensure as a family child care home. I understand that I can request a review of this agreement at the end of one year, at which time the department can amend the conditions of this agreement or keep the conditions as they are listed. Should the Child Care Home I license be amended because of a change of address, this Agreement may transfer to the new address if appropriate to the conditions of the Licensing Agreement.
