**NOTICE:**

Pat's Child Care owned by Patricia Morton, (hereinafter referred to as "Morton") is notified that the Department of Health and Human Services, Division of Public Health, (hereinafter referred to as "Department") is imposing disciplinary action against Morton's Family Child Care Home II license, for violation of the following statutes and regulations:

**AUTHORITY:**

Nebraska Revised Statutes, section 71-1919, of the Child Care Licensing Act provides that "the Department may ... take disciplinary action against a license issued under the Child Care Licensing Act on any of the following grounds: (1) Failure to meet or violation of any of the requirements of the Child Care Licensing Act or the rules and regulations adopted and promulgated under the act;"

Nebraska Revised Statutes, section 71-1920, of the Child Care Licensing Act provides that "...the Department may impose any one or a combination of the following types of disciplinary action against a license issued under the Child Care Licensing Act: ...(c) impose a civil penalty of up to five dollars per child, based upon the number of children

for which the program is authorized to provide child care on the effective date of the finding of violation, for each day the program is in violation; ...”

391 NAC 2-008.01 Grounds for Denial or Disciplinary Action: “The Department may deny the issuance of or take disciplinary action against a license on any of the following grounds: 1. Failure to meet or violation of any of the requirements of the Child Care Licensing Act or the rules and regulations adopted and promulgated under the Act; ...”

391 NAC 2-006.01 Licensee Qualifications and Requirements: “The Family Child Care Home II licensee must ...7. Be in compliance with all regulations whenever any children are in care...”

391 NAC 2-006.02A Criminal History Record Check: “The applicant/licensee must complete a pre-employment criminal history record check through a governmental law enforcement agency on him/herself, each staff member and volunteer age 19 or older, and each household member age 19 or older if the child care home is a private residence. Documentation must be kept and available for review by the Department...”

391 NAC 2-006.02B Registry Checks: “The applicant/licensee, staff, volunteers, and household members if the home is a private residence, must not be listed as a perpetrator of abuse or neglect on Nebraska’s:

1. Child abuse/neglect central register, if the individual is age 13 or older;
2. Adult protective services (APS) central registry, if the individual is age 18 or older; or
3. State Patrol sex offender registry...”

391 NAC 2-006.2C Reports of Law Enforcement Contact: “The applicant/licensee must complete a Report of Law Enforcement Contact for him/herself and must obtain a completed report for each staff member and volunteer age 19 or older and household member age 19 or older if the home is a private residence. The report must: 1. Be updated, signed and dated annually;...”

391 NAC 2-006.02F Health Information Report: “All staff who are responsible for the care and supervision of children more than 20 hours per week must complete the report within 30 days of hiring. The Health Information Report must be completed annually.”

391 NAC 2-006.05 Employee Records Requirements: The licensee must ensure the following records are maintained, updated as needed, and made available to the Department upon request.

391 NAC 2-006.05A Primary Provider and Staff: Records for the primary provider and for all staff, except substitutes and volunteers, must include:

1. Name;
2. Address and telephone number;
3. Social Security number;
4. Date of hire/termination;

5. A completed Report of Law Enforcement Contact;
6. Documentation of a criminal history record check;
7. A completed Health Information Report; and
8. Documentation of Nebraska registry checks with no adverse findings;
9. Documentation of training; and
10. Documentation that the individual has read and understands these regulations.

## **FACTS:**

On September 8, 2017, Lori Pflanz, Child Care Inspection Specialist, Nebraska Department of Health and Human Services, Division of Public Health, (hereinafter referred to as "Pflanz") conducted an unannounced annual inspection. At that time, Pflanz identified numerous non-compliances and required that they be corrected by October 8, 2017.

On October 26, 2017, Child Care Licensing Specialist Kathee Sanchez (hereinafter referred to as "Sanchez") sent Morton a letter indicating verification of compliance with regulations was required by November 8, 2017.

As of November 16, 2017, documentation has not been made available for Department review, therefore, the following regulations remain in violation:

- Criminal history records check on secondary provider.
- Registry check (APS/CPS) along with a sex offender registry check on secondary provider.
- Report of Law Enforcement Contact for Morton, household members and secondary provider.
- A Health Information Report for secondary provider.
- Information in the Primary Providers and Staff records which includes: Name; Address and telephone number; Social Security number; Date of hire/termination; A completed Report of Law Enforcement Contact; Documentation of a criminal history record check; A completed Health Information Report; Documentation of Nebraska registry checks with no adverse findings; Documentation of training; and Documentation that the individual has read and understands the regulations.

## **DISCIPLINARY ACTION IMPOSED:**

Based upon the facts presented above, the Department intends to impose the following:

1. Morton is assessed a civil penalty in the amount of \$12.00 per day (\$1.00 times license capacity of 12 children) from the effective date of this Notice, December 7, 2017, and for each day thereafter that Morton fails to submit corrections / documentation that

all of the outstanding non-compliances noted at the inspection conducted on September 8, 2017 have been corrected.

Documentation must be submitted to Lori Pflanz, Child Care Inspection Specialist, Children's Services Licensing, Licensure Unit, Division of Public Health PO Box 94986 Lincoln, NE 68509, or at such other address as directed in writing by the Department. Once Pflanz has received and verified the required submitted written documentation, which may require an on-site inspection, Morton, will be informed in writing of the total of the civil penalty, which will be due 30 calendar days from the date of the notification to Morton.

Said penalty will then be payable to the Nebraska Department of Health and Human Services, Division of Public Health. Said penalty is to be sent to Chris Kort, Administrative Assistant, Nebraska Department of Health and Human Services, Division of Public Health, Licensure, P.O. Box 94986, Lincoln, Nebraska, 68509-4986.

2. Morton must comply with all of the terms of this Notice by submitting the required documentation as indicated above by or on December 6, 2017.
3. Failure to comply with the terms of this disciplinary action, the applicable Family Child Care Home II regulations and failure to correct the violations may be grounds for revocation or such other discipline as the Department may deem appropriate after notice to the licensee and an opportunity for a hearing.

**BE ADVISED:**

Pursuant to Nebraska Revised Statutes, section 71-1922, this action becomes final on December 6, 2017, unless the Department receives a written request for a hearing on or before such date. The license shall continue in effect until the final order of the director if a hearing is requested. If the director does not receive such request on or before such date, the action of the Department is final.



Nebraska Revised Statutes, section 71-1920 of the Child Care Licensing Act, provides that "any fine imposed and unpaid under the Child Care Licensing Act shall constitute a debt to the State of Nebraska which may be collected in the manner of a lien foreclosure or sued for and recovered in any proper form of action in the name of State of Nebraska in the district court of the county in which the program is located."



**NOTICE:**

Patricia Bush Morton (hereinafter referred to as "Bush Morton") is notified that the Department of Health and Human Services, Division of Public Health, (hereinafter referred to as "Department") intends to impose disciplinary action against Bush Morton's Family Child Care Home II license for violation of the following:

**AUTHORITY:**

Nebraska Revised Statutes, section 71-1919, of the Child Care Licensing Act provides that "the Department may ... take disciplinary action against a license issued under the Child Care Licensing Act on any of the following grounds:

- (1) Failure to meet or violation of any of the requirements of the Child Care Licensing Act or the rules and regulations adopted and promulgated under the act; ...
- (4) Conduct or practices detrimental to the health or safety of a person served by or employed at the program;

Nebraska Revised Statutes, section 71-1920, of the Child Care Licensing Act provides that "...the Department may impose any one or a combination of the following types of disciplinary action against a license issued under the Child Care Licensing Act: (a) issue a probationary license; ... (c) impose a civil penalty of up to five dollars per child, based upon the number of children for which the program is authorized to provide child care on the effective date of the finding of violation, for each day the program is in violation; ..."

391 NAC 6-004.01 in pertinent part: "The child care provider and/or household members shall not engage in or have a history of behavior injurious to or which may endanger the health or morals of children." (Page 4, Standard 23, Family Child Care Home Standards, Rev. 4/12)

**FACTS AND FINDINGS:**

Bush Morton is the licensee of an operating Family Child Care Home II. This program was licensed on April 6, 2007 and is licensed for a maximum of 12 children, ages six weeks to 13 years, 24 hours a day, seven days a week.

Prior to a license being issued to Bush Morton, the Department required that Bush Morton enter into a Licensing Agreement prohibiting Bush Morton's sons, Christopher and Etavius Bush, from the child care

premises any time child care children were in attendance. Bush Morton signed this Agreement on December 12, 2006.

On September 4, 2012, Department staff conducted a complaint investigation to Bush Morton's program after receiving allegations that a four-year-old child had received an injury while in care at Bush Morton's. The complaint alleged that Christopher Bush (hereinafter referred to as "Christopher") had used a shoe that belonged to Bush Morton to hit a child care child.

Information obtained from the Lincoln Police Department shows that on August 30, 2012, law enforcement was contacted regarding a child abuse case. The child's grandmother had observed a large red area and welt on the front of the child's upper left leg after being picked up from Bush Morton's care at approximately 4:00 p.m. The child was crying at the time. The child informed the grandmother that Christopher had struck her on the leg with a black shoe because he was "mad" at her. Christopher is the fiance of the child's mother. Law enforcement observed a red area shaped like the front half of a shoe bottom and there was an approximately two inch welt along the top edge of the red mark. Law enforcement also interviewed the child who was consistent in her story that Christopher had gotten mad and had hit her with a black shoe belonging to Bush Morton.

Bush Morton was interviewed by law enforcement at Bush Morton's program. Bush Morton denied seeing that Christopher had hit the child or that the child was crying when picked up. Bush Morton stated she had not seen the incident but Christopher informed her that the child fell on some toys before leaving. Bush Morton was unable to locate the toy. Law enforcement did observe a pair of black shoes belonging to Bush Morton. The heel portion of the shoe appeared to be the same shape as the injury observed on the child earlier in the day.

Christopher was contacted and interviewed by law enforcement on this same day and gave his address as the same as that of Bush Morton's. Christopher denied that he had struck the child with a shoe and that he was mad at the child. He stated that there was a point when the day care children were watching a movie and he went into the other room. He then heard things falling and after going back into the room, noticed some toys had been knocked on the floor and saw the child stuck between some totes. Law enforcement cited Christopher for child abuse, a Class I Misdemeanor, as Christopher's description of the incident did not coincide with the injury received by the child.

When questioned by Department staff about Christopher's presence in the child care home, Bush Morton said that Christopher was only there for a few minutes on the date of the incident. Bush Morton then changed her story and said he was there 20 minutes and then changed her story again to say 30 to 40 minutes. The police report shows that Christopher was at Bush Morton's program longer than just to drop off his children for care and for longer than two hours. During this time, Christopher interacted with other child care children.

Bush Morton violated the Licensing Agreement by allowing Christopher to be present at the child care program. In addition, Bush Morton stated she was unaware how a child in her care sustained an injury.

#### **DISCIPLINARY ACTION IMPOSED:**

Based upon the facts set out above, the Department intends to impose the following:

1. Bush Morton's license shall have the following permanent limitation: Christopher Bush is prohibited from being on the child care premises during the hours of operation. This limitation applies regardless of whether there are child(ren) present on the premises. Etavious Bush is prohibited, under any and all circumstances, from being on the child care premises when children are present.

2. Bush Morton is assessed a civil penalty in the amount of \$60.00 (\$5.00 times license capacity of 12 children times one day (September 4, 2012) effective January 7, 2013, which is 15 days after the mailing of this Notice.

Said penalty must be paid on or by February 6, 2013, which is thirty (30) calendar days from the effective date of this Notice (January 7, 2013) and must be payable to the Nebraska Department of Health and Human Services, Division of Public Health, Licensure. Said penalty must be sent to Marsha Wandersee, Administrative Assistant, Nebraska Department of Health and Human Services, Division of Public Health, Licensure, Children's Services Licensing, P.O. Box 94986, Lincoln, Nebraska, 68509-4986.

3. Bush Morton's Family Child Care Home II license is placed on Probation for a period of one year effective January 7, 2013, which is 15 days after the mailing of this Notice. Terms and conditions include:

a. Bush Morton's operating hours are changed to 6:00 a.m. to 6:00 p.m., Monday through Friday effective January 7, 2013, which is fifteen calendar days after the mailing of this Notice.

b. Bush Morton will notify all parents of children enrolled in her program and parents of future enrollees by providing the Department a copy of the Acknowledgment of Notice of Disciplinary Action January 7, 2013, which is fifteen calendar days after the mailing of this Notice. Acknowledgments from parents of future enrollees are due to the Department within fifteen calendar days from the date of enrollment. A copy of this Acknowledgment is attached to this Agreement. These Acknowledgments must be sent to Ms. Katie Zabel, Child Care Inspection Specialist, Children's Services Licensing, Division of Public Health – Licensure Unit, P.O. Box 98933, Lincoln, Nebraska, 68509.

c. During the probationary period, Bush Morton must maintain compliance with all Family Child Care Home regulations. Compliance will be monitored by Children's Services Licensing staff and may be monitored by other Department representatives (i.e., Fire Marshal or designated agent, Environmental Health Specialist/Scientist or designated agent, Resource Development Worker, Children and Family Services Specialist/Worker, etc.). Bush Morton and any employees and/or agents must cooperate with the Department in these monitoring inspections.

3. A copy of this Notice of Disciplinary Action must be posted with the current child care license so it is clearly visible to parents and agency representatives.

4. Failure to comply with the terms of this disciplinary action and the Family Child Care Home Regulations will be grounds for revocation or such other discipline as the Department may deem appropriate after notice to the licensee and an opportunity for a hearing.

5. If Bush Morton discontinues the child care program for any reason, the time Bush Morton is not actively operating a licensed child care program will not count toward the probation period and any subsequent child care license issued by the Department shall be subject to the remainder of the probation period. Bush Morton must notify the Department, in writing, within seven (7) calendar days of any period she is not actively operating the program. Any subsequent child care license issued by the Department indicating Patricia Bush Morton and/or Pat's Child Care as licensee/director/owner shall be subject to the terms of this probation including completion of the probation period.

LICENSING AGREEMENT

I, Patricia Bush Morton, 736 South 11<sup>th</sup> Street, Lincoln, Nebraska, 68508, hereby voluntarily state and declare:

I have read and understand the Family Child Care Home Standards (CRED-PAM-0929).

I agree to comply with each of the Family Child Care Home Standards as long as I am licensed by the State of Nebraska to provide child care services.

I understand and agree to comply with Standard 23, Page 4, which states: "The child care provider and/or household members do not engage in or have a history of behavior injurious to or which may endanger the health or morals of children." (NAC 6-004.01)

I agree that my sons, Christopher Bush and Etavius Bush, will not be allowed on the child care premises **any time** day care children are in attendance **under any circumstances**. Premises is defined as "the home/facility, including areas of the home/facility not used for child care/preschool, all attached and all outbuildings, and all areas included within the lot boundaries". I agree to notify all parents of children enrolled in my program by providing the Department with copies of the Acknowledgment of Licensing Agreement signed by the parent(s) of all children in care **within fifteen calendar days of the effective date of the Provisional Family Child Care Home II license**. A copy of this Acknowledgment is attached to this Agreement. When any new child(ren) are enrolled in my program, I will provide the Department with copies of the Acknowledgment of Licensing Agreement signed by the parent(s) **within fifteen calendar days of enrollment**. In addition, a copy of this Licensing Agreement will be **prominently** posted with the current Family Child Care Home II license so it is clearly visible to parents and agency representatives.

I understand that Child Care Licensing staff shall conduct announced or unannounced visits to my facility to determine compliance with this Agreement.

**Any violation of this Agreement may be grounds for further discipline** as the Department of Health and Human Services Regulation and Licensure may deem appropriate.

This Agreement shall be in effect from the issuance of the Family Child Care Home II license for as long as I am licensed by the State of Nebraska to provide child care services.

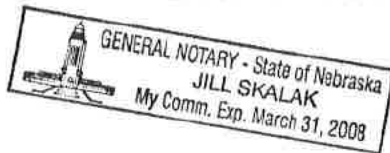
