1. I am the Licensee of the above-mentioned childcare program.
2. I have read, understand and agree to comply with all the Regulations Governing Licensure of Child Care Center's, Title 391, as long as I am licensed by the State of Nebraska to provide child care services. Specifically,

391 NAC 3-006.01 Licensee Qualifications and Requirements: "The Family Child Care Home II licensee must: 7. Be in compliance with all regulations whenever any children are in care."

3-006.03A Criminal History Record Checks: The applicant/licensee, if an individual or an individual in a partnership, must complete a pre-employment criminal history record check on him/herself, on each staff member and volunteer age 19 or older, and on each household member age 19 or older if the center is located in a private residence. Documentation must be kept and available for review by the Department.

3. I understand and agree with the following:

- A. This Licensing agreement is the result of a complaint inspection on December 12, 2017 conducted by Teresa Neal who determined that I, Cheryl Dubas, had knowingly hired staff with a criminal background preventing that person from working in child care.
- B. I will not knowingly hire anyone with a criminal record that precludes the applicant from working in childcare. This is to reinforce my written statement submitted 12/15/2018 in which I acknowledged criminal background checks must be done prior to hiring any staff.
- C. This Licensing Agreement will be prominently posted with the current license so it is clearly visible to parents and Department representatives.

- 4. Any violation of this Agreement may be grounds for further negative action or discipline.
- 5. This Agreement shall be in effect from the signing date until August 6, 2018. Should the license be amended because of a change of address, this Agreement may transfer to the new address if appropriate to the conditions of this Interim Licensing Agreement.
