Licensing Agreement

I, Jennifer Sturgeon, Authorized Agent, operating a Child Care Center, Omaha Early Learning Center at Skinner owned by Omaha Early Learning Centers, Inc, 4201 N. 34th Ave. Omaha, NE 68111, License number CCC9467, hereby state and declare:

I have read and understand the Regulations Governing Licensure of a Child Care Center, Title 391 NAC Chapter 3.

I agree to comply with each of the Child Care Center Regulations, as long as I am licensed by the State of Nebraska to provide child care services.

391 NAC 3-006.19A Prohibited Forms of Discipline

The following actions are prohibited as a form of discipline

- 9. Handling Roughly
- 14. Abusive or profane language
- 15. Yelling or screaming at children

I understand and agree that on 4/12/2017 a self report was made by Deb Winkelman- director of quality improvement at Omaha Learning Center at Skinner. Winkelman reported that a teacher grabbed a child roughly by the arm, and yelled at another child and pinned that child against a the wall with a table. A violation of regulations was substantiated by the Department.

I understand and agree that on 4/21/2017 a self report was made by Tasha Wulf- interim director at Omaha Early Learning at Skinner, stating a second staff member swung a child to the ground by his arm and yelled at him. A report was also received from the on 5/4/17 with similar allegations. A violation of regulations was substantiated by the Department.

I understand and agree that all staff will comply with the Omaha Early Learning Center Standards of Conduct that were submitted to the Department in response to the substantiated violations..

I understand and agree that all parents of children currently enrolled have received a copy of this Licensing Agreement within 2 working days, and that documentation of each parents receipt will be maintained and available for review upon request. Acknowledgements from parents of future enrollees will be signed prior to enrollment and receipts will be maintained and available for review upon request. A copy of this Acknowledgement is attached to this Agreement.

I understand that Child Care Licensing staff shall conduct announced or unannounced visits to the Child Care Center to determine compliance with this Agreement.

I will ensure that this Licensing Agreement will be prominently posted with the current Child Care Center license so it is clearly visible to parents and Department representatives.

I agree that I will comply with the revised Omaha Early Learning policies and procedures provided to the department in response to the above violations.

Any violation of this Agreement may be grounds for further negative action or discipline as the Department of Health and Human Services, Division of Public Health, Children's Services Licensing may deem appropriate.

This Agreement shall be in effect from the signing of this Agreement for a period of six months, from 7/2/17, 2017 to 1/2/18, 2018. In addition, should the Child Care Center be amended because of a change of address, this Agreement may transfer to the new address if appropriate to the conditions of this Licensing Agreement.
