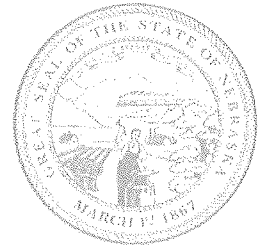

I, Cara Johnson, hereby state and declare:

1. I am the owner/director of the above-mentioned childcare program.
2. I have read, understand and agree to comply with all the Regulations Governing Licensure of Child Care Centers, Title 391, as long as I am licensed by the State of Nebraska to provide child care services. Specifically,

391 NAC 3-006.01 Licensee Requirements: “ ... licensee must: ... 2. Maintain compliance with all applicable state statutes and child care center regulations,” ...

391 NAC 3-006.15A Licensed Capacity: “The number of children in care at any one time must not exceed the center’s licensed capacity. Licensed capacity will be determined by the Department based on available space and the capacity authorized by the State Fire Marshal or delegated authority. Whichever number is smaller will be the licensed capacity of the center.

In determining whether the licensed capacity has been exceeded, any children over age 13 receiving care for compensation and any adults receiving care and supervision are included in the count of school-age children. All children are counted except:

1. Children who have left the center for an activity and will not be returning that day; and
2. Children who are enrolled in the center and in attendance at school.”

3. I understand that this agreement is the result of an unannounced semi-annual inspection conducted by Child Care Inspection Specialist Pam Wicht on June 12, 2018.

4. I understand and agree with the following:

- A. I will have no more than thirty (30) total children at any one time.
- B. This Agreement will be prominently posted with the current license so it is clearly visible to parents and Department representatives.
- C. That the Department shall conduct announced or unannounced visits to my facility to determine compliance with this Agreement

5. Any violation of this Agreement may be grounds for further negative action or discipline.

6. This Agreement shall be in effect from the signing date for six (6) months. Should the license be amended because of a change of address, this Agreement may transfer to the new address if appropriate to the conditions of this Licensing Agreement.
