



LICENSING AGREEMENT

I, Jacqueline Harnish, owner, hereby state and declare:

I am the owner of Jacqueline's Day Care owned by Jacqueline Harnish, Provisional Family Child Care Home I, FI11999, located at 318 Dawn Drive, Columbus, Nebraska 68601.

I agree to comply with all Regulations Governing Licensure of a Family Child Care Home Title 391 Chapter 1 (CSL001).

I agree to comply with all the regulations governing licensure of Family Child Care Home I, effective May 20, 2013 as long as I am licensed by the State of Nebraska to provide child care services.

I understand and agree to comply with:

1-006 STANDARDS OF OPERATION AND CARE: To provide adequate protection to children in care and to comply with state law, a Family Child Care Home I must meet the following standards.

1-006.01 Licensee Qualifications and Requirements: The Family Child Care Home I licensee must:

7. Be in compliance with all regulations whenever any children are in care;

1-006.08 Licensed Capacity and Staff-to-Child Ratio

<u>1-006.08B Staff-to-Child Ratio:</u> The appropriate staff-to-child ratio must be met at all times, as follows.

2. <u>Mixed ages.</u> If the program provides care to children of mixed ages, the following ratios apply:

Number of Children in Care	Number of Staff Required
1-8	1
9-10	1
(9 th and 10 th children must be school-age)	

- a. Programs serving children of mixed ages of may provide care for up to three infants if no more than two of the infants are under 12 months of age.
- b. Programs may provide care for up to two additional school-age children during non-school hours if no more than two of the other children in care are under 18 months of age.

3. <u>School-age only.</u> If the program provides care to school-age children only, the following ratio applies:

- 4. Be responsible for the day-to-day operation of the child care program;
- 5. Read, understand, and be familiar with these regulations;
- 7. Be in compliance with all regulations whenever any children are in care;

In addition, I agree to notify all parents of children enrolled in my program and parents of future enrollees by providing the Department a copy of the Acknowledgment of Licensing Agreement signed by the parent(s) of all children in care within ten calendar days from the signing of this Agreement. Acknowledgments from parents of future enrollees are due to the Department within fifteen calendar days from the date of enrollment. A copy of this Acknowledgment is attached to this Agreement. These Acknowledgments will be sent to the Department, Attn: Brenda Herring, Child Care Inspection Specialist, Office of Children's Services Licensing, 1955 Military Avenue, Fremont, NE 68025.

I understand and agree that during an unannounced complaint inspection I admitted to operating out of staff to child ratio for almost the whole month of August. I agree that I was notified about staff to child ratio requirements at orientation, it is on the web site under the regulations for a Family Child Care Home I and the Food Program staff discussed staff to child ratio with me, along with proper reporting.

I agree that this Licensing Agreement will be prominently posted with my ProvisionalFamily Child Care Home I License so that it is clearly visible to parents and agency representatives.

I understand that Children's Services Licensing staff shall conduct announced or unannounced visits to my program to determine compliance with this Agreement.

Any violation of this Agreement may be grounds for further negative action or discipline as the Nebraska Department of Health and Human Services, Division of Public Health, Licensure, Children's Services Licensing may deem appropriate.

This Agreement shall be in effect for six months from the signing after which time the Agreement will be reviewed and terminated, extended and/or modified. In addition, should a change of address occur or should! reapply for a different type of child care license, this Licensing Agreement may transfer to the newlicense and/or address if appropriate to the conditions of this Licensing Agreement.
