By providing this notice, Project Consulting Services, Inc. (“PCS”) does not waive any rights or defenses regarding the applicability of Nebraska law, the applicability of the Nebraska data event notification statute, or personal jurisdiction.

Nature of the Data Event

On February 26, 2026, PCS identified suspicious activity on certain computer systems. PCS immediately took steps to secure its systems and launched an investigation into the nature and scope of the activity. Through its investigation, PCS determined that an unknown actor gained access to certain computer systems between February 25, 2026 and February 26, 2026, and during this time files were copied and potentially viewed.

Upon becoming aware of the unauthorized access, PCS began a diligent and comprehensive review to determine the precise nature of the information that was impacted, as well as the identity of the individuals to whom the information relates. That process was recently completed, and PCS is notifying individuals whose information may have been impacted.

The information that could have been subject to unauthorized access includes name, Social Security number, and financial account information.

Notice to Nebraska Residents

On or about June 9, 2026, PCS provided written notice of this incident to two (2) Nebraska residents. Written notice is being provided in substantially the same form as the letter attached here as ***Exhibit A***.

Other Steps Taken and To Be Taken

Upon discovering the event, PCS moved quickly to investigate and respond to the incident, assess the security of PCS systems, and identify potentially affected individuals. PCS is also working to implement additional safeguards and training to its employees. PCS is providing access to credit monitoring services for twenty-four (24) months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, PCS is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. PCS is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

PCS is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

We are providing you with information about what happened, our response, and resources available to help protect your information from possible misuse, should you feel it is appropriate to do so.

What Happened? On February 26, 2026, PCS identified suspicious activity on certain computer systems. We immediately took steps to secure our systems and launched an investigation into the nature and scope of the activity. Through our investigation, we determined that an unknown actor gained access to certain computer systems between February 25, 2026 and February 26, 2026, and during this time files were copied and potentially viewed. PCS then began a diligent and comprehensive review to determine the precise nature of the information that was impacted, as well as the identity of the individuals to whom the information relates. That process was recently completed, and PCS is notifying individuals whose information may have been impacted.

What Information Was Involved? Based on the review, we determined that the impacted information includes your name and the following information: [Extra1].

What We Are Doing. The confidentiality, privacy, and security of information in our care are among our highest priorities. Upon becoming aware of the suspicious activity, we moved quickly to investigate and respond, assess and further strengthen the security of our systems and computer environment, and notify potentially affected individuals. We also reported this incident to federal law enforcement. As an added precaution, we are also offering credit monitoring and identity restoration services through Experian for 24 months, at no cost to you.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and credit reports for suspicious activity and to detect errors. Any suspicious activity should be promptly reported to your bank, credit card company, or other applicable institution. Additional information and resources are included in the enclosed *Steps You Can Take To Protect Personal Information*. You may also enroll in the complimentary credit monitoring and identity restoration services available to you. Enrollment instructions are attached to this letter.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also contact directly the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
