

**Nebraska Judicial Branch**  
**Court Case Searches -Volume Service Agreement**

Upon receipt of this Volume Service Agreement by Nebraska.gov, enrollment in the Volume Service set at a rate of \$1,000 flat fee per month will be effective January 1, 2026, for a minimum of six (6) consecutive months, after which the Nebraska.gov Subscription Services Agreement Subscriber (Subscriber) may:

- 1) Continue this Service on a month to month basis or;
- 2) Cancel this Service upon prior written notice to Nebraska.gov to be effective the first day of the following month the written cancellation notice was received by Nebraska.gov.

By agreeing with the following terms and conditions, any Subscriber may have access to County, District, Juvenile and/or Appellate Court Electronic Records (Records) in volume at the monthly flat rate:

- 1) The access shall only include public court case records;
- 2) Monthly flat fee includes case searches up to 20,000 records per month;
- 3) If an account exceeds the 20,000 record limit, the account will be transitioned to "pay-per-record" at a cost of \$2.00 per record. Accounts will transition back to bulk record access on the first day of the following month;
- 4) The Subscriber shall use the records in strict accordance with: (i) all federal, state and local laws, regulations, rules, and judicial and administrative decisions, (ii) relevant industry guidelines, and (iii) its own privacy policies;
- 5) The Subscriber shall abide by the Nebraska Supreme Court rules on Public Access to Court Records and Information, Neb. Ct. R. §§ 1-801 to 1-810.
- 6) Access to the records requested shall be limited to the Subscriber (person or agency) for internal purposes. Data or records provided shall not be sold, rented, leased, loaned, or distributed for profit.
- 7) The Subscriber shall not use access to court records to obtain names, addresses or any other information for the purpose of solicitation or sale, or for any purpose in which the Requestor can reasonably anticipate the receipt of monetary gain from direct or indirect use of such public records.
- 8) The Subscriber shall be required to subscribe to the Sealed Court Record Index to ascertain the sealed status of records pursuant to Neb. Ct. R. § 1-808(C).
- 9) The Subscriber shall remove any record that has been sealed by the court from its file(s)/system(s) and shall not further disclose the sealed court record(s) or information contained therein. Disclosure of sealed court records and information therein may result in civil or criminal penalties as provided for by law.
- 10) The Subscriber shall not engage in bulk distribution or collection of court records in violation of Neb. Ct. R. § 1-806. Bulk is defined under Neb. Ct. R. § 1-802 as all, or a significant subset of the Electronic Court Records or data maintained in the case management system.

Nebraska.gov or the Nebraska Judicial Branch reserve the right to terminate this Volume Service immediately if the Records are being used by the Subscriber contrary to the above terms and conditions. All other terms and conditions of the Nebraska.gov Subscription Services Agreement apply to this Volume Service, including payment.
