Substitute teachers who work equivalent hours of a .5 FTE, over the course of one school year, meet this requirement shall be considered employed as a teacher. This term also means employment by an Educational Service Unit (ESU) as a certificated employee as defined in Section 79-1234(2) R.R.S. when the certificated employee will be functioning as a teacher throughout the course of one (1) school year or a period of two (2) consecutive school terms that are the equivalent of one school year (e.g., one (1) spring semester and the following fall semester)
