

NOTICE OF PUBLIC HEARING and COMMENT PERIOD for TITLE 248 NAC 3

NOTICE is hereby given that the Department of Motor Vehicles will hold a rule repeal hearing on Thursday, December 19, 2019, beginning at 2:00 p.m. in Room B, Lower Level of the State Office Building, 301 Centennial Mall South, Lincoln, Nebraska.

THE PURPOSE of the hearing is to take testimony and evidence concerning the repeal of: TITLE 248, Nebraska Administrative Code, Chapter 3 entitled *Rules and Regulations Governing Donation of Organs and Tissues by Notation on Driver's License or State Identification Card*, *Neb. Rev. Stat. §§ 60-493, 60-494, 60-495, 60-4,144, 60-4,181 and the Revised Uniform Anatomical Gift Act Neb. Rev. Stat. §§ 71-4824 through 71-4845.*

These rules and regulations pertain to the process for electing to become an organ and tissue donor through the driver's licensing or state identification card process. The proposed change is to repeal the entire regulation. The rules and regulations are redundant to existing statutes and unnecessary.

THIS RULE MAKING HEARING is being conducted under the Nebraska Administrative Procedures Act, Neb. Rev. Stat. § 84-907, et seq. Draft copies of the proposed regulations are available for public examination at the Department of Motor Vehicles, Legal Division, State Office Building, 301 Centennial Mall South, Lincoln, Nebraska 68509-4699 and at the office of the Secretary of State, Room 1305, State Capitol, Lincoln, Nebraska 68509-4608. There is no new FISCAL IMPACT upon the state or political subdivisions from these rules and regulations.

ALL INTERESTED PERSONS are invited to attend and testify at the hearing. Interested persons may prefer to submit written comments during the PUBLIC COMMENT PERIOD. The public comment period begins with the publication of this notice and will close at the time of the public hearing. Any written comment received prior to or at the public hearing shall be made part of the hearing record at the time of the hearing.
