The proposed changes specify the regulations scope; update title and chapter name; update definitions; remove duplicate statutory language from the regulations; remove unnecessary and outdated language; simplify language; remove directions to agency staff; shorten the period of time that summary suspensions and limitations of credentials remain in effect after hearing pending the hearing officer's decision from 30 days to 15 days, unless otherwise prescribed by statute; update section headings and formatting; remove attachments; update terminology and statutory references; and restructure the regulatory chapter. Additional proposed changes include aligning the regulations with the Nebraska Attorney General's model rules for rule making; declaratory orders; ex parte communications; and rules of procedure in administrative hearings. These model rules can be found in Title 53 of the Nebraska Administrative Code.

Title 184 NAC 6 – Procedural Regulations for Removal of Appointed Board Members

The proposed changes specify the regulations scope; update title and chapter name; update definitions; remove duplicate statutory language from the regulations; remove unnecessary and outdated language; simplify language; update terminology and statutory references; remove directions to agency staff; update section headings and formatting; and restructure the regulatory chapter. Additional proposed changes include aligning the regulations with the Nebraska Attorney General's model rules for rule making; declaratory

orders; ex parte communications; and rules of procedure in administrative hearings. These model rules can be found in Title 53 of the Nebraska Administrative Code.

Authority for these regulations is found in <u>Neb. Rev. Stat.</u> § 81-3117(7).

TITLE 184GENERAL ADMINISTRATION

CHAPTER 1RULES OF PRACTICE AND PROCEDURE FOR DIVISION OF PUBLIC
HEALTH ADMINISTRATIVE HEARINGS

001. SCOPE AND AUTHORITY. <u>GENERAL</u> This chapter governs administrative hearings in contested cases brought by or against the Division of Public Health except where other procedures are required by statute or rules and regulations. Absent specific statutes, rules and regulations, or orders of the Division as to procedures, the statutes and Nebraska Supreme Court rules governing civil proceedings in district courts apply. The chapter implements the Administrative Procedure Act, Uniform Credentialing Act, Asbestos Control Act, Child Care Licensing Act, Children's Residential Facilities and Placing Licensure Act, Environmental Health Specialists Practice Act, Lead Based Paint Professions Certification Act, Medication Aide Act, provisions of Nebraska Revised Statutes (Neb. Rev. Stat.) §§ 71-6038 to 71-6042 regarding nurse aides and paid dining assistants, provisions of Neb. Rev. Stat. §§ 71-2225 to 71-2230 regarding the Commodity Supplemental Food Program, provisions of Neb. Rev. Stat. §§ 71-7001 to 71-7013 regarding breast and cervical cancer, Radiation Control Act, and Vital Statistics Act.

<u>002.</u> <u>DEFINITIONS.</u> <u>001.01</u> <u>Definitions</u> The following definitions shall apply as used throughout these rules and regulations. Other terms common to the administrative process are defined for explanatory purposes in a glossary of terms attached as Attachment 1 of these regulations.

<u>002.01</u> <u>APPLICANT</u>. <u>001.01A</u> <u>Applicant</u> means a<u>Any</u> person who makes <u>an</u> application to the Department for a license, certificate, registration, permit or any other authority, permission or approval of any kind that the Department is authorized by law to grant or deny.

<u>002.02</u> <u>APPLICATION</u>. <u>001.01B</u> <u>Application</u> means a <u>A</u> request for <u>a credential or permit or</u> for the amendment, correction, or issuance of a vital record any permission or authority that the <u>Division</u> Department is empowered <u>authorized by law</u> to grant or deny, in whole or in part₇. including, but not limited to:

<u>001.01B1</u> The issuance, renewal or reinstatement of, any license, certificate, permit, or registration;

001.01B2 The issuance, renewal, or reinstatement of any form of approval;

001.01B3 The issuance or renewal of any waiver, exemption or variance; or

<u>001.01B4</u> The amendment, correction, or issuance of a vital record.

<u>002.03</u> <u>BOARD.</u> <u>001.01C Board means a A</u> publicly appointed body created by law, chosen to perform that performs a public functions related to <u>Department Division</u> programs.

<u>001.01D Complaint</u> means a report to the Department of an alleged violation of statute or regulation made to initiate an investigation by the Department.

<u>002.04</u> <u>CONTESTED CASE.</u> <u>001.01E</u> <u>Contested Case</u> means a proceeding before the Department in which the legal rights, duties, or privileges of specific parties are required by law or constitutional right to be determined after hearing before the Department <u>Has the meaning given in 53 Nebraska Administrative Code (NAC) 4-001.02B</u>.

<u>002.05</u> <u>CREDENTIAL.</u> <u>A license, certificate, or registration that the Division is authorized by law to grant or deny.</u>

002.06 DAY. A calendar day unless otherwise specified.

<u>002.07</u> <u>DECISIONMAKER</u>. <u>001.01F</u> <u>Decisionmaker</u> means t<u>The</u> <u>Division</u> employee of the Department</u> who issues a preliminary order or decision on behalf of the <u>Department</u> <u>Division</u> that <u>becomes is</u> the subject of the <u>a</u> contested case.

001.01G Department means the Department of Health.

001.01H Director means the Director of Health.

002.08 DIVISION. The Department of Health and Human Services, Division of Public Health or persons exercising authority delegated to them by the Division.

002.09 EX PARTE COMMUNICATION. Has the meaning given in 53 NAC 4-001.02B.

<u>002.10</u> HEARING OFFICER. <u>001.011 Hearing Officer</u> means t<u>The Director of the Division</u> or an individual <u>a person</u> designated by the Director to conduct a hearing, contested case, or other proceeding, pursuant to the Administrative Procedure Act, Neb. Rev. Stat. <u>§84-901 et seq.</u> whether designated as the presiding officer, administrative law judge, or some other title designation.

<u>002.11</u> <u>PARTY.</u> <u>001.01J Party</u> means the person by or against whom an administrative action is brought or a person allowed to intervene in an administrative proceeding <u>Has the meaning given in 53 NAC 4-001.02B</u>.

001.01K Person means bodies politic and corporate, individuals and partnerships.

<u>002.12</u> <u>PERMIT.</u> <u>A permission, authority, or approval of any kind that the Division is</u> <u>authorized by law to grant or deny.</u>

<u>002.13</u> <u>PETITION.</u> <u>001.01L</u> <u>Petition</u> means the initial document filed by or with the Department that sets forth a claim and request for Department action Has the meaning given in 53 NAC 4-001.02B.

<u>001.01M Petition for Discipline</u> means the initial pleading in an action for discipline or a motion for revocation of probation or other discipline for violation of an order of discipline against a licensee or certificate holder filed pursuant to Neb. Rev. Stat. §71-149 <u>et seg</u>.

<u>002.14</u> <u>PLEADING.</u> <u>001.01N</u> <u>Pleading</u> means any <u>A</u> petition, answer, reply or response, notice, motion, stipulation, objection, discovery document, orders, decisions or other formal written document filed in any <u>a</u> proceeding before the Department.

<u>001.010 Public Record</u> means and includes all records and documents, regardless of physical form, of or be longing to the Department, except where any statute provides that particular information o records shall not be made public.

<u>001.01P Rule or Regulation means any rule, regulation or standard issued by the Department</u> certified and filed with the Secretary of State of the State of Nebraska under the Nebraska Administrative Procedure Act, Neb. Rev. Stat. <u>§</u>§84-901 to 84-920.

<u>001.01Q Uniform Licensing Law</u> means those sections of the Nebraska Revised Statutes cited in Neb. Rev. Stat. §71-101.

<u>001.02 Scope</u>. These rules and regulations shall govern administrative hearings conducted by or before the Department except those in 001.02C.

<u>001. 02A Applicability to Pending Actions</u>. Generally speaking, the procedural rules to be applied in pending cases are those in effect at the date of the hearing and not those in effect at the time the act or violation charged is alleged to have taken place.

<u>001.02B General Applicability</u>. These rules are intended to govern the administrative proceedings conducted by the Director or designee which are for the purpose of adjudicating contested cases.

001.02C When Not Applicable. These rules and regulations do not apply:

<u>001.02C1</u> To the promulgation, amendment or repeal of any regulation under Department authority (see 184 NAC 3);

<u>001.02C2</u> To any declaratory ruling that the Department is empowered to make (<u>see</u> 184 NAC 2);

<u>001.02C3</u> To the extent that statutes or regulations require a different procedure or standard in particular cases.

<u>001.02D</u> When Silent. In the absence of a specific statute, rule and regulation or order of the Department as to a procedure, the statutes for civil procedures and practices for district courts of this state and the rules of the Nebraska Supreme Court for proceedings in district courts shall apply.

<u>001.02E</u> <u>Director Designee</u>. References throughout these regulations to decisions by the Director or a designee of the Director are not intended to define the law on proper delegation by the Director of authority to make final decisions. Generally speaking, the Director holds the authority to issue final decisions in contested cases or decisions which terminate or are dispositive of a contested case. Delegation may be made by the Director to the extent permitted by law in particular cases.

<u>003.</u> <u>COMPUTATION OF TIME.</u> <u>001.03.</u> <u>Time, Computation.</u> In computing time prescribed or allowed by these rules and regulations or by any applicable statute in which the method of computing time is not specifically provided, days will be computed by excluding the day of the act or event, and including the last day of the period. If the last day of the period falls on a Saturday, Sunday, or state holiday, the period shall run until the end of the office hours of the Department on the next working day. Office hours are from 8:00 a.m. to 5:00 p.m., Monday through Friday, excluding state holidays 53 NAC 4-004.09 governs when computing the time prescribed by this chapter or by any applicable statute which does not specifically specify the method of computing time.

<u>004.</u> INFORMAL PROCEDURES. <u>001.04 Informal Procedures.</u> Informal procedures may be used for disposition of any matter that, under law, may be acted upon without hearing. Matters which under the law may be acted upon without a hearing may be handled by correspondence or conference.

<u>001.05 Offices</u>. The offices of the Department are located on the third floor of the Nebraska State Office Building, 301 Centennial Mall South, Lincoln, Nebraska.

<u>005.</u> <u>REPRESENTATION.</u> <u>001.06</u> <u>Practice of Law.</u> Practice of law <u>in contested cases brought</u> by or against the Division before the Department is governed by the applicable Revised Statutes of Nebraska and the decisions of the Nebraska Supreme Court. <u>These provided that these</u> rules shall <u>do</u> not, however, interfere with or prohibit <u>persons</u> anyone from transacting his or her <u>their</u> own business before the <u>Department</u> <u>Division</u>.

<u>006.</u> <u>EX PARTE COMMUNICATIONS.</u> <u>001.07 Ex Parte Communications.</u> <u>The prohibitions</u> against ex parte communications and the requirements regarding disclosure of such communications set forth in 53 NAC 4-002 apply to proceedings under this chapter.</u>

<u>001.07A Defined.</u> Ex parte communication shall mean an oral or written communication which is not on the record in a contested case with respect to which reasonable notice to

all parties was not given. Filing and notice of filing provided under subdivision (6)(d) of section 84-914 shall not be considered on the record and reasonable notice for purposes of this subdivision. Ex parte communication shall not include:

001.07A1 Communications which do not pertain to the merits of a contested case;

<u>001.07A2</u> Communications required for the disposition of ex parte matters as authorized by law;

001.07A3 Communications in a rate making or rule making proceeding; and

001.07A4 Communications to which all parties have given consent.

<u>001.07B</u> Prohibitions; When Applicable. Ex parte prohibitions apply while a matter is pending. For purposes of this section, a matter is "pending" before the Department from the time a petition is filed or a request for hearing is received in response to a notice of Department action until the matter is finally disposed of within the agency through dismissal, settlement, the filing of a court appeal or expiration of the statutory period for doing so, or by such other mechanism as is provided by law. These definitions also apply to any proceedings for further relief subsequent to final disposition. See <u>e.g.</u> sections 006.02, 006.03 and section 014. Nothing herein shall be intended to preclude the Director, other person or persons responsible to make a final decision, hearing officer, staff attorney or other assistant from declining to engage in communications about the merits of a case prior to the time specified in this section.

001.07C Prohibitions; To Whom Applicable.

<u>001.07C1</u> Parties and Public. No party in a contested case or other person outside the agency having an interest in the contested case shall make or knowingly cause to be made an ex parte communication to the hearing officer or to an agency head or employee who is or may reasonably be expected to be involved in the decision making process of the contested case.

<u>001.07C2</u> Persons in Decision Making Roles. No hearing officer or agency head or employee who is or may reasonably be expected to be involved in the decision making process of the contested cases shall make or knowingly cause to be made an ex parte communication to any party in a contested case or other person outside the agency having an interest in the contested case.

<u>001.07C3</u> Investigators. No agency head or employee engaged in the investigation or enforcement of a contested case shall make or knowingly cause to be made an exparte communication to a hearing officer or agency head or employee who is or may reasonably be expected to be involved in the decision making process of the contested case.

001.07D Types.

<u>001.07D1</u><u>Oral</u><u>Communications</u>.<u>Unless</u><u>required</u><u>for</u><u>the</u><u>disposition</u><u>of</u><u>matters</u> authorized by law, no party or his or her attorney shall discuss any aspect of a pending case other than scheduling or a similar matter with the Director, Hearing Officer, or other person assigned to

render a proposed or final decision in the case, or to advise or assist either, without the opposing party or his or her attorney, unless, after notice or request, the opposing party or attorney fails or refuses to attend and the Director or Hearing Officer is so advised.

<u>001.07D2</u> Written Communications. Unless required for the disposition of matters authorized by law no party or his or her attorney shall deliver to the Director or Hearing Officer or other person assigned to render a proposed or final decision in the case or to advise or assist either of them, any letter, memorandum, brief, or other written communication without concurrently delivering a copy to the opposing party or opposing counsel, when represented.

<u>001.07E</u> Contacts Not Considered. In determining the outcome of a case, neither the Director nor any Hearing Officer shall consider any <u>ex</u> <u>parte</u> oral or written communications from a party, a party's attorney, or proposed witnesses or any other person who has a direct or indirect interest in the outcome about any substantive aspect of a pending case. Only matters made part of the record of a contested case shall be considered.

<u>001.07F</u> <u>Disclosure of Contacts.</u> The hearing officer or agency head or employee who is or may reasonably be expected to be involved in the decision making process of the contested case who receives or who makes or knowingly causes to be made an ex parte communication set forth in 001.07C1 to 001.07C2 of this section shall file in the record of the contested case:

001.07F1 all such written communications;

001.07F2 memoranda stating the substance of all such oral communications; and

<u>001.07F3</u> all written responses and memoranda stating the substance of all oral responses to all the ex parte communications.

The filing shall be made within two working days of the receipt or making of the ex parte communication. Notice of the filing, with an opportunity to respond shall be given to all parties of record.

<u>001.08 Copies of Rules and Regulations</u>. Copies of the rules and regulations in force and effect for the Department shall be made available to all interested persons, on request. Copies of 184 NAC 1 and copies of other Department regulations shall be furnished at a price fixed to cover costs of publication and mailing. The Department may furnish the same without charge if funds are available.

<u>001.09 Certified Copies of Rules and Regulations</u>. Official copies of any Department rules and regulations, certified as such by the Secretary of State, are available from the offices of the Secretary of State, Regulations Division.

002 COMPLAINTS AND INVESTIGATIONS

<u>002.01 Making a Complaint</u>. Any person may make a complaint and request investigation of an alleged violation of statutes the Department has authority to enforce or violation of regulations promulgated and adopted by the Department. Complaints may be submitted in writing, by telephone, or by personal visit to the offices of the Department. Persons making a complaint may be asked to fill out a form. Any unwritten complaint will be put in written form by the Department. The complaint should state in a reasonably specific manner the basis for the person's belief that a violation of a statute or regulation has occurred.

<u>002.02 Review of Complaints</u>. Upon receipt of a complaint, the Department will evaluate the complaint and determine whether to conduct an inspection or investigation, as appropriate.

<u>002. 02A</u> In determining whether to investigate a complaint, the Department considers such things as:

<u>002.02A1</u> whether the complaint pertains to a matter within the Department's authority;

<u>002.02A2</u> whether the circumstances indicate that a complaint is made in good faith and is not malicious, frivolous, or vexatious;

<u>002.02A3</u> whether the complaint is timely or has been delayed too long to justify present examination of its merit;

<u>002.02A4</u> whether the person complaining would be a necessary witness if action were taken and is willing to identify himself or herself and come forward to testify; and

<u>002.02A5</u> whether the information provided or in the knowledge of the person complaining is sufficient to provide a reasonable basis to believe that a violation has occurred or to secure necessary evidence from other sources.

<u>002.02B Review by Attorney General</u>. The Bureau of Examining Boards shall provide the Attorney General with a copy of all complaints it receives and advise the Attorney General of investigations it makes which may involve any possible statutory or regulatory

violation by the licensee or certificate holder. The Attorney General shall then determine which, if any, statutes or regulations the licensee or certificate holder has violated and the appropriate legal action to take.

002.04 Confidentiality.

<u>002.04A Complainant</u>. The identity of a person making a complaint will not be disclosed without his or her consent unless permitted by law and consistent with 002.04B1, below.

<u>002.04B Investigation Files</u>. Investigational files and materials are public records and are available to the public unless exempted by statute.

<u>002.04B1 Discretion</u>. Investigational files may be withheld from disclosure or disclosed under 84-712.05(5) to serve the ends of justice or in the public interest.

002.04B2 Exceptions under Uniform Licensing Law.

<u>002.04B2a</u> Complaints, investigational records, reports and files of any kind pertaining to alleged violations of statutes or regulations governing persons licensed or certified under Uniform Licensing Law are not public records unless made part of the record of a contested case. Reports made to the Department under mandatory reporting laws for practitioners, members of their profession, other professions, and health care facilities, peer review organizations and professional associations are treated in the same manner as investigational files.

<u>002.04B2b</u> Investigational records, reports and files pertaining to an application shall not be a public record until action is taken to grant or deny an application and may be withheld from disclosure thereafter under section 84-712.05.

Such reports may not be obtained by legal discovery proceedings or otherwise disclosed unless the privilege is waived by the patient involved or the reports are made part of the record in a contested case under section 71-154, in which case such reports shall only be disclosed to the extent they are made part of such record.

The findings of the inspection of a nursing home with respect to compliance by any nursing home with the provisions of sections 71-2017 to 71-2029 and 71-6008 to 71-6037 and any rules and regulations adopted and promulgated pursuant thereto shall be made available to the public, together with the nursing home's response to any allegations, in a readily available form and place not later than twenty-one working days after the findings are made available to the nursing home. When the findings are made available to the public they shall include no reference to any cited violation which has been corrected to the department's satisfaction unless the same reference also clearly notes that the violation has been corrected. Other information relating to any nursing home obtained by the department through reports, investigations, complaints, or as otherwise authorized by sections 71-2017 to 71-2029 and 71-6008 to 71-6037 and rules and regulations adopted and promulgated pursuant thereto, which is not a part of the department's findings from an inspection of the nursing home, shall not be made available to the public except in proceedings involving the citation of a nursing home.

<u>002.04B4_Courts.</u> Reports by county and district courts to the Department beginning July 1, 1995, of the conviction of persons licensed by the Department or of judgment against such persons arising out of claims of professional liability shall be public records.

007.01 INITIATION AND PARTIES. 003.01 How Initiated; Parties. A contested case begins if when proper delivery of notice or request for hearing, as applicable, is obtained, by:

- (A)003.01A Timely request for hearing after the issuance of written notice by the Decisionmaker decisionmaker of the total or partial denial of an application either totally or partially. The sole parties to a denial action shall be are the applicant, as appellant, and the Division Department as appellee.

The sole parties to an action involving refusal of renewal shall be are the holder of the credential or permit license, certificate or other approval, as appellant and the Division Department, as appellee.
- (C)003.01C The filing of a petition for discipline. The sole parties shall be are the State of Nebraska on the relation of the Attorney General, as plaintiff, and the licensee or certificate credential holder, as defendant.
- (D)003.01D Timely request for hearing after the issuance of written notice by the Decisionmaker of revocation, suspension, citation, or other discipline. The sole parties shall be are the Division Department, as plaintiff, and the credential or permit holder licensee, certificate holder, permittee, or holder of other approval, as defendant.
- (E)003.01E Except as provided in section 009.04 006.04, timely request for hearing after denial of an application or a petition for reinstatement of a credential or permit license, certificate or other form of authority. The sole parties shall be are the person requesting reinstatement, as petitioner, and the Division Department, as respondent.
- (F)003.01F Timely request for hearing after the issuance of an administrative order by the Decisionmaker compelling or prohibiting performance of an action by any person. The sole parties shall be are the Division Department, as plaintiff, and the person to whom the order is directed, as defendant.
- (G)003.01G The filing of a tTimely request for appeal of a decision by a person or entity, other than the Division Department, which the Division Department is authorized by law to review. The sole parties shall be are the person requesting review, as appellant, and the person whose decision is the subject of review, as appellee.
- (H)003.01H An Order to Show Cause why the Division Department should not take disciplinary or other action against a person. The sole parties shall be are the Division Department as petitioner, and the person to whom the order is directed, as respondent.
- (I)003.01 Such other actions as may require a hearing as provided by law or constitutional right.

007.02 HEARING NOT REQUIRED. 003.02 Hearing, Not Required.

007.02(A) CIRCUMSTANCES. 003.02A Notwithstanding the procedures set forth in this chapter these regulations for hearing, an evidentiary hearing is not required:

(i)003.02A1 lif there are no issues of material fact-:

The board shall review the application or petition and other documents submitted to determine whether there are sufficient grounds to believe that the cause for action against the license, certificate, or registration no longer exists and the applicant/petitioner <u>person</u> is otherwise qualified to practice or continue in practice. To make its determination, the board may:

<u>006.05L2a</u> Require submission of further documentation of the treatment or evaluation of the applicant/petitioner;

<u>006.05L2b</u> Appoint a physician or physicians to conduct diagnostic evaluation of the applicant/petitioner and to report the findings to the board.

<u>006.05L2c</u> Require the person to pass a written, oral, or practical examination or any combination of such examinations.

006.05L3 Board Findings.

<u>006.05L3a Findings that Not Qualified or Partially Qualified</u>. The procedures of 006.05C to 006.05G shall apply when the board determines:

006.05L3a1 That the cause for the action still exists.

<u>006.05L3a2</u> That the applicant or petitioner is not otherwise qualified to practice.

<u>006.05L3a3</u> That the condition of the applicant or petitioner or his or her other qualifications otherwise, or both, are not sufficient to merit full licensure or certification, but that he or she can practice or continue in practice safely under limitations or conditions.

<u>006.05L3b</u> Findings that Qualified. If the board finds, upon competent medical evidence, that the applicant or petitioner is qualified to engage in practice and the cause for denial, refusal to renew, limitation, suspension, or revocation no longer exists, the board shall certify that fact to the <u>director</u> by written findings meeting the requirements of section 013 and shall cause the record of the proceedings to be submitted to the Director for action.

<u>006.05L4 Director Action.</u> The Director shall review the findings of the board and record of its proceedings. Decisions shall be based on the record made before the board; no hearing shall be held before the Director.

<u>006.05L4a</u> Action Upon Board Certification That Not Qualified Or Partially <u>Qualified</u>. The procedures of 006.05H1 shall be followed when the board certifies to the Director that the applicant or petitioner is not qualified to practice or is partially qualified.

<u>006.05L4b</u> Action Upon Board Certification That Qualified. When the board certifies that the basis upon which the action was taken no longer exists and that the petitioner is otherwise qualified to engage in practice, the Director shall issue, return, or reinstate such license, certificate, or registration or remove any limitation or restrictions on the license, certificate, or registration.

010. SPECIAL CASES. 007 PROCEDURES IN SPECIAL CASES

<u>010.01</u> SUMMARY SUSPENSIONS OR LIMITATIONS. <u>007.01</u> Summary Suspensions or <u>Limitations.</u> These procedures apply when the Division exercises its statutory authority to suspend, limit, or take other action against a credential or permit to take effect immediately, without advance notice or hearing, because of imminent danger to public health, safety, or welfare, unless other procedures are prescribed by statute or rules and regulations. Under some statutes the Department is authorized to suspend, limit or take other action against a license, certificate, permit, registration or other form of approval to take effect immediately

without advance notice or hearing, because of an imminent danger to public health, safety or welfare. In such cases, the following procedures shall apply unless a statute or other regulation (see e.g., Neb. Rev. Stat. §71-147.02 and section 006.01B) provides for a different procedure:

<u>010.01(A)</u> <u>NOTICE AND ORDER</u>. <u>007.01A</u> The notice of <u>alleged</u> violations alleged shall <u>will</u> be accompanied by an Oorder which shall:

(i)007.01A1 Recites the basis for the immediate suspension, limitation, or other action taken, i.e. including the basis for the Department's finding that reasonable cause exists to believe that the violations alleged have occurred and are grounds for discipline, and for its determination determining that such violations constitute an immediate danger to the public requiring summary action; and

(ii)<u>007.01A2</u>Sets the matter for hearing and notify notifies the person against whom the action is taken of the date, time, and location of hearing and issues for hearing.

<u>010.01(B)</u> <u>HEARING DATE.</u> <u>007.01B</u> The hearing shall be set to be heard will be held within thirty (30) days of the date the Qorder is entered unless continued upon the written request of the party against whom the action is taken or upon joint motion of the parties.

<u>010.01(C)</u> <u>SERVICE.</u> <u>007.01C</u> The <u>Oo</u>rder and <u>Nn</u>otice of <u>Cc</u>harges <u>shall will</u> be served at least ten (10) days prior to the date set for hearing <u>by any method permitted by law</u> <u>Service shall be made by certified or registered mail, return receipt requested, by personal</u> delivery or by leaving a copy at the person's usual place of residence with some person of suitable age and discretion residing there, or by other method permitted by law.

<u>010.01(D)</u> <u>EFFECT.</u> <u>007.01D</u> The suspension, limitation, or other action taken shall remains in effect until thirty (30) <u>15</u> days after the hearing is closed, <u>unless an alternative</u> <u>period is prescribed by statute</u>. If no decision has been is reached within that time, the temporary suspension, limitation, or other action shall terminates unless or until such time as a final decision is entered that imposes imposing a like sanction.

<u>010.02</u> <u>SHOW CAUSE PROCEEDINGS.</u> <u>007.02</u> <u>Show Cause Proceedings.</u> <u>These</u> procedures apply when a statute calls for the initiation of a case by requiring a person to show cause why discipline should not be taken, unless other procedures are prescribed by statute or rules and regulations. When a statute calls for initiation of a case by requiring a person to show cause why discipline should not be taken, the following procedure shall apply to the extent that the statute or regulations governing the matter do not provide for other procedures.

<u>010.02(A)</u> <u>ENTRY OF ORDER.</u> <u>007.02A</u> An Order to Show Cause order to show cause shall will be entered which shall:

(i)007.02A1Notify Notifies the person affected of the charges or claims that form the basis to believe that a violation of statute or regulation has occurred, including the factual basis for the belief and reference to the statutes or rules and regulations alleged to be violated. Such notice may be included in the Order order or in a

<u>010.02(B)</u> <u>SERVICE.</u> <u>007.02B</u> The Order order and charges shall will be served by certified or registered mail, return receipt requested, or by personal delivery upon the person affected by a means permitted by law at least 30 days before the date of hearing.

<u>010.02(C)</u> <u>HEARING.</u> <u>007.02C</u> The hearing <u>shall will</u> be held not less than 60 <u>days</u> nor more than 90 days after the date that the <u>Order to Show Cause</u> <u>order to show cause</u> is entered, unless continued for good cause. <u>The burden is on the person charged to show cause why the Division should not proceed with a hearing on the alleged violations.</u>

<u>007.02D</u> The person affected shall be served with the Order and charges at least thirty (30) days before the date of hearing. The burden is on the person charged to show cause at the hearing why the Department should not proceed with a hearing on the alleged violations.

<u>010.03.</u> <u>REINSTATEMENT.</u> <u>007.03</u> <u>Reinstatement Generally.</u> The procedures of section <u>008</u> 005 apply to denials of petitions for reinstatement of <u>a license</u>, certificate or other form of <u>approval credential or permit</u> except as provided in <u>section 009.04</u> <u>006.04 or 007.04</u> or when a statute or <u>rules and regulations</u> other regulation provides <u>otherwise</u> for a different procedure in a particular case.

<u>011.</u> <u>HEARING OFFICERS.</u> <u>008 HEARING OFFICERS</u> The appointment of hearing officers upon receipt of timely requests for hearing, or filing of petitions or other pleadings initiating contested cases, is govered by 53 NAC 4-005.

<u>008.01 Appointment of a Hearing Officer</u>. Upon receipt of a timely request for hearing or the filing of a petition or other pleading initiating a contested case, the Director shall designate a Hearing Officer.

<u>008.01A</u> The Director may designate him/herself, an employee of the Department, an attorney, or any other individual to serve as Hearing Officer.

<u>008.01B</u> In designating a hearing officer, the Director shall consider the following:

<u>008.01B1</u> A person who has served as investigator, prosecutor, or advocate in a contested case or in its prehearing stage may not serve as hearing officer or assist or advise a hearing officer in the same proceeding except as provided in 008.01B3.

<u>008.01C</u> The Director may designate in writing any person(s) employed by the Department to appoint Hearing Officers. Such designation(s) shall be of public record and available in the offices of the Director.

<u>008.01D</u> The Director or his designee may substitute hearing officers at any time unless the Director or Hearing Officer determines that substitution would result in substantial prejudice to the rights of the part-parties, in which case a new hearing will be set or the case dismissed without prejudice to the right to bring a new action.

008.02 Duties.

<u>008.02A</u> <u>Conduct Hearing</u>. A Hearing Officer shall have the duty to conduct full, fair, and impartial hearings, to take appropriate action to avoid unnecessary delay in the disposition of proceedings, and to maintain order. He/she shall have all the powers necessary to that end, including any or all of the following powers:

008.02A1 To place witnesses under oath;

<u>008.02A2</u> To rule upon objections and offers of proof and receive relevant, competent, and probative evidence;

<u>008.02A3</u> To regulate the course of the proceedings and the conduct of the parties and their representatives;

<u>008.02A4</u> To consider and rule upon procedural motions and issue discovery orders and protective orders in accordance with the rules of civil procedure except as may otherwise be prescribed by law; DRAFT 10-26-2021 Title 184 Chapter 1

012.009 PLEADINGS AND OTHER FILINGS. These requirements apply to pleadings and other filings except where otherwise prescribed by statute or rules and regulations.

<u>012.01</u> FORM. Except as provided in section 008, pleadings and filings other than letters must contain:

- (A) Captions that include the venue, names and capacities of the parties, and pleading name;
- (B) Descriptions of all material facts pertinent to the pleading, requests for whatever action or relief is sought, references to applicable law, and any further statements necessary to explain the pleading or as required by law;
- (C) Signatures of the party or the party's attorney, if represented;
- (D) <u>Names, addresses, and telephone numbers of the party or the party's attorney, typed</u> or hand-printed beneath the signature, as well as attorneys' bar numbers; and
- (E) <u>Certificates of service, signed by the party, the party's attorney, or other person who</u> <u>serves the pleading, in the case of pleadings other than petitions.</u> <u>Certificates must</u> <u>identify the pleading, names and address of all persons on whom the filing was</u> <u>served, method of service, and date service was made.</u>

<u>009.01A5</u> In pleadings other than a petition, a certificate of service, signed by the party, his or her attorney, or other person who serves the pleading. <u>012.02</u> SIZE AND PAPER. Pleadings and other filings must be on white, letter-sized (8 ½ X 11) paper, single-sided, and legible. If handwritten, pleadings must be in ink. Attachments must meet these requirements unless otherwise approved by the hearing officer.

<u>009.01B Size and Paper</u>. All pleadings and other filings shall be made on white, letter-sized (8 1/2 x 11) paper of standard weight.

<u>009.01C Print</u>. All pleadings shall be legibly typewritten, mimeographed, photostatically reproduced, printed, or handwritten. If handwritten, they must be written in ink. Only one side of a page shall contain any writing.

<u>009.01D</u> Attachments. Documents attached to a pleading shall be securely fastened to the pleading and shall meet the requirements of 009.01B and 009.01C, unless otherwise approved by the Director, or Hearing Officer.

012.03 FILING. Pleadings and other materials must be filed in the Division by personal delivery, email, or mail during regular office hours. Pleadings received after regular officer hours will be stamped as received on the following work day. Parties may request receipts for any filing they make. Requests must be accompanied by an extra copy of the document for stamping and return.

<u>009.01E Filing</u>. Except as otherwise provided in these regulations, pleadings and other filings shall be filed in the office of the Director. Filing may be accomplished by personal delivery or by mail. <u>011.03 Evidence Made Part of the Record</u>. All records and documents shall be offered and made a part of the record in the case. Relevant portions of books, papers or documents shall be plainly designated and distinguished from all irrelevant portions before the relevant material may be entered into the record. When irrelevant material in a document is so voluminous it will encumber the record, the document may be marked for identification and the relevant material read into the record. All exhibits must be marked and shown to the opposing party or counsel before being offered into evidence.

<u>011.04 Substitution of Copies</u>. Duplicate copies may be substituted for original documents marked and made part of the record with the permission of the Director or Hearing Officer.

<u>011.09A To Hearing Testimony</u>. In general, objections should be made after the question but before the answer if the question calls for inadmissible matter or that the question is in improper form. <u>011.09B To Documentary or Tangible Evidence</u>. An objection to a document should be made at the time the document is offered into evidence.

<u>015.01</u> <u>PUBLIC ATTENDANCE.</u> <u>012.01</u> <u>Public Attendance.</u> Hearings on contested cases are open to the public, except that evidence subject to a protective order may be received in camera or under such conditions as may be appropriate to preserve confidentiality. <u>Records</u> will be made of any portion of a hearing held in camera. The hearing officer may order the record sealed to be made available only for purposes of review by the hearing officer or other person authorized to recommend or render a decision in the case or a court of competent jurisdiction in an appeal.

<u>015.04</u> <u>ORDER OF PROOF.</u> <u>012.04</u> <u>Order of Proof.</u> Evidence will be received in the following order unless a different order is required by law or ordered by the hearing officer the Hearing Officer orders a different procedure or a different order is required by law:

(1<u>A</u>)t<u>The main case of the plaintiff, petitioner, or appellant plaintiff/petitioner/appellant;</u> (2<u>B</u>)t<u>The case of the defendant, respondent, or appellee defendant/respondent/appellee;</u> (3<u>C</u>)t<u>The rebuttal by the plaintiff, petitioner, or appellant plaintiff/petitioner/appellant; and</u> (4D)sSurrebuttal of defendant, respondent, or appellee defendant/respondent/appellee.

015.05 BASIC STAGES. 012.05 Basic Stages of Hearing. The basic stages of hearing are:

<u>015.05(A)</u> <u>OPENING. 012.05A</u> <u>Opening of the Proceedings.</u> The Hearing <u>Oofficers</u> will open the proceedings by announcing the case to be heard, <u>entering the notice of hearing into the record</u>, introducing <u>him/herself themselves</u> and asking for the parties or their counsel to make their appearances (i.e., announce their presence and identify themselves).

<u>015.05(C)</u> <u>OPENING STATEMENTS.</u> <u>012.05C</u> <u>Opening Statements.</u> Parties may make opening statements of no more than 20 minutes in length, unless otherwise permitted by the hearing officer, related to the evidence presented and explanation of that evidence. The parties are granted the opportunity to make opening statements if they so desire. Opening statements take place in the same order as the order of proof. Parties may reserve the opening statement to precede the presentation of that party's case.

<u>015.05(D)</u> <u>PRESENTATION OF EVIDENCE.</u> <u>012.05D</u> <u>Presentation of the Evidence.</u> The evidence is presented in the order described in <u>015.04</u> <u>012.04</u>. In each stage described in <u>012.04</u>, witnesses customarily pass through the following steps:

(i)<u>012.05D1</u>Direct examination conducted by the party <u>calling</u> who calls the witness.; (ii)<u>012.05D2</u>Cross-examination by the opposing party-;

(iii)012.05D3 Re-direct examination by the party who called the witness-; and

(iv)012.05D4 Re-cross examination by the opposing party.

<u>015.05(E)</u> <u>CLOSING ARGUMENTS.</u> <u>012.05E</u> <u>Closing Arguments.</u> After the evidence is presented, parties may make closing arguments of no more than 20 minutes in length, unless otherwise permitted by the hearing officer, related to the evidence presented and explanation of that evidence. After the evidence is presented, each party may have

<u>015.05(F)</u> <u>OTHER MATTERS.</u> <u>012.05F</u><u>Other Matters.</u> After the close of the evidence and any argument, the <u>Hh</u>earing <u>Oo</u>fficer may take up such matters as may be necessary before closing the <u>hearing (e.g., briefing)</u>.

<u>015.05(G)</u> <u>CLOSING</u>. <u>012.05G</u> <u>Closing the Hearing</u>. The <u>Hh</u>earing <u>Oo</u>fficer announces the closing of the hearing.

<u>012.06 Opening Statements and Closing Arguments</u>. Opening statements and closing arguments will be permitted only insofar as the statements or arguments relate to the evidence presented and explanation of that evidence. Unless otherwise permitted by the Hearing Officer, opening statements and closing arguments shall be limited to twenty (20) minutes by each party.

Either or both parties may waive oral argument. A party may reserve opening statement to precede the presentation of his or her case.

<u>015.06</u> <u>HEARING BY WRITTEN SUBMISSIONS AND STIPULATIONS.</u> <u>012.07</u> <u>Stipulations</u> <u>or Hearing by Written Submission.</u> Parties may enter into agreements to offer their cases by written submission or may stipulate to the facts and proceed to hearing on the issue of disposition only. <u>Any sS</u>uch agreements must be <u>made</u> in writing and entered into the record or be made verbally on the record at time of hearing. <u>Parties shall be bound by their agreements</u>.

<u>015.08</u> <u>PARTIES APPEARING WITHOUT COUNSEL.</u> <u>012.09</u> <u>Direct Testimony By Parties</u> <u>Appearing Without Counsel.</u> Parties appearing without counsel may present their own testimony by narration, and shall <u>will</u> be sworn in prior to beginning testimony.

<u>015.09</u> <u>RECESSES.</u> <u>012.10</u> <u>Recesses.</u> The <u>Hh</u>earing <u>Oo</u>fficer may recess the hearing for breaks, meals, and from day to day until the hearing is completed. If a hearing exceeds the day or days scheduled, the matter may be recessed to the next available date for proceeding with hearing.

<u>015.10</u> <u>BRIEFS.</u> <u>012.11</u> <u>Briefs.</u> Parties may submit pre-hearing or post-hearing briefs, and they may be required by the hearing officer to submit briefs simultaneously or according to a prescribed schedule. In addition, the Director or Hearing Officer may require the parties to submit briefs either simultaneously or according to a prescribed schedule.

The parties shall have opportunity to be heard on the motion. If the motion is granted, the opposing party shall will be given opportunity to offer rebuttal.

<u>015.12</u> <u>REOPENING.</u> <u>012.13 Reopening a Case.</u> Once a hearing is closed, it will be reopened only upon a showing of good cause and before judgment. Application shall may be made by motion and shall will be heard unless the parties stipulate and jointly move to reopen the case.

016.013 DECISIONS AND ORDERS. The rendering of decisions and issuance of orders are subject to 53 NAC 4-008.

<u>013.01</u> <u>Decisions, Generally</u>. Every final decision rendered by the Department shall be in writing or stated in the record, and shall be accompanied by findings of fact and conclusions of law. The parties to the proceeding shall be notified of the decision by certified mail or registered mail, return receipt requested. Service on the attorney for a party shall be deemed service on the party. The department may withhold a final decision from public access for a period of five (5) days from the date the decision is entered or until service is made, whichever is earliest.

<u>013.01A Proposed Findings of Fact and Conclusions of Law</u>. objections to the proposed findings of the other by motion made within five (5) days of their receipt of the proposal or such other time as the Director or Hearing Officer may order. Any such objections shall identify the evidence in support of that party's objection.

<u>013.02 Evaluation of Evidence</u>. The Department may utilize its experience, technical competence, and specialized knowledge in the evaluation of the evidence presented.

<u>013.03 Sanctions - Considerations</u>. The following are lists of factors that may be considered in determining appropriate sanctions in a disciplinary proceeding after guilt has been established by the record, and when supported by the record. These factors are not intended to be exclusive, and such other or different factors will be considered when they are permitted or required by law and as the evidence supports.

<u>013.03A Aggravating Factors</u>. The following may be considered as aggravating factors depending on the facts established by the evidence:

013.03A1 Multiple incidents; however, uncharged incidents will not be considered;

<u>013.03B2</u> A mental or physical condition that significantly reduces culpability, if such a condition is not an element of the violation;

<u>013.03B3</u> Corrective efforts initiated by the person charged and related to the conduct charged, such as changes in practices, policies, behavior, participation in treatment, training, etc., though consideration will be given to the extent to which such efforts were voluntary and self-motivated.

013.03B4 A prior record in good standing;

013.03B5 Contriteness and willingness to cooperate.

<u>013.03C</u> Other Factors. Those factors described in section 010.14E1 of these regulations with regard to review of settlements may also be considered in determining appropriate sanctions for purposes of findings after hearing, as applicable.

<u>013.03D</u> Actions under 006.01 or 006.02. In disciplinary actions under 006.01 or 006.02, if the Director determines that guilt has been established, the Director may, at his or her discretion, consult with the board of examiners for the profession involved concerning sanctions to be imposed or terms and conditions of sanctions. When the Director does so consult, the licensee, certificate holder, or registrant shall be provided with the Director's request, the recommendation of the board and an opportunity to respond in such manner as the Director determines.

<u>013.04 Decisions; Taxation of Costs.</u> All costs of a formal hearing shall be paid by the party or parties against whom a final decision is rendered. Costs shall be charged as in ordinary civil actions in the district court.

A motion for reconsideration does not extend the statutory time to appeal.

014.01 Circumstances. A reconsideration of a matter that has been decided may occur:

<u>014.01A</u> When a motion for rehearing filed by a party dissatisfied with the decision of the Department is granted; or

<u>014.01B</u> When a court to which a decision has been appealed remands the case for reconsideration or rehearing.

<u>017.03</u> <u>DECISIONS</u>. <u>014.06</u> <u>Decision</u>. <u>Decisions on motions</u> <u>A decision on a motion</u> for rehearing <u>reconsideration shall will</u> be made by order within 27 days of the date the final decision was served. A decision may be made orally by the <u>hearing officer</u> <u>Director</u> at time of hearing, but <u>will shall</u> be reduced to writing within such period. <u>Decisions may be served by</u> certified mail, return receipt requested, or personal delivery.

<u>017.04</u> BASIS FOR RECONSIDERATION. <u>014.07 Basis for Reconsideration.</u> The Department may grant a motion for rehearing if the motion is made in proper form, is filed within the proper time, and when the Department is satisfied that one or more of the following

conditions are met: Motions for reconsideration made in the proper form and filed within the proper time may be granted if:

- (A)014.07A tThe motion and record show a serious irregularity in the conduct of the proceeding;
- (B)014.07B tThere is newly-discovered evidence which was not available to the moving party at the time of the hearing and which may be sufficient to reverse the Division's Department's action;
- (C)014.07C The decision is contrary to the manifest weight of the evidence;
- (D)014.07D The motion and record show an error of law; or
- (E)014.07E There was good cause for the moving party's failure to appear or to file papers, which resulted in default by that party.

017.05 PROCEDURE. 014.08 Procedure. When a motion for rehearing is granted or upon remand by a court for rehearing, the parties shall be provided rehearing. Depending up the basis upon which it is granted, reconsideration may consist of an entirely new hearing; reopening the record of hearing for the limited purpose of receiving newly discovered evidence; or entry of new findings and conclusions of law. Upon the granting of a motion for reconsideration the original decision will be vacated. When new hearing proceedings are required, the order will set the date, time and location of hearing, and prehearing and hearing proceedings.

<u>014.08A</u> Rehearing may consist of, as appropriate to the basis on which reconsideration is granted or the case remanded:

014.08A1 An entirely new hearing; or

<u>014.08A2</u> A reopening of the record of hearing for the limited purpose of receiving newly discovered evidence; or

014.08A3 Entry of new findings of fact and conclusions of law.

<u>014.08B</u> Upon the granting of a motion for rehearing the original decision shall be vacated. When new hearing proceedings are required, the order shall set the date, time and location

of hearing, and prehearing and hearing procedures shall be the same as those for the original proceeding.

018.015 APPEALS. Appeals are governed by 53 NAC 4-009.

<u>015.01 By Whom</u>. Any person aggrieved by a final decision in a contested case before the Department, whether the decision is affirmative or negative in form, is entitled to judicial review under the Administrative Procedure Act, or to resort to such other means of review as may be provided by law.

<u>015.02 When</u>. Persons desiring to appeal a Department decision must do so within thirty (30) days after the service of the final decision of the Department.

<u>015.03 Procedure</u>. Unless otherwise provided by statute or regulation, the procedures of Neb. Rev. Stat. §84-917 govern the procedure for taking an appeal.

<u>015.04 Enforcement of the Decision (Stay)</u>. The filing of an appeal in a court of competent jurisdiction does not stay the enforcement of a Department decision. The Department may order a stay, or the court may order a stay after notice to the Department of an application for stay. In determining whether to grant a stay, the Department will consider whether a stay is justified to protect against a substantial threat to public health, safety or welfare.

<u>015.05</u> Record on Appeal. The Department shall, within thirty (30) days after service of a petition on appeal, or within such further time as the court for good cause may allow, prepare and transmit to the court a certified transcript of the proceedings, including the final decision under appeal. The record shall contain:

015.05A Notice of all proceedings;

<u>015.05B</u> Any pleadings, motions, requests, preliminary or intermediate rulings and orders, and any similar correspondence to and from the agency pertaining to the case;

<u>015.05C</u> The transcribed record of the hearing, including all exhibits and evidence introduced during the hearing, statement of matters officially noticed, and all offers of proof and objections and rulings thereon;

<u>015.05D</u> The final order appealed from.

<u>015.06</u> <u>Costs of Record</u>. The Department shall require the party appealing to pay for the reasonable direct cost of preparation of the official record except when that party is not required to pay a filing fee to initiate court appeal. The Department may require payment or bond prior to the transmittal of the record.

<u>016 REPEAL</u> The former Rules of Practice and Procedure of the Department, 184 NAC 1, are hereby repealed.

Attachment 1

GLOSSARY OF TERMS

Affidavit means a written declaration of facts made under oath before a Notary Public.

Admission means the confession or voluntary acknowledgement by a party that a fact or point that the opposing party is making is true.

Brief means a written statement by a party to explain his case or an issue in the case to the Department containing a fact summary, law summary, and argument about how the law applies to the facts.

<u>Closing Argument</u> means the verbal or written statements of the parties, made after all evidence has been offered by the parties at hearing, which lays out the parties' view of the facts proven, the law applicable to the case, and the reasoning that connects the facts and law.

<u>Competent Evidence</u> means evidence that is both relevant to the point in question and is the proper type of evidence to prove a point.

Consolidation means the combining of separate cases.

<u>Continuance</u> means the postponement of the hearing of a case or of a hearing on an issue of a case to a later date.

Cross-Examination means the questioning of person called as a witness by the opposing party either at hearing or in deposition.

<u>Cumulative Evidence</u> means evidence that is offered to show what has already been proven by other evidence.

Default means the failure of a party to appear at hearing.

Direct Examination means the first questioning in a hearing of a witness by the side that called the witness to testify.

<u>Discovery</u> means methods permitted by law for one party to obtain evidence from another party concerning the subject matter of a contested case before the Department, including interrogatories, requests for admission, motions or requests for production, responses to any of the same, depositions, and physical or mental examination.

Dismissal means termination of a contested case. When an order for dismissal is made "with prejudice," any further cases brought by the same person on the same subject are precluded. When made "without prejudice" a future case by the same person on the same subject is not precluded.

Ex Parte Communication means a written or oral communication about the substance of a contested case made by, for, or on behalf of one party outside of the presence of the other party.

Evidence means all types of information (testimony, affidavits, documents, or concrete objects) presented at hearing.

Exhibit means either (1) any object or document offered as evidence in a hearing or deposition or (2) any document attached to a pleading, affidavit, or any other formal paper.

Extension or Enlargement of Time means a lengthening of time.

Hearing means, as the context requires, either (1) a formal proceeding before the Department for the purpose of receiving evidence on issues of fact to make a determination of the rights, privileges or duties of parties to a contested case; or (2) a proceeding before the Department, held after notice, to hear arguments on matters brought to the attention of the Department by motion or other pleading to be determined before or after the evidentiary hearing on the merits of a contested case.

Impeachment means showing that a witness is untruthful.

Objection means the claim that a particular question, answer to a question, or use of a particular piece of evidence is improper, unfair, or illegal, and the request that the Hearing Officer or Director rule on the point.

Offer into Evidence means to introduce evidence or to attempt to have something admitted into evidence.

Offer of Proof means the process by which a party discloses the nature, purpose and admissibility of evidence after an objection to evidence by the opposing party has been sustained by the Hearing Officer.

Official Notice means the act of recognizing the existence or truth of certain facts without the necessity that those facts be put into evidence.

Opening Statement means the explanation at the beginning of a hearing by each side of his or her version of the facts, how the facts will be proven, and how he or she thinks the law applies to the case.

Order means a written command or direction given by the Director or his or her designee.

<u>Praecipe</u> means a request from a party to the Department to serve a petition or other pleading or subpoena on a person with instructions that identify the person and where and how service should be made.

<u>Preheating conference</u> means a meeting between the Hearing officer and the parties for the purpose of preparation for hearing, and which may include, but is not limited to, such things as clarifying or narrowing the issues to be determined at hearing, exchanging and making exhibits, exchange of lists witnesses, ruling on pending motions, or exploring possibility for settlement.

<u>Privilege</u> means a right or duty recognized by law to withhold information, usually because of some special status or relationship of confidentiality.

Probative means tending to prove or actually proving something.

<u>Progression conference</u> means a meeting between the Hearing Officer and the parties for discussing the status of matters preliminary to hearing such as progress in discovery, hearing motions, and setting timelines for pre-hearing matters and hearing.

<u>Protective order</u> means an order that permits a party to hold back from showing documents or other things to the other party or that protects documents or things from disclosure to the general public.

<u>Rebuttal</u> means contradicting, refuting or defeating of statements, facts or arguments made by the opposing party.

<u>Relevant</u> means evidence having any tendency to make the existence of any fact that is of consequence to the determination of the action more probable or less probable than it would be without the evidence.

<u>Rules of Evidence</u> means the rules and principles set forth in Neb. Rev. Stat. §§27-101 to 27-1103 about whether evidence can be admitted or accepted as proof in a hearing and how to evaluate its importance.

Ruling means settling or deciding a motion or objection made at hearing.

Sequestration means the isolation of witnesses who are to testify at formal hearing to preclude their observation of the testimony of other witnesses.

Settlement means the agreement by the parties to the result of a case, including stipulation, agreed order, consent order or similar method as agreed to by the parties.

Subpoena means an order to a person to appear for deposition or at a formal hearing to testify in a case, and, when identified as a subpoena duces tecum, to bring certain documents.



CHAPTER 2 - RULES OF PRACTICE AND PROCEDURE OF THE DEPARTMENT OF HEALTH FOR DECLARATORY ORDERS

<u>001 SCOPE</u>. These rules and regulations govern the form to be used in petitioning the Department for a declaratory order and the procedure for submission of petitions, their consideration, and their disposition.

002 DEFINITIONS. As used in these regulations the following definitions shall apply:

<u>002.01 Argument</u> means the oral statement of the petitioner or any other party which explains his or her view of the facts and issue to be decided, the law applicable to the question presented, and the reasoning that connects the facts and law.

<u>002.02</u> <u>Contested Case</u> means a proceeding before the Department in which the legal rights, duties, or privileges of specific parties are required by law or constitutional right to be determined after hearing before the Department.

<u>002.03</u> <u>Declaratory Order</u> means a written response by the Department to a question submitted by an person with respect to the applicability to specified circumstances of any statute, rule, regulation or order within the primary jurisdiction of the Department.

002.04 Department means the Department of Health.

002.05 Director means the Director of Health.

<u>002.06</u> Intervenor shall mean persons who have or claim to have any interest, legal right, duty, privilege, or immunity which would be directly affected by the agency's issuance of a binding declaratory order.

<u>002.07 Necessary Party</u> as distinguished from a general interest such as may be the concern of the public at large, and who is or would be adversely affected in a legally cognizable way by the uncertainty sought to be resolved.

<u>002.08 Party</u> means the petitioner and any person granted leave to intervene in a declaratory order proceeding.

<u>002.09 Person</u> means individuals, partnerships, any bodies politic or corporations, either profit or non-profit.

<u>002.10 Petition</u> shall mean the document filed in accordance with section 003 of these regulations to initiate or to intervene in a declaratory order proceeding.

002.011 Petitioner means the person filing a petition for declaratory order.

<u>002.12 Rule or Regulation</u> means any rule, regulation, or standard issued by the Department certified and filed with the Secretary of State of the State of Nebraska under the Administrative Procedure Act, Neb. Rev. Stat. §84-901 <u>et seq.</u>

003 DECLARATORY RULINGS GENERALLY

<u>003.01 Purpose</u>. A declaratory order procedure provides a means by which persons, may request a response to a question about a statute, regulation, or order as it applies to specified circumstances.

<u>003.02 Subjects for Declaratory Orders</u>. A declaratory order may be requested on the applicability of a statute, regulation or order enforced by the Department.

<u>003.02A</u> "Applicability" refers to the appropriateness of the relation of the law to the person, property or state of facts, or its relevance under the circumstances given. It may include such questions as whether the law applies at all, to whom it applies, when it applies, how it applies, or which law applies.

<u>003.02B</u> A declaratory order may be requested only on the applicability of existing statutes and rules and regulations.

<u>003.02C</u> A declaratory order may be requested to obtain a determination of proposed conduct, not to obtain a determination of the effect of conduct that has already taken place or is taking place.

<u>003.02D</u> A declaratory order is not a mechanism for review or appeal of a decision made by the Department in a contested case.

<u>003.02E</u> A declaratory order may not be requested to obtain a declaration by the Department that a statute or regulation is unconstitutional, or that a regulation of the Department is invalid.

<u>003.02F</u> A declaratory order may not be issued by the Department that would substantially prejudice the rights of a person who would be a necessary party and who does not consent in writing to the determination of the matter by a declaratory order proceeding.

<u>003.03 Who May Request An Order</u>. Any person may request a declaratory order from the Department. The parties shall be the petitioner and any persons who qualify for intervention and file timely petitions for intervention under section 005.03 of these regulations.

<u>003.04 When A Ruling May Be Requested</u>. A petition for declaratory order may be filed at any time, except that when a declaratory order has been issued, or declined, the Department may refuse to issue a ruling on a subsequent petition covering substantially the same subject matter that is filed within one hundred twenty (120) calendar days.

<u>003.05 Effect of Ruling</u>. A declaratory order shall have the same status and binding effect as any other order issued in a contested case. Such an order is based upon unproven facts a petitioner furnishes to the Department. The actual existence of those facts generally would become an issue only in later administrative proceedings in which a party seeks to use a declaratory order as justification for that party's conduct. An order on the merits will not be binding if the facts are other than as represented and relied upon in issuing a declaratory order.

004 PETITION FOR DECLARATORY ORDER

<u>004.01 Request</u>. A request for a declaratory order must be made by petition that meets the requirements of subsections 004.02 and 004.03 of this section.

004.02 Form.

<u>004.02A Pleading.</u> A petition for declaratory order may be in the form of a pleading or letter which shall contain:

004.02A1 A caption, which shall include:

004.02A1a The venue: BEFORE THE DEPARTMENT OF HEALTH, STATE OF NEBRASKA;

<u>004.02A1b</u> A heading specifying the subject matter and the name of the petitioner; and

<u>004.02A1c</u> The name of the pleading: PETITION FOR DECLARATORY RULING.

004.02A2 The statements required in 004.03 below.

<u>004.02A3</u> The signature of the petitioner, or when represented by an attorney, the signature of the attorney.

<u>004.02A4</u> The name and address of the petitioner, and when represented by an attorney, the name, address, telephone number, and bar number of the attorney.

<u>004.02B Size and Paper</u>. Petitions shall be made on white, letter-sized (8 1/2 x 11) paper of standard weight.

<u>004.02C Print</u>. Petitions shall be legibly typewritten, photostatically reproduced, printed, or handwritten. If handwritten, they must be written in ink. Only one side of a page shall contain any writing.

<u>004.02D Attachments</u>. Any documents attached to a petition shall be securely fastened to the pleading and shall meet the requirements of 004.02B and 004.02C for paper and print, and when possible, be reproduced on 8 1/2" x 11" paper or placed in an 8 1/2" x 11" envelope and clearly marked as an attachment to the petition.

<u>004.03 Content</u>. To be considered, a petition for declaratory order must meet the following requirements for content and substance.

<u>004.03A Identification.</u> The petition shall provide the name, address and day time telephone number of the petitioner.

<u>004.03B</u> Statement of Facts. The facts surrounding the problem or question presented in the petition must be complete, specific and particularized to the problem or question.

<u>004.03C</u> Nature of the Question. The petition must state the precise question for which a declaratory order is sought, which shall be as narrowly posed as the surrounding facts permit. The question shall identify the statute and/or rule and regulation applicable, or believed to be applicable, to the situation presented.

<u>004.03D</u> Statement of Position. The petition shall state the petitioner's position as to how the Department should rule and why the Department should rule in the manner requested.

<u>004.03E</u> <u>Necessary Parties</u>. The petition must identify by name and address all persons known to petitioner who may have a specific personal interest in the applicability of the statute, regulation or order or who may be adversely affected by the uncertainty sought to be resolved by the petitioner. The petitioner shall also attach any written consents to the determination of the matter requested by declaratory order proceeding that the petitioner has obtained from such persons.

<u>004.03F Attachments</u>. Any documents pertinent to the petition that the petitioner wishes to be considered in making a ruling must be attached to the petition.

<u>004.03G</u> Verification. The petition shall be subscribed and verified by the petitioner. If the Petitioner is a corporation, political subdivision, or other entity, then the petition shall be subscribed and verified by a duly authorized agent of the petitioning entity.

<u>004.04 Sample Petition</u>. A petitioner may use the sample form of petition approved by the Department, a copy of which is attached as Attachment A to these regulations and made a part of these regulations by reference. A petitioner may also prepare his or her own petition, so long as it is a reasonable facsimile in form and meets the requirements of subsections 004.02 and 004.03.

<u>004.05 Filing</u>. A petition for declaratory order by the Department shall be filed in the office of the Director of Health. Filing may be accomplished by personal delivery or by mail. Filings will be received during regular office hours of the Department. Office hours are from 8:00 a.m. to 5:00 p.m., Monday through Friday, excluding state holidays. The mailing address for the Department is Department of Health, Third Floor, 301 Centennial Mall South, Lincoln, Nebraska 68509.

<u>004.06 Number of Copies</u>. In addition to the original petition, two (2) copies shall be delivered to the Department for Department use.

<u>004.07 Reception of Petition</u>. The Department shall stamp all petitions and other filings relating to a declaratory order action as "RECEIVED" and with the date of filing. Filings received after regular office hours shall be stamped as received the following work day.

<u>004.08 Request for Receipt</u>. Request may be made for a receipt for any filing made. Request may be made by letter or verbally. The request must be accompanied by an extra copy of the document for stamping and return, and if return is to be by mail, a stamped, self-addressed envelope.

<u>004.09 Service of Petition</u>. At the same time the petitioner shall serve a copy of the petition, by certified mail, return receipt requested, on all necessary parties, including all persons, political subdivisions, corporations, organizations or other entities who are known to have or claim any interest, legal right, duty, privilege, or immunity which would be directly affected by issuance of a declaratory order in this matter by the Department.

005 CONSIDERATION AND DISPOSITION OF PETITIONS

<u>005.01 Process Generally</u>. Upon the filing of a petition, the Director may consider the petition for him/herself, refer a petition to an appropriate licensing or governing board, or delegate the matter to a designated hearing officer, board, or a Department employee to consider the petition and recommend a decision to the Director.

<u>005.01A</u> In reviewing a petition, the Department may, in its discretion do one or more of the following:

<u>005.01A1</u> Require that additional information be submitted before the petition will be considered.

<u>005.01A2</u> Require petitioner to provide notice to persons who may be necessary parties and other persons of the pendency of the proceeding;

<u>005.01A3</u> Schedule a date, time and location at which the petitioner and any other parties may make an oral presentation on the petition.

005.01A4 Consider the petition and any attachments without oral presentation.

<u>005.01B</u> Within thirty (30) days after receipt of a petition, the Department shall in writing:

005.01B1 Set the matter for specified proceedings as described in 005.01A

005.01B2 Decline to issue a declaratory order on the merits of the petition; or

005.01B3 Issue a declaratory order.

<u>005.01B4</u> Agree to issue a declaratory order by a specified time.

Notwithstanding this section, the Department may determine at any time that it will not issue a declaratory order if issuance of an order under the circumstances would be contrary to any provisions of section 005.11 of these regulations. The Department shall notify the petitioner and, if applicable, any intervenor or necessary party in writing when the Department determines not to issue a declaratory order.

<u>005.01C</u> If the Department has not issued a declaratory order within sixty (60) days after receipt of a petition therefor, the petition shall be deemed to have been denied.

005.01D Decisions; By Whom Made. Decisions on petitions may be made:

<u>005.01D1</u> Only by the Director, when the decision is to issue an order on the merits on behalf of the Department;

<u>005.01D2</u> By a designee of the Director, when the decision is not to issue an order on the merits on behalf of the Department;

<u>005.01D3</u> By a requisite number of members of a board, when a petition seeks a declaratory order about statutes or regulations that are within the sole authority of a board of the Department to implement by regulations or otherwise; or

<u>005.01D4</u> By both the Director and a board, when they have joint authority to adopt regulations to implement or interpret the law for which an order is sought.

Either the Director or the designated representative may call upon other staff of the Department to provide technical or legal advice as needed to make or to recommend a determination.

<u>005.02</u> Additional Information. If, upon review of the petition, additional information is determined by the Department to be needed to consider the petition, the Department shall notify the petitioner of the nature of the information to be submitted. The request may be made in writing or verbally, but if made verbally, must be confirmed to writing and signed by the person making the request. Department review shall be made within fifteen (15) days of the filing of the petition. The petitioner shall have five (5) days from the receipt of the verbal or written request in which to submit the requested information. The information must be given in writing and be signed by the petitioner. The request and response will be made part of the official record of the proceeding.

<u>005.03 Intervention</u>. Persons who qualify for intervention and file timely petitions for intervention may intervene in proceedings for declaratory orders. The Department may, at its discretion, invite any person or entity to file a petition for intervention.

<u>005.03A When.</u> The Department shall grant a petition for intervention if all of the following are satisfied.

<u>005.03A1</u> The petition is submitted in writing to the Director or designee, with copies mailed to all parties named in the Director's notice of the hearing, no later than twenty-five (25) days after the filing date of the petition to permit consideration prior to disposition as provided by 005.01B. After the period specified in 005.01B intervention may be allowable:

<u>005.03A1a</u> upon motions made not less than five (5) days prior to any proceedings scheduled; or

<u>005.03A1b</u> upon motions made not more than forty-five (45) days after filing of the petition when the matter is still under consideration;

whichever is earlier.

<u>005.03A2</u> The petition states facts demonstrating that the petitioner's legal rights, duties, privileges, immunities, or other legal interests may be substantially affected by the proceeding or that the petitioner qualifies as an intervenor under any provision of law.

<u>005.03A3</u> The Department determines that the interests of justice and the orderly and prompt conduct of the proceedings will not be impaired by allowing the intervention. The Department may grant a petition for intervention at any time upon determining that the intervention sought is in the interests of justice and will not impair the orderly and prompt conduct of the proceedings.

<u>005.03B</u> <u>Conditions</u>. If a petitioner qualifies for intervention, the Department may impose conditions upon the intervenor's participation in the proceedings, either at the time that intervention is granted or at any subsequent time. Conditions may include:

<u>005.03B1</u> Limiting the intervenor's participation to designated issues in which the intervenor has a particular interest demonstrated by the petition;

<u>005.03B2</u> Limiting the intervenor's participation to briefing or other procedures so as to promote the orderly and prompt conduct of the proceedings; and

<u>005.03B3</u> Requiring two or more intervenors to combine their presentation(s) and other participation in the proceedings.

<u>005.03C</u> Order on Intervention. The Department shall issue an order granting or denying each pending petition for intervention, specifying any conditions and briefly stating the reasons for the order:

<u>005.03C1</u> On or before the thirtieth day following the filing of the petition for declaratory order when intervention is sought under 005.03A1.

<u>005.03C2</u> Within twenty four hours after a petition for intervention is sought under 005.03A1a or 005.03A1b, as applicable.

The Director or designee may modify the order at any time, stating the reasons for the modification. The Director or designee shall promptly give notice of an order granting, denying, or modifying intervention to the petitioner for intervention and to all parties.

<u>005.04</u> Oral Presentation (Argument), When. Oral argument shall be had only on specific order of the Department on its own motion or upon motion by petitioner or other party. Request may be made in the petition. If opportunity for oral argument is granted, argument shall be scheduled to be held not more than forty-five (45) days after filing of the petition. Petitioner and all other parties or, when represented, their attorneys, shall be served with a notice of the date, time and place for oral argument not less than five (5) days in advance of the scheduled date. Service shall be made by certified mail, return receipt requested. Oral argument may be conducted either in person or by telephone conference or with the approval of the Department, by other electronic means that may be technically feasible, subject to agreement considering cost and responsibility for payment.

<u>005.05</u><u>Oral Presentation, Procedure</u>.<u>Oral presentation will be made before the</u> representative of the Department authorized to render or to recommend a decision or before a hearing officer.

005.05A The Department representative or hearing officer shall:

005.05A1 Identify the proceeding and introduce himself or herself;

<u>005.05A2</u> Ask the petitioner and any other parties or their representatives to identify themselves for the record;

005.05A3 Hear the oral presentation of the petitioner and any other parties; and

005.05A4 Close the proceedings.

<u>005.05B</u> At the declaratory order proceeding, agency staff shall have the right to present oral argument.

<u>005.05C</u> The Department representative or hearing officer conducting the proceeding may ask questions during or after the presentation(s).

<u>005.05D</u> Oral presentation shall not exceed forty-five (45) minutes per party in duration unless additional time is granted by the Department representative or hearing officer.

<u>005.05E</u> Parties may make oral presentation on their own behalf or be represented by an attorney.

<u>005.05F</u> A court reporter shall be present to record the presentation(s).

<u>005.06</u> Brief. A petitioner may submit a written argument, or brief, in support of the petition at time of filing without leave of the Department. The Department may require a brief or may grant opportunity to submit a brief after filing upon application by any party. If required or granted, the parties shall submit the brief according to the date set by the Department. A brief must meet the requirements of 004.02 in form.

<u>005.07 Decision, When</u>. The Department shall act on a petition within sixty (60) days of the date of the filing of a petition.

005.08 Decision, Form. The decision may be made in the form of a pleading or letter.

<u>005.09 Decision, Content</u>. The decision may consist of a declaratory order on the merits of the petition or a refusal to rule on the merits. When the decision is a refusal to rule, the decision shall contain the reasons for its action. Decisions consisting of a declaratory order shall contain:

005.09A The names of all parties to the proceeding on which it is based;

005.09B The particular facts on which it is based; and

<u>005.09C</u> The statute, regulations, rule or order at issue in the matter;

<u>005.09D</u> The Department's conclusion as to the applicability of the statute, regulations, rule, or order to the facts;

<u>005.09E</u> The Department's conclusion as to the legal effect or result of applying the statute, regulations, rule, or order to the facts; and

<u>005.09F</u> The reasons for the conclusions reached.

<u>005.10</u> <u>Decision, Service</u>. The petitioner, and any other party, or if represented, their attorneys, shall be served with a copy of the decision by certified mail, return receipt requested.

005.11 Refusal to Rule, Grounds

<u>005. 11A</u> Grounds upon which the Department shall refuse to issue a declaratory order include, but are not limited to, the following:

<u>005.11A1</u> The petitioner fails to submit any additional information requested or submits such information after the due date;

<u>005.11A2</u> The petition requests a declaratory order on a matter that is outside the scope of authority of the Department;

<u>005.11A3</u> The petition requests review or appeal of a decision made by the Department in a contested case;

<u>005.11A4</u> The petition requests a declaratory order on the effect of past conduct or current conduct;

<u>005.11A5</u> An investigation for purposes of formal adjudication, contested case, or a petition to issue, amend, or repeal regulations is pending before the Department involving the petitioner or substantially the same or similar facts or issues raised in the petition;

<u>005.11A6</u> The petition seeks a declaration that a statute or rule and regulation is unconstitutional or invalid;

<u>005.11A7</u> The issue raised has been definitely settled by a change in circumstances or other means so that the need for a ruling has terminated.

<u>005.11A8</u> An order would substantially prejudice the rights of a person who would be a necessary party and who does not consent in writing to the determination of the matter by a declaratory order proceeding.

<u>005.11A9</u> An order may affect the rights or duties of a class or classes of persons so that a declaratory process is unmanageable or the issues should be addressed through rulemaking or adjudication.

<u>005.11B</u> The types of grounds upon which the Department may determine to refuse to issue a declaratory order, may include, but are not limited to, the following:

<u>005.11B1</u> Refusal is necessary to assure adequate allocation of Department resources available for issuing rulings on petitions raising questions of greater urgency or significance;

<u>005.11B2</u> Less than one hundred twenty (120) calendar days has elapsed since a declaratory ruling was issued or declined on any petition covering substantially the same subject matter.

<u>005.11B3</u> The question presented is of such complexity that the Department has had insufficient opportunity or resources to develop a fully matured opinion;

<u>005.11B4</u> The issue raised requires analysis of so many complex factors that it is unmanageable outside of a full-scale adjudication;

005.11B5 A ruling would not resolve the controversy or uncertainty;

<u>005.11B6</u> The question posed or facts presented are insufficiently specific, overbroad, or are otherwise inappropriate as a basis on which to decide;

<u>005.11B7</u> The issue raised turns on peculiar facts which cannot be predicted or adequately described in advance.

006 APPEAL

<u>006.01 Right of Review</u>. A declaratory order is subject to review in the manner provided in the Administrative Procedure Act, Neb. Rev. Stat. §84-917, for contested cases.

<u>006.02</u> Stay. The taking of an appeal does not stay the enforcement of a binding decision. The Department or a court of competent jurisdiction may stay action upon application by the appealing party.

<u>006.03</u> Record. Within thirty (30) days after service on the Department of a petition on appeal, or such time as the court may allow, the Department shall prepare and transmit to the appropriate court a certified transcript of the proceedings before it. The record in a declaratory order action shall consist of, as applicable:

<u>006.03A</u> The petition and attachments to the petition;

006.03B Any request for additional information and the response of the petitioner;

006.03C The notice of oral argument;

006.03D The brief of the petitioner or any other party;

006.03E The transcribed record of oral presentation(s) made before the Department;

<u>006.03F</u> Motions, requests or correspondence by or between the petitioner or any other party and Department pertaining to the petition; and

006.03G The declaratory order appealed from.

<u>006.04 Costs</u>. The Department shall charge the appealing party with the reasonable direct cost for preparation of the record or require the party to advance the cost of preparation in all cases except when the party is not required to pay a filing fee to the court. The Department may require payment or bond prior to transmittal of the record.

CHAPTER 3 - RULES OF PRACTICE AND PROCEDURE OF THE DEPARTMENT OF HEALTH FOR PETITIONS FOR PROMULGATION, AMENDMENT, OR REPEAL OF REGULATIONS

<u>001 SCOPE</u>. These rules and regulations govern the form to be used in petitioning the Department to promulgate, amend or repeal regulations

002 DEFINITIONS. As used in these regulations the following definitions shall apply:

<u>002.01 Argument</u> means the oral or written statement of the petitioner which explains his or her view of the facts and issue to be decided, the law applicable to the question presented, and the reasoning that connects the facts and law.

002.02 Department means the Department of Health.

002.03 Director means the Director of Health.

<u>002.04 Person</u> means individuals, partnerships, any bodies politic, and corporations, either profit or non-profit.

<u>002.05 Petitioner means the person filing a petition for promulgation or amendment or repeal</u> of rules or regulations.

<u>002.06 Rule or Regulation</u> means any rule, regulation, or standard issued by the Department certified and filed with the Secretary of State of the State of Nebraska under the Nebraska Administrative Procedure Act, Neb. Rev. Stat. <u>§84-901 et seq.</u>

003 PETITIONS GENERALLY

<u>003.01 Purpose</u>. The petition process provides a means by which persons may request that the Department examine the propriety of issuing new regulations or amending or repealing existing regulations.

003.02 Subjects for Petitions.

<u>003.02A</u> A petition to amend or repeal a rule or regulation may be requested only on the applicability of existing statutes and rules and regulations.

<u>003.02B</u> A petition may not be requested to obtain a declaration by the Department that a statute or regulation is unconstitutional, or that a regulation of the Department is invalid.

<u>003.02C</u> A petition to amend or to issue new rules or regulations is appropriate only when the subject matter concerns something that the Department has authority to regulate.

<u>003.03 Who May File</u>. Any person may petition the Department to promulgate, amend or repeal rules or regulations. <u>See</u>, 002.04. The sole parties to a petition proceeding shall be the petitioner and the Department.

<u>003.04 When A Ruling May Be Requested</u>. A petition may be filed at any time, except that when a petition has been declined or a rulemaking proceeding initiated, a subsequent petition covering substantially the same subject matter will not be considered by the Department for a period of one hundred eighty (180) calendar days from the date of denial or initiation of rulemaking.

004 PETITION - FORM AND GENERAL FILING REQUIREMENTS

<u>004.01 Request</u>. A petition must meet the requirements of subsections 004.02 and 004.03 of this section.

<u>004.02 Form.</u>

<u>004.02A Pleading.</u> A petition shall be in the form of a pleading which shall contain:

004.02A1 A caption, which shall include:

<u>004.02A1a</u> The venue: BEFORE THE DEPARTMENT OF HEALTH, STATE OF NEBRASKA;

004.02A1b A heading specifying the subject matter of the petition; and

<u>004.02A1c</u> The name of the pleading, <u>e.g.</u>, PETITION FOR AMENDMENT OF RULES AND REGULATIONS.

004.02A2 The statements required in 004.03 below.

<u>004.02A3</u> The signature of the petitioner or, when represented by an attorney, the signature of the attorney.

<u>004.02A4</u> The name and address of the petitioner, and when represented by an attorney, the name, address, telephone number, and bar number of the attorney.

<u>004.02B Size and Paper</u>. Petitions shall be made on white, letter sized (8 1/2" x 11") paper of standard weight.

<u>004.02C Print</u>. Petitions shall be legibly typewritten, photostatically reproduced, printed, or handwritten. If handwritten, they must be written in ink. Only one side of a page shall contain any writing.

<u>004.02D Attachments</u>. Any documents attached to a petition shall be securely fastened to the pleading and shall meet the requirements of 004.02B and 004.02C for paper and print. When possible, attachments shall be on 8 $1/2" \times 11"$ paper or placed in an 8 $1/2" \times 11"$ envelope and clearly marked as an attachment to the petition.

<u>004.03 Content</u>. To be considered, a petition must meet the following requirements for content and substance.

004.03A Statement of Claim. The petition must:

<u>004.03B1</u> Identify the statutes providing a basis for the proposed action and identify the existing regulation if amendment or repeal of a regulation is proposed;

<u>004.03B2</u> State the substance of or proposed wording for any amendment or new regulation;

<u>004.03B3</u> State the reason(s) why the regulation should be promulgated, amended, or repealed, including, but not limited to, the facts surrounding the need for the proposed action and how the proposed action will address or resolve the situation presented.

<u>004.03C Argument</u>. The petition shall state whether petitioner requests opportunity for oral or written argument on the petition.

<u>004.03D Exhibits</u>. Any documents pertinent to the petition that the petitioner wishes to be considered in making a ruling must be attached to the petition.

<u>004.04</u> Sample Petition. A petitioner may use sample forms of petition approved by the Department, copies of which are attached as Attachments A, B and C to these regulations and made a part of these regulations by reference. A petitioner may also prepare his or her own petition, so long as it is a reasonable facsimile in form and meets the requirements of subsections 004.02 and 004.03.

<u>004.05 Filing</u>. A petition shall be filed in the office of the Director. Filing may be accomplished by personal delivery or by mail. Filings will be received during regular office hours of the Department. Office hours are from 8:00 a.m. to 5:00 p.m., Monday through Friday, excluding state holidays. The mailing address for the Department is Department of Health, Third Floor, 301 Centennial Mall South, Lincoln, Nebraska 68509.

<u>004.06 Number of Copies</u>. In addition to the original petition, two (2) copies shall be delivered to the Department for Department use.

<u>004.07 Reception of Petition</u>. The Department shall stamp all petitions and other filings relating to the petition as "RECEIVED" and with the date of filing. Filings received after regular office hours shall be stamped as received the following work day.

<u>004.08 Request for Receipt</u>. Request may be made for a receipt for any filing made. Request may be made by letter or verbally. The request must be accompanied by an extra copy of the document for stamping and return, and if return is to be by mail, a stamped, self-addressed envelope.

<u>004.09 Brief</u>. A petitioner may submit a written argument, or brief, in support of the petition at time of filing without leave of the Department. The Department may grant opportunity to submit a brief after filing upon application of the petitioner. If granted, the petitioner shall submit the brief according to the date set by the Department. A brief must meet the requirements of 004.02 in form.

005 CONSIDERATION AND DISPOSITION OF PETITIONS

005.01 Process Generally. Upon the filing of the petition the Director will designate him/herself or a Department representative to make the final decision on the petition. The Director may also assign an employee or hearing officer to consider the petition and recommend a decision to the Director.

<u>005.01A</u> Upon the filing of a petition, the Department may, in its discretion do one or more of the following:

<u>005.01A1</u> Require that additional information be submitted before the petition will be considered.

<u>005.01A2</u> Schedule a date, time and location at which the petitioner may make an oral presentation on the petition before a ruling is made.

<u>005.01A3</u> Consider the petition and other materials submitted without oral presentation.

<u>005.01B</u> In disposing of a petition, the Department may:

005.01B1 Deny the petition;

005.01B2 Initiate rulemaking proceedings; or

005.01B3 If otherwise lawful, adopt a rule or regulation.

<u>005.03</u><u>Additional Information</u>. If, upon review of the petition, additional information is determined by the Department to be needed to consider the petition, the Department shall notify the petitioner of the nature of the information to be submitted. The request may be made in writing or verbally, but if made verbally, must be reduced to writing and signed by the person making the request. The request shall be made within ten (10) days of the date of filing of the petition. The petitioner shall have five (5) days from the verbal request or date of mailing of the request, whichever applies, in which to submit the requested information. The information must be given in writing and be signed by the petitioner. The request and response will be made part of the official record of the proceeding.

<u>005.04</u> Oral Presentation (Argument), When. Oral argument shall be had only on specific order of the Department. Request may be made in the petition. The Department may grant oral argument if it determines argument would be helpful to its consideration of the petition. If opportunity for oral argument is granted, argument shall be scheduled to be held not more than thirty (30) days after filing of the petition. Petitioner, or, when represented, petitioner's attorney, shall be served with a notice of the date, time and place for oral argument not less than five (5) days in advance of the scheduled date. Service shall be made by certified mail, return receipt requested.

<u>005.05 Oral Presentation, Procedure</u>. Oral presentation will be made before the representative of the Department authorized to render a decision or before a hearing officer designated by the Director.

005.05A The Department representative or hearing officer shall:

005.05A1 Identify the proceeding and introduce himself or herself;

<u>005.05A2</u> Ask the petitioner or petitioner's representative to identify himself/herself for the record;

005.05A3 Hear the argument of the petitioner; and

005.05A4 Close the proceedings.

<u>005.05B</u> The Department representative or hearing officer conducting the proceeding may ask questions during or after petitioner's presentation.

<u>005.05C</u> Oral presentation shall not exceed forty-five (45) minutes in duration unless additional time is granted by the Department representative or hearing officer.

<u>005.05D</u> The petitioner may make oral presentation on his or her own behalf or be represented by an attorney.

<u>005.05E</u> A court reporter may be present to record the presentation.


005.06 Decision, When. The Department shall act on a petition within sixty (60) days.

<u>005.07 Decision, Form</u>. The decision will be made in the form of a pleading as set forth in 004.02.

<u>005.08 Decision, Content</u>. The decision may consist of a direction to initiate rulemaking proceedings or a total or partial denial. The decision shall contain the reasons for the ruling.



CHAPTER 4 - RULES OF PRACTICE AND PROCEDURES FOR PETITIONS FOR NEGOTIATED RULEMAKING

001 DEFINITIONS

001.01 APA shall mean the Administrative Procedure Act, Neb. Rev. Stat. §84-901 et seq.

001.02 Department shall mean the Department of Health of the State of Nebraska.

<u>001.03 Consensus</u> shall mean unanimous concurrence among the interests represented on a negotiated rulemaking committee unless the committee agrees upon another specified definition.

<u>001.04 Convenor</u> shall mean a person who impartially assists an agency in determining whether establishment of a negotiated rulemaking committee is feasible and appropriate for a particular rulemaking procedure.

<u>001.05 Interest</u> shall mean, with respect to an issue or matter, multiple parties that have a similar point of view or that are likely to be affected in a similar manner.

<u>001.06 Negotiated rulemaking</u> shall mean rulemaking through the use of a negotiated rulemaking committee.

<u>001.07 Negotiated rulemaking committee or committee</u> shall mean an advisory committee established to consider and discuss issues for the purpose of reaching a consensus in the development of a proposed rule.

<u>001.08 Person</u> shall mean an individual, partnership, limited liability company, corporation, association, governmental subdivision, agency or public or private organization of any character.

<u>001.09 Rule or regulation</u> shall mean any rule, regulation, or standard issued by an agency, including the amendment or repeal thereof whether with or without prior hearing and designed to implement, interpret, or make specific the law enforced or administered by it or governing its organization or procedure, but not including rules and regulations concerning the internal management of the agency not affecting private rights, private interests, or procedures available to the public and not including permits, certificate of public convenience and necessity, franchises, rate orders, and rate tariffs, and any rules of interpretation thereof. For purposes of these regulations, every rule and regulation which shall prescribe a penalty shall be presumed to have general applicability or to affect private rights and interests.

002 PETITIONS GENERALLY

<u>002.01 Purpose.</u> The negotiated rulemaking process provides a mechanism by which any person may petition the Department for use of a committee to attempt to reach a consensus about controversial issues before a formal rulemaking proceeding is begun. This process is not a substitute for the proceedings of the APA, but is supplemental to that process. Nor is this process meant to preclude other Department efforts or processes to reach consensus with affected persons about the content of rules or regulations.

<u>002.02 Subjects for Petition.</u> A negotiated rulemaking process may be requested on any topic appropriate for a rule or regulation.

<u>002.02A</u> A process may be requested only to develop rules to carry out statutes that are within the authority of the Department to implement.

<u>002.02B</u> A process may not be requested to develop a rule or regulation to vary the specific terms of a statute, that is, on subjects about which the Department has no discretion or policymaking authority.

<u>002.02C</u> A process may not be requested to negotiate a rule on a matter which is not within the definition of a rule or regulation as set forth in 001.09.

<u>002.02D</u> A process may be requested when the use of a negotiated rulemaking procedure is in the public interest as determined by the Director under the provisions of section 004.

<u>002.03 Who May Petition.</u> Any person may petition the Department to request the use of a negotiated rulemaking committee in the development or revision of a rule.

<u>002.04 When a Negotiated Rulemaking Committee May be Requested.</u> A petition for use of negotiated rulemaking may be filed at any time, except that if formal rulemaking proceedings under the APA have been initiated by publication of a notice of public hearing in a newspaper having general circulation in the state, the Department may decline to consider the petition or may consider the timing of the filing as a factor in determining whether to grant or deny a petition.

<u>002.05 Effect of a Committee Decision.</u> Agreements reached under any negotiated rulemaking process are not binding and can be modified during formal rulemaking under the APA as with any other rule or regulation.

003 PETITIONS - FORM AND CONTENT

<u>003.01 Request.</u> A request for use of a negotiated rulemaking procedure shall be made by petition that meets the requirements of this section.

003.02 Form.

<u>003.02A</u> A petition may be in the form of a pleading that contains a caption, heading, and name as set forth on Attachment 1, which is attached and made part of these regulations by this reference.

<u>003.02B</u> A petition may be made in the form of a letter so long as it contains all of the information required by these regulations and is clearly delineated as a petition for negotiated rulemaking.

003.03 Size and Paper. All petitions shall be on white, letter- sized paper (8 1/2 x 11) of standard weight.

<u>003.04 Print.</u> Petitions shall be legibly typewritten, photo- statically reproduced, printed, or handwritten. If handwritten, they must be in ink. Only one side of a page shall contain any writing.

<u>003.05</u> <u>Attachments.</u> Any documents that are intended to accompany the petition shall be securely fastened, clearly marked as attachments to the petition, and meet the requirements of this section for size and print.

<u>003.06 Content.</u> A petition shall meet the following requirements for content and substance. It shall:

<u>003.06A</u> identify the general subject matter about which a negotiated rulemaking process is sought, including the statutes providing authority for the desired regulation and, if amendments to existing regulations are sought, identification of the regulations by title, chapter and name.

<u>003.06B</u> identify the specific issue(s) proposed to be included in a negotiated rulemaking process.

<u>003.06C</u> discuss the facts surrounding each problem or issue.

<u>003.06D</u> discuss why a negotiated rulemaking process is in the public interest, including information on each criterion set forth in 004.02A to 004.02E for Director consideration. The petitioner may submit information concerning criteria set forth in 004.02F and 004.02G and such other information as may assist the Director in making a decision.

<u>003.07 Filing.</u> The petition shall be filed in the office of the Director of Health. Filing may be made by personal delivery or by mail during regular office hours of the Department. Office hours are from 8:00 a.m. to 5:00 p.m., Monday through Friday, excluding state holidays. The mailing address for the Department is Department of Health, Third Floor, Nebraska State Office Building, Third Floor, 301 Centennial Mall South, Lincoln, NE 68509.

<u>003.08 Reception of Petitions.</u> The Department shall stamp petitions and other filings related to a petition as "RECEIVED" and with the date of filing. Materials received after regular office hours shall be stamped as received the following day.

004 PETITIONS - CONSIDERATION AND DISPOSITION

004.01 Process Generally. Upon the filing of a petition, the Director may designate a Department employee or board or use the services of a convenor of the Department to recommend to the Director whether a negotiated rulemaking process should be initiated.

<u>004.02</u> <u>Criteria for Decision.</u> The Department will establish a negotiated rulemaking committee to negotiate and develop a proposed rule if the Director determines that the use of such a procedure is in the public interest. In making that determination, the Director shall consider the factors set forth in section 002.02 and whether:

<u>004.02A</u> There is need for a rule;

<u>004.02B</u> There are a limited number of identifiable interests that will be significantly affected by the rule;

<u>004.02C</u> There is a reasonable likelihood that a committee can be convened with a balanced representation of persons who:

004.02C1 can adequately represent the interests identified; and

<u>004.02C2</u> are willing to negotiate in good faith to reach a consensus on the proposed rule;

<u>004.02D</u> There is a reasonable likelihood that a committee will reach a consensus on the proposed rule;

<u>004.02E</u> The negotiated rulemaking procedure will not unreasonably delay the notice of proposed formal rulemaking and the issuance of the final rule pursuant to the APA;

<u>004.02F</u> The agency has adequate resources and is willing to commit those resources, including technical assistance, to the committee; and

<u>004.02G</u> The Department, to the maximum extent possible consistent with the legal obligations of the agency, will use the consensus of the committee as the basis for the rule proposed by the Department in the formal rulemaking process of the APA.

<u>004.03</u> <u>Consideration</u>. Within sixty (60) days after submission of a petition, the Department shall:

004.03A Deny the petition in writing, stating its reasons for denial; or

<u>004.03B</u> Initiate the negotiated rulemaking procedure as set forth in the Department Rules and Regulations Governing Negotiated Rulemaking Committees, 184 NAC 5.

<u>004.04</u> <u>Decision</u>. The decision of the Department may be made in the form of a pleading or a letter clearly designated as the decision on the petition. The petitioner shall be served with a copy of the decision by certified mail, return receipt requested.

005 REVIEW OF DECISION

<u>005.01</u> A Department action relating to establishing, assisting or terminating a negotiated rulemaking committee is not subject to judicial review, though nothing herein bars judicial review if such is otherwise provided by law.



<u>001.09 Person</u> shall mean an individual, partnership, limited liability company, corporation, association, governmental subdivision, agency or public or private organization of any character.

<u>001.10</u> Rule or regulation shall mean any rule, regulation, or standard issued by an agency, including the amendment or repeal thereof whether with or without prior hearing and designed to implement, interpret, or make specific the law enforced or administered by it or governing its organization or procedure, but not including rules and regulations concerning the internal management of the agency not affecting private rights, private interests, or procedures available to the public and not including permits, certificate of public convenience and necessity, franchises, rate orders, and rate tariffs, and any rules of interpretation thereof. For purposes of these regulations, every rule and regulation which shall prescribe a penalty shall be presumed to have general applicability or to affect private rights and interests.

002 NEGOTIATED RULEMAKING GENERALLY

<u>002.01</u> Scope of Regulations. These regulations govern the method for negotiated rulemaking once the Department determines that this kind of process may be in the public interest. The procedure for any person to petition to use negotiated rulemaking and for Department consideration and disposition of a petition is covered in the Department Rules of Practice and Procedure for Petitions for Negotiated Rulemaking, 184 NAC 4.

002.02 Process Generally.

<u>002.02A</u> Notice. If the Department decides to establish a negotiated rulemaking committee, the Department shall give notice to the Secretary of State and publish the notice in a newspaper having general circulation in the state and, as appropriate, in other newspapers and publications. The notice shall include:

<u>002.02A1</u> An announcement that the agency intends to establish a negotiated rulemaking committee to negotiate and develop a proposed rule;

<u>002.02A2</u> A description of the subject and scope of the rule to be developed and the issues to be considered;

002.02A3 A list of interests likely to be significantly affected by the proposed rule;

<u>002.02A4</u> A list of the persons proposed to represent the affected interests and the agency;

002.02A5 A proposed schedule for completing the work of the committee; and

<u>002.02A6</u> An explanation of how a persons may apply for or nominate another person for membership on the committee.

<u>002.02B</u> Comment and Application Period. Persons interested in either making comments about the process or in applying or nominating others to serve on the committee shall have a period of thirty (30) days from the date of publication of the notice in which to do so. Persons making application shall do so on forms provided by the Department, attached as Attachment 1 to these regulations, or using a reasonable facsimile of Attachment 1 that they prepare.

<u>002.02C</u> Feasibility Determination. The Department considers the comments and applications filed for membership on the committee and determines whether a committee can adequately represent the persons who will be significantly affected by a proposed rule and that it is feasible and appropriate for the particular rulemaking. The Department may use the services of a convenor to assist in making a determination of need, to identify persons who will be significantly affected by a proposed rule, and to conduct discussions with affected persons to determine whether a committee is feasible and appropriate for the particular rulemaking. The convenor may be a state employee or retained by contract, as the Department determines.

<u>002.02C1 Feasible.</u> If the Department decides that negotiated rulemaking is feasible it may establish a committee as set forth in these regulations.

<u>002.02C2 Not Feasible.</u> If the Department decides not to establish a committee, the Department shall:

<u>002.02C2a</u> Notify the persons who commented on or applied for membership on the committee of the reasons for the decision; and

<u>002.02C2b</u> Publish notice of the decision not to establish a committee in a newspaper of general circulation in the state and, as appropriate, in other newspapers and publications.

<u>002.02D</u> Committee. When so determined by the Department, a committee is formed to negotiate issues and develop proposed rules and regulations for use by the Department in formal rulemaking.

003 FORMATION OF COMMITTEE

<u>003.01 Membership.</u> Members of a committee to undertake negotiated rulemaking may include:

<u>003.01A</u> A person designated by the Department to represent the Department on substantive issues.

<u>003.01B</u> Persons selected by the Department or a convenor appointed by the Department, or both, as willing and qualified to represent the interests that will be significantly affected by any proposed rule.

<u>003.01C</u> Persons recruited by the committee itself by consensus as being essential to the success of the process.

<u>003.01D</u> Persons selected by the committee upon committee review of a petition or nomination as set forth in section 003.02 of these regulations.

All members shall participate in the deliberations with the same rights and responsibilities of other members.

<u>003.02</u> Petition or Nomination for Membership. Persons who will be significantly affected by a proposed rule and who believe that their interests will not be adequately represented by any person on a negotiated rulemaking committee may petition for or nominate another person for membership.

<u>003.02A Content.</u> Each petition or nomination shall be submitted to the committee by delivering or mailing the same to the Director of Health. All petitions shall include:

003.02A1 Identification of the applicable negotiated rulemaking proceeding;

<u>003.02A2</u> The name of the petitioner or nominee and a description of the interest or interests the person represents;

<u>003.02A3</u> Evidence that the petitioner or nominee is authorized to represent parties related to the interests the person proposes to represent;

<u>003.02A4</u> A written commitment that the petitioner or nominee will actively participate in good faith in the development of the rule under consideration; and

<u>003.02A5</u> An explanation of the reasons that those already on the committee do not adequately represent the interests the petitioner.

Persons wishing to file a petition may use the form attached as Attachment 2 to these regulations or a reasonable facsimile they have prepared.

<u>003.02B</u> <u>Disposition by Committee.</u> Upon receiving a petition or nomination, the committee shall decide by consensus at its next meeting whether or not to expand its membership.

003.03 OPERATION OF COMMITTEE GENERALLY.

<u>003.03A Procedures.</u> Each committee formed under the Negotiated Rulemaking Act and these regulations may adopt its own ground rules and procedures for its operation.

003.03B Selection of Facilitator.

<u>003.03B1</u> Nomination. The Department may nominate a person to serve as facilitator, subject to approval of the committee by consensus.

<u>003.03B2</u> Substitute. If the committee does not approve the Department nomination, the Department shall submit a substitute nomination.

<u>003.03B3</u> <u>Committee Selection.</u> If the committee does not approve a substitute nominee by the Department, the committee shall select by consensus a person to serve as facilitator.

<u>003.03B4</u> Qualified Facilitator. A person designated by the Department to represent it on substantive issues may not serve. The Department may employ or contract for an organization or individual to serve as a facilitator for a committee or use the services of a state employee to act as facilitator. A facilitator shall not have a financial or other interest that would preclude him or her from serving in an impartial and independent manner. The Department shall determine whether a person under consideration for facilitator has such an interest. A person disqualified under this criterion shall be dropped from further consideration.

<u>003.03B5 Lack of Consensus.</u> If the committee neither approves a Department nominee nor reaches consensus on a qualified facilitator, then the committee shall undertake negotiations without a facilitator. A person designated by the Department to represent it on substantive issues may not serve as presiding officer.

003.03C Facilitator Duties. A facilitator approved or selected by a committee shall:

003.03C1 Preside at the meetings of the committee in an impartial manner.

<u>003.03C2</u> Impartially assist members in conducting discussions and negotiations and achieving consensus;

<u>003.03C3</u> Manage the keeping of minutes and records.

003.04 Expenses of Committee.

<u>003.04A</u> Reimbursement. Members of a negotiated rulemaking committee are responsible for their own expenses of participation. The Department may, however, pay for a member's actual and necessary expenses incurred as provided in <u>Neb</u>. <u>Rev</u>. <u>Stat</u>. <u>§§81-1174 to 81-1177 and a reasonable per diem rate of compensation if:</u>

<u>003.04A1</u> The committee member certifies a lack of adequate financial resources to participate in a committee using the form attached as Attachment 3; and

<u>003.04A2</u> The Department determines that the committee member's participation is necessary to assure an adequate representation of the interests of the members.

<u>003.04B Grants or Gifts.</u> The Department may accept grants or gifts from any source to fund a negotiated rulemaking process if:

<u>003.04B1</u> Information on the name of the person giving the grant or gift and the amount of the grant or gift is available to the public;

<u>003.04B2</u> The grant or gift is given to and accepted by the Department without placing any condition on the membership of a committee or the outcome of a negotiated rulemaking process; and

<u>003.04B3</u> There is a consensus among members of the committee that the acceptance of the grant or gift will not diminish the integrity of the process.

<u>003.04C Technical Assistance.</u> The Department shall provide appropriate administrative support to committees established under these regulations, including technical assistance and support.

004 COMMITTEE ACTION

<u>004.01 Negotiations.</u> A committee shall consider the matter proposed by the Department for consideration and shall attempt to reach consensus concerning a proposed rule and any other matter the committee determines is relevant to the proposed rule.

004.02 Report. The committee shall transmit to the Department.

<u>004.02A</u> A report containing the proposed rule, if consensus is achieved at the conclusion of negotiations; or

<u>004.02B</u> A report specifying the areas in which the committee reached consensus and the issues that remain unresolved, if consensus is not reached. The committee may include any other information, recommendations, or materials that the committee considers appropriate. Any member of the committee may include as an addendum to the report additional information, recommendations, or materials.

005 COMMITTEE TERMINATION

<u>005.01</u> A committee terminates upon the adoption of the final rule by the Department under the APA unless the Department, after consulting the committee, or the committee, specifies an earlier termination date.

TITLE 184 GENERAL ADMINISTRATION

CHAPTER 6 REMOVAL OF APPOINTED BOARD MEMBERS BY THE STATE OF HEALTH

001. SCOPE AND AUTHORITY OF REGULATIONS. This chapter implements the Uniform Credentialing Act, Nebraska Revised Statutes (Neb. Rev. Stat.) §§ 38-101 to 38-1,146 and the practice acts cited in Neb. Rev. Stat. § 38-101. The chapter applies to the removal of a any member of an appointed board by the Board of Health except when erroneous appointments are vacated to comply with statutory requirements. as provided by NEB. REV. STAT § 71-118, § 71-374(4), § 71-5505.01, § 71-3707, § 71-6115(1) and § 71-1, 132.07(4). These regulations shall not apply to erroneous appointments that are vacated to comply with statutory requirements.

002. DEFINITIONS. Definitions are set out in the Uniform Credentialing Act and this chapter.

002.01 Appointed Board means:

A)any designated examining board created by NEB. REV. STAT. § 71-112 including Examiners in Medicine and Surgery, Examiners in Athletic Training, Examiners in Respiratory Care Practice, Examiners in Chiropractic, Examiners in Dentistry, Examiners in Optometry, Examiners in Massage Therapy, Examiners in Physical Therapy, Examiners in Pharmacy, Examiners in Audiology and Speech-Language Pathology, Examiners in Medical Nutrition Therapy, Examiners in Funeral Directing and Embalming, Examiners in Podiatry, Examiners in Podiatry, Examiners of Psychologists, Examiners in Veterinary Medicine, and Examiners in Mental Health Practice;

B)the Board of Cosmetologists Examiners as created by NEB. REV. STAT. § 71-374(4);

C)the Board of Advanced Emergency Medical Care as created by NEB. REV. STAT. § 71-5505.01;

D)the Board of Registration for Environmental Health Specialists as created by NEB. REV. STAT. § 71-3707;

E)the Board of Examiners in Nursing Home Administration as created by NEB. REV. STAT. § 71-6065;

F) the Board of Occupational Therapy Practice as created by NEB. REV. STAT. § 71-6115(1):

G) the Board of Nursing as created by NEB. REV. STAT. § 71-1,132.07(4);

- H) the Board of Hearing Aid Instrument Dispensers and Fitters as created by NEB. REV. STAT. § 71-4715; and
- I) the Board of Advanced Registered Nurse Practitioners as created by NEB. REV. STAT. § 71-1718.01.

<u>002.012</u> <u>BOARD OF HEALTH.</u> <u>Board of Health</u> means: t<u>T</u>he Nebraska State Board of Health as created at NEB. REV. STAT. § 71-2601. For purposes of these regulations the Board shall be divided into a Review Panel and a Hearing Panel.

<u>002.023</u> <u>CHAIRPERSON OF THE HEARING PANEL</u>. <u>Chairperson of the Hearing Panel</u> means: a <u>A</u> member of the Board of Health designated by the chairperson of the Board of <u>Health</u> to serve as chairperson of the <u>Hh</u>earing <u>Pp</u>anel. This person may <u>include be</u> the <u>Cc</u>hairperson of the Board of Health.

<u>002.034</u> <u>COMPLAINT.</u> <u>Complaint</u> means a <u>A</u> negative report of any nature against a <u>Mm</u>ember as it relates to <u>the member's</u> that individual's status, ability, or capacity to serve as an <u>appointed</u> board member.

<u>002.045</u> <u>HEARING PANEL</u>. <u>Hearing Panel</u> means those <u>The</u> members of the Board of Health which who hears and makes a final decisions regarding <u>a Member's members</u>' removal. Members of the <u>Hh</u>earing <u>Pp</u>anel <u>shall may</u> not be on the <u>Rr</u>eview <u>Pp</u>anel.

002.06 Member means any Member of an appointed board.

<u>002.07 Prosecution</u> means the Review Panel's presentation of complaints and investigational findings made against a Member to the Hearing Panel for final determination.

<u>002.058</u> <u>REVIEW PANEL.</u> <u>Review Panel</u> means a <u>A</u> standing committee of the Board of Health, comprised of three members who are appointed by the <u>C</u>chairperson of the Board of <u>Health</u>.

<u>003.</u> <u>REMOVAL AUTHORITY.</u> <u>AUTHORITY OF BOARD.</u> The Board of Health has the authority to remove any Member of an Appointed Board. <u>Professional and lay members of appointed boards may be removed on the grounds set forth in Neb. Rev. Stat. § 38-160.</u>

<u>003.01 Actions committed in capacity of an Appointed Board Member.</u> Lay or professional Members may be removed for any of the following reasons:

003.01A physical or mental incapacity to carry out the duties of a board member.

003.01B continued neglect of duties.

<u>003.01C</u> incompetency in carrying out the duties of a board member.

003.01D acting beyond the individual board member's scope of authority.

003.01E malfeasance in office.

<u>003.02 Actions committed by Member as a health care professional.</u> In addition to the reasons set out in section 003.01 above, professional Members may be removed for any of the following reasons:

<u>003.02A</u> any cause which a professional license, certificate, or registration in the profession involved may be suspended or revoked under NEB. REV. STAT. § 71-147 or § 71-148.

003.02B a lack of licensure, certification, or registration in the profession involved.

004 CONFIDENTIALITY

<u>004.01 Complaints, Investigational Files, and Reports.</u> Complaints, investigational records and reports are public records which may be withheld from disclosure to the public under NEB. REV. STAT. § 84-712.05 (5), and all such complaints, records and reports shall be withheld except in the following instances:

<u>004.01A</u> Prior to the filing of a Petition under section 005.05A, the complaint, and all investigational records and reports may only be disclosed to the extent necessary to complete any investigation;

<u>004.01B</u> After the filing of a Petition under section 005.05A, the complaint, investigational records, and reports may be disclosed to the extent they are made part of the record of a contested case;

<u>004.01C</u> Notwithstanding the provision of section 004.01A, any information forwarded to the Hearing Panel pursuant to section 005.05B shall remain confidential and shall not be disclosed to the public.

<u>004.02 Complainant.</u> The identity of a person making a complaint will not be disclosed without his or her consent.

<u>004.03 Review Panel Consideration.</u> In order to prevent needless injury to the reputation of a Member, the actions of the Review Panel in the review and consideration of complaints, investigations, and determination of reasonable cause, may be confidential.

0045. SCREENING OF COMPLAINTS AGAINST MEMBERS.

<u>0045.01</u> <u>RECEIPT OF COMPLAINTS.</u> <u>Receipt of Complaints.</u> No particular form for the complaint is required. Complaints may be reported to any member of the Board of Health or to the Department of Health <u>and Human Services</u>.

<u>0045.01(A)</u>- <u>PETITIONS FOR DISCIPLINE</u>. Any filing of any petition for disciplinary action under NEB. REV. STAT. § 71-147 or § 71-148, based on Neb. Rev. Stat. §§ 38-<u>178 or 38-179</u> or any certification by an appointed board that a member is not qualified to practice a profession because of any of the for reasons set out in <u>Neb. Rev. Stat. § 38-</u>

<u>1,110</u> NEB. REV. STAT. § 71-161.13, shall constitutes the filing of a complaint under these regulations.

<u>0045.01(B)</u>. <u>INITIATION BY REVIEW PANEL</u>. The <u>R</u>review <u>Pp</u>anel may, on its own, initiate a complaint based upon any public information.

<u>0045.01(C)</u>- <u>REQUESTS FOR REMOVAL AND QUESTIONS ABOUT FITNESS.</u> The receipt of a r<u>R</u>equests that a board members be removed or information questioning a <u>Member's members'</u> fitness to <u>serve</u> continue serving, shall constitute the filing of a complaint under these regulations.

<u>0045.02</u> EXAMINATION OF COMPLAINTS. Examination of Complaints. The review Ppanel shall will review and examine all complaints at the earliest date possible provided that such review take place no later than the next regular no later than the next regular scheduled Board of Health meeting.

<u>0045.03</u> <u>REFERRAL OF COMPLAINTS.</u> <u>Referral of Complaints.</u> In addition to the Review Panel examining the complaints received under the provisions of these regulations, all complaints received under these regulations shall be referred as follows:

<u>0045.03(A)</u> <u>COMPLAINTS ABOUT ACTIONS AS HEALTH CARE PROFESSIONALS.</u> <u>Complaints Pertaining to a Member's actions as a Health Professional.</u> Complaints made under the provision of these regulations, which consist of involving allegations for which a professional license, certificate, or registration credentials may be disciplined suspended or revoked shall will be referred for investigation as provided by statute for in NEB. REV. STAT § 71-168. Complaints which consist of allegations of physical or mental incapacity of a licensed, certified or registered member shall be referred for investigation as provided in NEB. REV. STAT. § 71-161.13 et seq. The Rreview Ppanel shall will suspend action on these referrals pending the receipt of notice, which is provided to complainants, from either the Department Director of the Division of Public Health, the Board of Examiners, or the Attorney General, of that person's their determination of a course of action concerning the complaint. Such notice will be provided to complainants.

<u>O045.03(B)</u> <u>COMPLAINTS PERTAINING TO CAPACITY TO SERVE.</u> <u>Complaints</u> <u>Pertaining to the Capacity of a Member to Serve on an Appointed Board.</u> Complaints made under the provisions of these regulations which consist of reasons specified in section 003.02 of these regulations pertaining to capacity to serve on an appointed board shall will be referred to the Bureau of Examining Boards for investigation.

<u>0045.04</u> EVALUATION OF INVESTIGATIONS. <u>Evaluation of Investigations.</u> The <u>Rr</u>eview <u>Pp</u>anel may determine if investigation is required beyond that <u>which is</u> provided for in section <u>004.03</u> 005.03; and <u>shall will</u> provide for such investigation. In determining whether to conduct such an investigation the <u>Rr</u>eview <u>Pp</u>anel may consider factors such as:

- (A) Whether the circumstances indicate that a complaint is made in good faith and is not malicious, frivolous, or vexatious;
- (B) Whether the complaint is timely or has been delayed too long to justify present evaluation of its merit; and

(C) Whether the complainants may be a necessary witnesses if action is taken and is are unwilling to identify himself or herself themselves and come forward to testify.

0045.05 <u>REVIEW PANEL DETERMINATION.</u> <u>Review Panel Determination.</u> After the review and investigation of all complaints, the Review Panel shall take the following actions:

<u>0045.05(A)</u> FINDING BASIS FOR REMOVAL. If a majority of the Rreview Ppanel determines, after review and investigation of all complaints, that there is reasonable cause to believe that a Member or his or her members or their actions are encompassed within fall under a category listed in section 003 of these regulations, the Rreview Ppanel shall will prepare a Ppetition for Rremoval and forward it the same to the Hhearing Ppanel in accordance with section 005 006. The Ppetition for Removal shall will set out in detail the factual basis for the allegations, and shall further allege the basis for removal as set out in under section 003 above.

<u>0045.05(B)</u> FINDING NO BASIS FOR REMOVAL. If, after review and investigation of all complaints, a majority of the Rreview Ppanel determines that members or their actions are not encompassed within section 003, or are a Member or his or her actions do not fall under any category listed in section 003, or is not substantiated, any and all the complaints against the Mmember shall will be dismissed for purposes of removal from his or her position on an appointed board, and the Rreview Ppanel shall will so notify the member and the any complainant, if applicable. The dDismissed complaint(s) and all related investigation material shall will be forwarded to the Hhearing Ppanel at the next scheduled meeting for informational purposes only. These materials shall be subject to the confidentiality requirements as provided for in section 004.

Those members of the Board of Health that make up the Review Panel The members of the review panel shall will serve as the prosecution and shall be are responsible for presenting all the investigative findings regarding complaints against members a complaint against a Member. These findings shall be presented to those members of the Board of Health that make up the Hearing Panel. The Hhearing Ppanel shall ultimately will determine if the investigative findings establish that the member or the Mmember's actions fall under the criteria put forth in section

003. If such the member or member's actions are found to fall under section 003, the Hhearing Ppanel may remove the Mmember.

<u>0056.03</u> <u>LEGAL REPRESENTATION.</u> <u>Legal Representation.</u> The Review Panel and the Hearing Panel <u>Review and hearing panels</u> may request legal representation at any time.

The Chairperson of the Hearing Panel hearing panel chairperson shall will prepare an official notice setting forth the time and place of the formal hearing and a general description of the hearing's purpose. This The notice and a copy of the petition shall will be served on the Mmember by any means permitted by law at least 30 days before the hearing. either personally or by any method specified in NEB. REV. STAT. § 25-505.01, or the Chairperson of the Board of Health may permit substitute or constructive service as provided in NEB. REV. STAT. § 25-517.02 when service cannot be made with reasonable diligence by any of the methods specified in NEB. REV. STAT. § 25-505.01.

<u>0056.05</u> <u>HEARING PROCEDURES.</u> <u>Hearing Procedures.</u> The hearing before the Hearing Panel shall will be conducted in accordance with the Model Rules of Practice and Procedure as put forth at 53 Nebraska Administrative Code Chapter 4. The hearing may be conducted by the <u>Hh</u>earing <u>Pp</u>anel, or by a designated hearing officer, but in no case shall will a final decision be rendered by fewer than a majority of the <u>hearing panel</u> Board of Health.

<u>0056.06</u> <u>BURDEN AND STANDARD OF PROOF.</u> <u>Burden of Proof.</u> The <u>Rr</u>eview <u>Pp</u>anel shall will bear the burden of proof <u>by a preponderance of the evidence</u> for all hearings before the <u>Board of Health</u>.

<u>006.07 Standard of Proof.</u> The standard of proof for all hearings before the Board of Health shall be by a preponderance of the evidence.

0067. FINAL DECISION.

<u>0067.01</u> <u>TIMING OF DETERMINATION.</u> <u>Determination by Hearing Panel.</u> The <u>Hh</u>earing <u>Pp</u>anel <u>shall will</u> make a determination on the petition no later than the next regular meeting of the Board of Health following completion of the hearing. This decision <u>shall will</u> constitute the final decision of the Board of Health for purposes of section 007.02.

<u>0067.02</u> <u>REMOVAL.</u> <u>Decision.</u> Upon completion of the hearing a <u>M</u>embers may be removed only by a positive vote of a majority of the total <u>hearing panel</u> Board of Health.

<u>0067.03</u> FORM OF DECISION. Form of the Decision. The decision of the Board of Health shall will be in writing or stated in the record and shall be accompanied by findings of fact and conclusions of law. The findings of fact shall will consist of a concise statement of the conclusions upon each contested issue of fact.

<u>0067.04</u> <u>SERVICE.</u> <u>Transmission of the Decision.</u> The final decision, including the findings and conclusions, shall will be served on the <u>Mmember by any means permitted by law either</u> in person or by certified mail, return receipt requested. Service on the <u>member's</u> attorney for

the Member shall <u>will</u> be deemed service on the <u>Mm</u>ember. A copy of the final decision shall <u>will</u> be transmitted to all other interested parties either in person or by regular mail.

<u>0078.</u> <u>APPEALS. OF BOARD DECISION</u> Members aggrieved by a final decision of the Board of Health are entitled to judicial review under the Administrative Procedure Act.</u>

<u>008.01 Appeal of Board Decision.</u> Any decision of the Board may be appealed to the District Court in accordance with the Administrative Procedures Act as set forth at NEB. REV. STAT. § 84-901 et seq.
