In accordance with Neb. Rev. Stat. 84-907, public hearings conducted by the Nebraska Game and Parks Commission, will be held on October 21, 2022 at the Broken Bow Public Library Meeting Room 626 South D St. Broken Bow, NE prior to consideration and/or enactment of the following:

Pursuant to Neb. Rev. Stat. Sections §§ 37-1201, 37-1202, 37-1246, 37-1247, 37-1265, 37-1266, 37-1268; a public hearing will be held at 8:30 AM to consider amendments to Title 163, Nebraska Administrative Code Chapter 3, entitled Boating Regulations, Section 003 – Equipment Standards to update current regulations to conform with federal law regarding changing language from life preservers to personal flotation devices approved by the US Coast Guard, changing language from boat to vessel and clarifying language on what constitutes overloading of a vessel.

Pursuant to Neb. Rev. Stat. Sections §§37-336, 37-338, 37-1266, a public hearing will be held at 8:45 AM to consider amendments to Title 163, Nebraska Administrative Code Chapter 3, entitled Boating Regulations, Section 012 Waters with Special Restrictions by adding a 5 mph/no wake regulation from sundown to sunrise on Lake 15 (Victory Lake) and Lake 10 at Fremont Lakes. Add language limiting the number towable devices for water sports pulled by a motorboat or personal watercraft to one at Fremont Lakes SRA on Lake 15 (Victory Lake) and Lake 10. Add Lake at Bridgeport SRA to Sub-section 012.08. Add language clarifying that non-powered vessels and those powered by outboard electric motors are not allowed to operate at Fremont Lakes SRA on Lake 15 (Victory Lake) and Lake 10. Add an exemption for NGPC and other governmental agencies working in their official capacity.

Sections §§37-1201, 37-1202, 37-1246, 37-1247, 37-1265, 37-1266, 37-1268, a public hearing will be held at 9:00 AM to consider amendments to Title 163, Nebraska Administrative Code Chapter 3, entitled Boating Regulations, Section 015, Special Rules and Regulations for Non-Public Lake Associations, deleting redundant language and correcting errors, removing 015.02R through subpart 015.02R5 in regard to Villa Springs per their HOA request. Add language for the Sanitary and Improvement District No. 177 (Riverside Lakes, East Lake) Douglas County to this section from Section 12

Pursuant to Neb. Rev. Stat. Sections §§37-301, 37-304, 37-314, 37-424, a public hearing will be held at 9:15 AM to consider amendments to Title 163, Nebraska Administrative Code Chapter 2, entitled Fisheries Regulations, Section 010 Special Fishing Permits for Residents Who Are Severely Physically or Developmentally Disabled and Who Require Assistance in Angling, to simplify public access to forms for the permitting and renewal process by making them available online and at permitting offices.

Add the non-resident antelope archery permit to the list of antelope permits that are draw units, and allow non-resident archery antelope hunters to either apply for a preference point or the archery permit.

Stat. 37-301, 37-304, 37-305, 37-308, 37-314, 37-315, 37-344, 37-411, 37-426, 37-4,104, 37-4,107, 37-4,109, 37-4,111, 37-501 through 37-504, 37-508 and 37-543 through 37-545, a public hearing will be held at 10:00 AM., to consider amendments to Commission Order C06, Sport Fishing, regarding daily bag limits, possession limits, length limits, and open areas. Update the water bodies that have a minimum length limit of 21 inches on Black Bass. Redefine boundary designation between the Republican River and Harlan County Reservoir for size and/or bag limits for Channel Catfish and Walleye, Sauger and Saugeye. Add an additional lake to the no harvest of Northern Pike. Establish special size restriction for Bluegill, Redear and Crappie for Flanagan Lake. Update restriction for Lonergran Creek and Otter Creek at Lake

McConaughy.

### EXPLANATORY STATEMENT

Prepared by: Jeff Clauson, Boating Law Administrator

The Nebraska Game and Parks Commission is amending the above-referenced regulations as provided by law, and hereby submits this explanatory statement to accompany the regulation and describe their purposes and the changes made during the rulemaking process.

- I. Summary: Changes made to existing regulations.
- II. Overview of Purposes and Changes Made

**Section 012.** Last approved date changed. Duplicate statutory reference deleted.

012.01 eliminate verbiage for exemptions and add clarification to Sub-section regarding Nebraska Game and Parks authorized activities and other governmental agencies exemption as indicated in Sub-section 012.10. Add clarifying language for Victory Lake.

012.02 eliminate verbiage for exemptions and add clarification to Sub-section regarding Nebraska Game and Parks authorized activities and other governmental agencies exemption as indicated in Sub-section 012.10. Edit data into chart form. Add the following lakes to the list of lakes with a 5 mph/no wake rule: Peterson Lake WMA, Brown County; Archway Lakes, Buffalo County; Ballards Marsh WMA, Cherry County, CNPPID Supply Canal, Lincoln, Dawson, & Gosper County; Flanagan Lake, Douglas County; Big Indian 11a, Gage County; Conestoga SRA, Lancaster County; Duck Creek Recreation Area, Nemaha County; Portal Recreation Area, Sarpy County. Remove the following lakes from this list: Gavin's Point Dam Tailwaters, Cedar County; Midway Canyon Reservoir, Dawson County, Plum Creek Canyon Reservoir, Dawson County; Sanitary and Improvement District No. 177 (Riverside Lakes, East Lake), Douglas County. Rename the following lakes: Pigeon/Jones Creek to Kramper Lake-Danish Alps; West Papillion #5 to Prairie Queen. Add clarifying language for South Pine WMA. Add clarifying language to Shell Lake. Corrected Cottonmill to Cottontail Lake and Wagon Trail to Wagon Train Lake.

Eliminate verbiage for exemptions and add clarification to Sub-section regarding Nebraska Game and Parks authorized activities and other governmental agencies exemption as indicated in Sub-section 012.10. Add the following lakes to the list that allow only non-powered vessels or conventional outboard electric motors: Keller Park SRA, Brown County; Crystal Cove Lake, Dakota County, Cherry Creek Diversion Pond, Fort Robinson SP, Dawes County; Cherry Creek Pond, Fort Robinson SP, Dawes County; Grabel

Ponds, Fort Robinson SP, Dawes County; Ice House Ponds, Fort Robinson SP, Dawes County; Diamond Lake WMA, Gage County; Big Elk, Sarpy County. Rename Cottonwood Lake to Lake Yankton, Knox County. Move clarifying language for Bridgeport SRA from the county column to the body of water column.

012.04 edit data into chart form. Eliminate verbiage for exemptions and add clarification to Sub-section regarding Nebraska Game and Parks authorized activities and other governmental agencies exemption as indicated in Sub-section 012.10. Change motorboat to motorized vessel. Add the following lakes to the list where motorized vessels are not allowed to operate: Chester Island WMA, Lincoln, County; Midland Lake, Sarpy County; Shadow Lake, Sarpy County. Remove Archway Lakes, Buffalo County; Keller Park SRA, Brown County.

012.05 edit data into chart form. Eliminate verbiage for exemptions and add clarification to Sub-section regarding Nebraska Game and Parks authorized activities and other governmental agencies exemption as indicated in Sub-section 012.10. Remove the following lakes from the list: Smith Lake Crescent Lake FWS – NWR, Garden County; Chester Island WMA, Lincoln County; Midland Lake, Sarpy County; Shadow Lake, Sarpy County. Move clarifying language for Calamus Reservoir from the county column to the body of water column.

012.06 edit data into chart form. Eliminate verbiage for exemptions and add clarification to Sub-section regarding Nebraska Game and Parks authorized activities and other governmental agencies exemption as indicated in Sub-section 012.10. Add Fremont SRA Lakes, Victory Lake (Lake 15) and Lake 10, Dodge County

012.07 eliminate verbiage for exemptions and add clarification to Sub-section regarding Nebraska Game and Parks authorized activities and other governmental agencies exemption as indicated in Sub-section 012.10.

012.08 add language back to regulations that was left out after this Section was last updated regarding motorboats and jet skis being limited to towing one person skiing or wakeboarding or pulling more than one towable tube or similar device on Fremont SRA Lakes, Victory Lake (Lake 15) and Lake 10, Dodge County and Bridgeport Lake, Center Lake, Morrill County, for congestion and safety reasons.

012.09 add language back to regulations that was left out after this Section was last updated regarding the prohibition on the use of non-powered vessels and conventional outboard electric motors on Fremont SRA Lakes, Victory Lake (Lake 15) and Lake 10, Dodge County for congestion and safety reasons.


012.10 Add this as an exemption Sub-section for NGPC and other governmental agencies authorized activities.

The proposed regulations are consistent with the legislative intent established by Section 84-907.09. The proposed regulation is not the result of any state or federal mandate, rendering a state or federal funding mechanism not applicable. The Commission will solicit public comment prior to the date of the public hearing. The Commission did not use the Negotiated Rule-Making Act in developing the proposed regulation.



Chapter 3 – Boating Regulations

012 Waters with Special Restrictions

The following regulations are prescribed by the Game and Parks Commission, State of Nebraska in accordance with Neb. Rev. Stat. §§ 37-336, 37-338, 37-1266. ~~These regulations are effective following enactment by the Commission, approval by the Attorney General and Governor, and when five days have elapsed since filing with the Secretary of State.~~

For purposes of this section, the following terms are defined as:

Wildlife Management Areas (WMA) means those areas which are primarily for public hunting, fishing or other wildlife value.

State Recreation Areas (SRA) means areas with a primary value for day use, but with secondary overnight use facilities.
