The proposed changes update definitions; update fees; modify terminology; remove all duplicate statutory, unnecessary, and inconsistent language from the regulations; update section headings; correct typographical and punctuation errors; and update formatting.

Authority for these regulations is found in Neb. Rev. Stat. § 81-3117(7).

# Provide an Estimated Cost & Description of Impact:

State Agency: Decreasing inspection frequency and adding interim inspection checklists has greatly reduced the amount of time spent on inspections of facilities regulated. Adjusting fees to correspond with time spent will result in an estimated \$100,280.00 per year reduction in revenue to the State Agency.

Political Subdivision: No fiscal impact.

Regulated Public: Yearly fees to registrants are proposed to be reduced by the following:

Service Type Fees (Service Registrations)

Dental X-ray Machines

Cabinet X-ray Machines

Therapy Units

\$100.00/service type \$15.00/machine \$50.00/machine \$100.00/unit

This reduction results in fees that are more aligned with the surrounding states and better represent time spent inspecting which will reduce financial burden on registrants. Specific fiscal impact per licensee will be dependent on number of machines, units, and service types being registered.

TITLE 180 CONTROL OF RADIATION

CHAPTER 18 FEES FOR CERTIFICATES OF REGISTRATION, RADIOACTIVE

MATERIAL(S) LICENSES, ENVIRONMENTAL SURVEILLANCE, EMERGENCY RESPONSE AND OTHER REGULATORY SERVICES.

#### 18-001 SCOPE AND AUTHORITY:

48-001.04 SCOPE AND AUTHORITY. This chapter establishes the fees for licensing, registration, environmental surveillance and implementation, emergency planning, emergency response and implementation, and other regulatory services and provide for their payment. The regulations are authorized by and implement the Nebraska Radiation Control Act, Nebraska Revised Statute (Neb. Rev. Stat.) §§ 71-3501 to 71-3520.

18-001.01 Except as otherwise Unless specifically provided otherwise, the rules and requirements in this chapter apply to any person who is:

- **1.(A)** An applicant for, or holder of:
  - a.<u>(i)</u> A radioactive material license pursuant to 180 NAC 3, 5, 7, 12, 14 or 19 180 Nebraska Administrative Code (NAC);-or
  - b.(ii) A certificate of registration for radiation machines/, facilities, and/or services issued pursuant to 180 NAC 2 or 5.; or
  - c.(iii) A general license.
- 2.(B) The holder of a fixed nuclear facility construction permit or operating license issued by the U.S. Nuclear Regulatory Commission (NRC) pursuant to 10 CFR Part 50:-or
- 3.(C) The operator of any other fixed nuclear facility under a license issued by the U.S. Nuclear Regulatory Commission NRC Pursuant to 10 CFR Parts 30, 31, 32, 33, 34, 35, 36, 39, 40, and/or 70-;
- 4.(D) The operator of any other nuclear facility.; or
- 5.(E) The operator of any facility that during the course of operation results in the release of radioactive material to the environment.

18-002. DEFINITIONS.: For the purposes of As used in 180 NAC 18, the following definitions apply:

<u>002.01</u> <u>CARRIER.</u> means a <u>A</u> person who transports passengers or property in commerce by rail car, aircraft, motor vehicle or vessel.

<u>002.02</u> <u>EMERGENCY PLANNING, EMERGENCY RESPONSE AND IMPLEMENTATION.</u> <u>means tThe development and application of those capabilities necessary to protect for the protection of the public and the environment from the effects of an accidental or uncontrolled exposure dose or release of radioactive materials, including the equipping, training and periodic retraining of emergency response personnel.</u>

- <u>002.03</u> <u>ENVIRONMENTAL SURVEILLANCE AND IMPLEMENTATION.</u> <u>Environmental surveillance and implementation means t</u>The development and application of those capabilities necessary to assess the radiological impact of activities conducted by licensees and registrants on public health and safety and the environment.
- 002.04 FACILITY. means aAny facility other than that defined in this subsection.
- 002.05 FIXED NUCLEAR FACILITY. means A fixed nuclear facility includes:
  - (A) Any nuclear reactor(s) at a single site;
  - (B) Any facility designed or used for the assembly or disassembly of nuclear weapons; and
  - (C) Any other facility using or possessing source material, special nuclear material, byproduct material, and/or any other radioactive material for which the Department conducts off-site environmental surveillance to protect the public health and safety or the environment.

# **18-**003. EXEMPTIONS.

<u>18-003.01</u> No application or annual fee will be required for any carrier, transporting any of the materials described in the Radiation Control Act in the ordinary course of such carrier's business the Department of Health and Human Services, Office of Radiological Health.

18-003.02 No fee will be required for the Department of Health and Human Services.

### 48-004. PAYMENT OF FEES.

- <u>18-004.01</u> <u>APPLICATION FEES.</u> Each application for a license or certificate of registration for which a fee is prescribed will be accompanied by a non-refundable fee:
  - 4.(A) An application for a certificate of registration must be accompanied by the total fee for all applicable categories.;
  - 2.(B) Applications for new materials licenses, applications to reinstate expired, terminated or inactive licenses and applications for amendments to licenses that would place the license in a higher fee category or add a new fee category must be accompanied by the prescribed application fee for each category.
  - 3.(C) No application will be accepted for filing or processing prior to full fee payment, as specified, and the application will be returned to the applicant.; and
  - 4.(D) All application fees will be charged irrespective regardless of the Department's disposition of the application or a withdrawal of the application.

# 18-004.02 ANNUAL FEES FOR LICENSES AND CERTIFICATES OF REGISTRATION. The following applies to annual fees for licenses and certificates of registration:

- 4.(A) A non-refundable fee as specified in 180 NAC 18-005 or 18-008 must be paid in full each year on or before the last day of the <u>license or certificate of registration</u> expiration anniversary month; of the license or certificate of registration.
- 2.(B) In the case of a single license which authorizes more than one category of use, an annual fee must be paid for each category applicable to the license.
- 3.(C) In the case of a registration for radiation generating equipment, an annual fee must be paid for each machine at a facility.

- 4.(D) In the case of services for radiation generating equipment which authorizes more than one category, annual fees must be paid for each category applicable to the registration-; and
- 5.(E) An application for an amendment to a license or certificate of registration which results in a change to a category with a higher annual fee will result in a fee being charged equal to the prorated difference between the fee for the current category and the one to which the amended license or certificate will escalate.
  - a.(i) The prorated costs will be based on monthly intervals and will be charged from the first day of the month the amendment is effective until the end of the current billing period.
  - b.(ii) The Department will bill the licensee or registrant for the prorated portion of the applicable annual fee.; and
  - c.(iii) The replacement of part(s) or parts for an existing radiation machine will not result in an additional fee.

# 48-004.03 RECIPROCITY FEES. The applicable annual fee must accompany each application for:

- 4.(A) Each application for rReciprocal recognition of an out-of-state radioactive materials license under 180 NAC 3-028 must be accompanied by the applicable annual fee.; and
- 2.(B) Each application for rRecognition of an out-of-state registration under 180 NAC 2-012 must be accompanied by the applicable annual fee, provided that no such fee has been submitted within 12 months of the date of commencement of the proposed activity.

# 18-004.04 ENVIRONMENTAL SURVEILLANCE FEES. This fee will recover the expenses arising from environmental surveillance and implementation activities:

- 4.(A) Each holder of a fixed nuclear facility construction permit or operating license, or an operator of any other fixed nuclear facility, or any other facility as defined in 180 NAC 18-002 must submit the fee according pursuant to 180 NAC 18-009 for services received; and
- 2. This fee will recover for the, Department of Health and Human Services, the expenses arising from environmental surveillance and implementation activities.
- 3.(B) Payment must be made within 60 days following the invoice date of invoice.

# 18-004.05 EMERGENCY PLANNING, EMERGENCY RESPONSE AND IMPLEMENTATION FEES. This fee will recover expenses that arise from emergency planning, response, and implementation activities:

- 4.(A) Each holder of a fixed nuclear facility construction permit or operating license, or an operator of any other fixed nuclear facility, or any other facility as defined in 180 NAC 18-002 must submit the fee, <u>according pursuant</u> to 180 NAC 18-010, for services received.
- 2. This fee will recover for the Department of Health and Human Services, the expenses arising from emergency planning, emergency response and implementation activities.
- 3.(B) Payment must be made within 90 days following the invoice date of invoice.

**18**-009. ENVIRONMENTAL SURVEILLANCE FEES: Whenever the Department conducts environmental surveillance the full cost of the service will be charged:

**18**-010. EMERGENCY RESPONSE FEES: Whenever the Department provides emergency response capability a fee will be charged equal to the cost, to include personnel, equipment and supplies.

48-011. NUCLEAR POWER PLANT FEES. The Department will collect a fee for emergency response or environmental surveillance, or both, offsite from each nuclear power plant equal to the cost of completing the emergency response or environmental surveillance and any associated report. In no event will the fee for any nuclear power plant exceed the lesser of the actual costs of such activities or \$53,000 per annum. Commencing July 1, 1997, the accounting division of the Department of Administrative Services will recommend an inflationary adjustment equivalent which will be based upon the Consumer Price Index for All Urban Consumers of the United States Department of Labor, Bureau of Labor Statistics, and will not exceed 5% per annum. The adjustment will be applied to the annual fee for nuclear power plants. The fee collected will be credited to the Department of Health and Human Services Cash Fund. This fee will be used solely for the purpose of defraying the direct costs of the emergency response and environmental surveillance at Cooper Nuclear Station and Fort Calhoun Station conducted by the Department. The Department may charge additional fees when mutually agreed upon for services, training, or equipment that are a part of or in addition to matters in 180 NAC 18-011. The fees for nuclear power plants are as provided in Nebraska Radiation Control Act, Neb. Stat. Rev. §§ 71-3505 (1) (g) – 71-3505 (2).

# 18-012 FAILURE TO PAY PRESCRIBED FEES

<u>18-012.01</u> In any case where the Department finds that an applicant for a license or certificate of registration has failed to pay the fee, the Department will not process that application until the fee is paid.

<u>18-012.02</u> In any case where the Department finds that a licensee or registrant has failed to pay a fee by the due date, the Department may implement the appropriate compliance procedures.

18-012.03 In any case where the Department finds that a fixed nuclear facility has failed to pay fees for environmental surveillance and/or emergency planning, emergency response and implementation pursuant to contract within 90 days following date of invoice, the Department may issue an order to show cause why the services should not be terminated for breach of contract.

<u>18-012.04</u> In the event the Department has performed services for or expended funds on behalf of a person who has not reimbursed the Department after demand, then the Department may take appropriate legal action to recover amounts.
