On October 4, 2016, the Commission entered an order opening the above-captioned proceeding to amend Title 291, Chapter 7, Transmission Lines Rules and Regulations, to adopt the 2017 edition of the National Electrical Safety Code as the official rules of the Commission for the construction, operation, and maintenance of overhead and underground electric transmission lines.

APPENDIX A

1. Amend rule 001.01 to read as follows:

Ool. Ol Power Lines to Comply with National Electrical Safety Code: For the purposes of implementing Chapter 75, Article 7, of the Reissue Revised Statutes of Nebraska, 1943, Transmission Lines Rules and Regulations, the 2012/2017 edition of the National Electrical Safety Code as modified by the Commission (and incorporated herein by reference and available for viewing at the Nebraska Public Service Commission, 300 The Atrium, 1200 "N" Street, Lincoln, Nebraska 68508) shall be the official rules of the Commission for the construction, operation, and maintenance of overhead and underground electric transmission lines, except when such rules and regulations conflict with the laws of Nebraska or the special rules and regulations of the Commission.
