### BY THE COMMISSION:

On June 12, 2020, Cooperative Producers, Inc. (Applicant), Hastings, Nebraska, filed an application with the Nebraska Public Service Commission (Commission) seeking termination of a storage contract on corn stored in its facility by Gary Garman, Burr Oak, Kansas, pursuant to Neb. Rev. Stat. § 88-544 (Reissue of 2014) and Commission Rules and Regulations, 291 NAC 8, § 002.13 (2018). The Applicant submitted a "Storage/D.P. Charges Report" evidencing the corn stored at its facility pursuant to the storage contract.

Applicant stated in its application that the reason for this action was that the storage charges due have exceeded the value of the corn remaining in storage as represented on the scale tickets. As of May 31, 2020, the value of the corn was \$514.11 and the storage charges due were \$652.91.

### O P I N I O N   A N D   F I N D I N G S

Upon consideration of the application, the Commission finds that Cooperative Producers, Inc. has filed a proper request to terminate the storage contract on grain owned by Gary Garman. The information presented in the application sufficiently states the reasons behind the requested termination. The Commission therefore finds that the application should be granted and the storage contract terminated.

### O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. GW-1154, be and is hereby, granted,
