BY THE COMMISSION:

Upon the verified Complaint of Terri Fritz, Grain Director, Grain Warehouse Department ("Complainant"), filed on June 7, 2023, Norag LLC, Stillwell, Kansas ("Respondent"), is alleged to be in violation of Title 291 Neb. Admin. Code, Chapter 8, § 003.03 for failing to meet maintain a minimum allowable net worth of \$10,000 and to be in violation of Title 291 Neb. Admin. Code, Chapter 8, § 003.03I for failing to maintain suitable working capital.

Included in Complainant's requests for relief, Complainant seeks temporary suspension of Respondent's grain dealer license. Pursuant to Neb. Rev. Stat. § 75-903.01, if the Commission determines that the public good requires it, the Commission may, after the filing of a complaint and without hearing, temporarily suspend a grain dealer's license pending the determination of a complaint. The Complaint alleges that the Respondent is financially deficient and not in compliance with the rules and regulations governing grain dealer licensure in the State of Nebraska. Based on the allegations contained in the Complaint and the potential risk associated therewith, the Complainant seeks an Order Temporarily Suspending Norag LLC's grain dealer's license.

Based on the above, the Commission finds that the public good requires the license granted to Norag LLC in GD-3032 to be temporarily suspended pending the determination of the Complaint filed in GDC-454.
