BY THE COMMISSION:

Upon the verified complaint of John A. Fecht, Director, Warehouse Department (Complainant), filed on July 8, 2013, George Pfeifer d/b/a George Pfeifer Trucking, Spencer, Nebraska (Respondent) was alleged to be in violation of The Grain Dealer Act, Neb. Rev. Stat. § 75-901 et seq. (2008) (The Act) by failing to maintain Commission financial requirements.

Complainant seeks civil penalties, temporary suspension of Respondent's grain dealer license, and after hearing, revocation of Respondent's grain dealer license pursuant to Neb. Rev. Stat. § 75-910 and Neb. Admin. Code, Title 291, Ch. 8 § 003.10. Public Hearing should be set on the matter. The Commission finds that hearing shall be held on **August 14, 2013 at 10:00 a.m.** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska in conjunction with the hearing on Application No. GD-2930/GDC-437.
