BY THE HEARING OFFICER:

On June 1, 2020, Black Hills Nebraska Gas, LLC, d/b/a Black Hills Energy ("Black Hills" or "Applicant") filed an application seeking a general rate increase. On July 13, 2020, the procedural schedule was set by order of the hearing officer. This schedule included the announcement of town hall meetings, to be held during the week of September 21 - 26, via webconference. At the time of the scheduling order, the dates and times of the town hall meetings were undecided. On August 5, 2020, dates and times for the town hall meetings were set via hearing officer order; however, since that date, the need to reschedule the town hall meetings has arisen.
