BY THE COMMISSION:

On January 26, 2021, in Commission Docket NG-109, the Commission entered an order approving a general rate increase for Black Hills Nebraska Gas, LLC, d/b/a Black Hills Energy ("Black Hills"), of Rapid City, South Dakota. The order in Docket NG-109 approved a stipulation reached between Black Hills and the Public Advocate ("Stipulation"). Pursuant to that Stipulation, Black Hills' existing System Safety and Integrity Rider ("SSIR")¹ was renewed for a period of five (5) years. Also, as part of that Stipulation, the parties agreed to modify tariff language applicable to the SSIR, including modifications to definitions of eligible projects, categories, and criteria.

The Commission hereby opens this docket for the purpose of reviewing and overseeing the SSIR for the 2022 program year. This docket will also allow Black Hills, the Public Advocate, and Commission staff to collaborate with regard to tariff language in advance of Black Hills' application for approval of projects for the 2022 program year.

The Commission further finds that it may be necessary to assess certain expenses associated with this docket to Black Hills pursuant to Neb. Rev. Stat. \S 66-1840. The Commission hereby provides notice to the utility that expenses related to this docket may be assessed.

¹ The SSIR was originally approved in Commission Docket No. NG-78, In the Matter of the Application of SourceGas Distribution LLC, Golden, Colorado, seeking an order authorizing it to put into effect a system safety and integrity rider tariff and a system safety and integrity rider charge (approved in part on Oct. 28, 2014).
