BY THE HEARING OFFICER:

On June 2, 2006, Kinder Morgan, Inc. (Kinder Morgan) filed an application seeking approval of a general rate increase. The application was published on June 6, 2006, in The Daily Record, and the 30-day protest and intervention period expired on July 7, 2006.

Petitions for Formal Intervention were timely filed by the Public Advocate and the Public Alliance for Community Energy (ACE). A petition for informal intervention was timely filed by Aquila Energy, Inc. d/b/a Aquila Networks (Aquila).

On October 10, 2006, pursuant to a Hearing Officer order entered October 4, 2006, Commissioner Vap held a workshop to seek input from the parties about the propriety of and procedures for including ratepayer comments and complaints in the record of the proceeding. All parties were represented at the workshop by counsel, either in person or via telephone.

OPINION AND FINDINGS

The Hearing Officer finds that the hearing in the above-captioned matter should include sites in various locations throughout the area that Kinder Morgan serves to facilitate comments from ratepayers. Pursuant to Commission Rules of Procedure, members of the public are permitted to make statements at a hearing without being required to file a protest or petition to formally or informally intervene. Neb. Admin. Code Title 291, Ch. 1, Rule 015.03.
