BY THE COMMISSION:

The Commission has received a letter from Harding & Shultz and an invoice dated February 23, 2007, for Public Advocate Consultant services cost associated with the above-captioned docket, totaling \$2,120.00. Commission staff has reviewed the invoice and found it to conform to the Agreement for the Base Public Advocate Services dated November 15, 2004, between the Commission and Harding, Shultz & Downs.

Effective May 14, 2007, the Nebraska Certificate of Convenience and utility assets of Kinder Morgan, Inc., were transferred to SourceGas Distribution, LLC (SourceGas), in accordance with approval rendered by this Commission in Application No. NG-0039.¹ Commission staff recommends the Commission approve assessment of the expenses reflected on the invoice to SourceGas, pursuant to Neb. Rev. Stat. sec. 66-1840.

O P I N I O N A N D F I N D I N G S

Upon the recommendation of the Commission staff, the Commission finds that assessment to SourceGas of the expenses reflected in the above-mentioned invoice from Harding, Shultz & Downs should be approved. The Commission further finds that the Commission should pay the invoice upon receipt of payment by SourceGas.
