BY THE COMMISSION:

By Application filed June 16, 2017, Nebraska Resources Company, LLC ("NRC") of Tulsa, Oklahoma, seeks to withdraw its certificate of authority to operate as a jurisdictional utility in the State of Nebraska and to cancel its tariff. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on June 22, 2017. No protests were filed; therefore, this Application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

By virtue of the authority granted by the Commission in Docket NG-0053 on September 9, 2008, NRC was given the authority to operate as a natural gas jurisdictional utility within the State of Nebraska. In an application received on June 16, 2017, NRC requested the withdrawal of its Certificate of Public Convenience and Necessity and Tariff within the State of Nebraska. Since the date of the authority was received, NRC has neither transported nor received revenues for transporting any natural gas, and has not served any natural gas meters. In the Application, NRC states it has not been able to develop a business plan that would enable it to operate in any reasonable economic manner, and therefore it has determined it is in its best interest to withdraw its certificate of authority in Nebraska.

Upon consideration of the request and being fully advised in the premises, the Commission finds the request to be reasonable and finds that NRC's Certificate of Public Convenience and Necessity to operate as a jurisdictional natural gas utility and applicable tariff should be cancelled.
