BY THE COMMISSION:

On January 15, 2008, Nebraska Resources Company, LLC, (Nebraska Resources) filed an application seeking a Certificate of Public Convenience and Necessity authorizing it to operate as a jurisdictional utility in Nebraska and approval of tariff. Notice of the Application was published in the Daily Record, Omaha, Nebraska on January 17, 2008.

The Nebraska Natural Gas Access and Supply Coalition (NNGAS) filed a Petition for Informal Intervention on June 13, 2008. Pursuant to Neb. Admin. Code, Title 291, Ch. 1 § 15.02, the Petition included a pre-filed statement of NNGAS' single witness as well as all exhibits to be offered at the hearing.

The Commission finds that the Petition should be granted and that NNGAS be designated an informal intervenor. Based upon the information filed with the Commission, an updated Service List for the above-captioned docket has been attached hereto as Appendix A.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Petition for Informal Intervention referenced herein shall be granted.

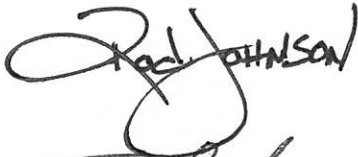

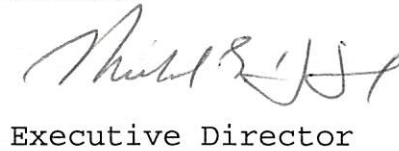
