BY THE COMMISSION:

On November 10, 2014, SourceGas Distribution LLC (SourceGas), Golden, Colorado, filed an application seeking authority to put into effect a System Safety and Integrity Rider Tariff and Safety and Integrity Rider Charge (SSIR) for recovery of 2015 eligible costs.

A Petition for Formal Intervention was filed by the Public Advocate on November 26, 2014. The Commission finds that the petition for formal intervention shall be granted.

Pursuant to the Commission's order in Docket NG-0078, consideration of the recovery of the 2015 costs through the SSIR is being reviewed on an expedited schedule. SourceGas and the Public Advocate have been cooperating in preliminary discovery prior to the expiration of the formal intervention deadline.
