On November 10, 2014, SourceGas Distribution LLC (SourceGas), Golden, Colorado, filed an application seeking authority to put into effect a System Safety and Integrity Rider Tariff and Safety and Integrity Rider Charge (SSIR) for recovery of 2015 eligible costs.

The Public Advocate's Petition for Formal Intervention was granted on December 9, 2014, and a planning conference was scheduled for December 15, 2014. The parties have since agreed to a schedule and hearing date. Therefore, no planning conference is necessary.
