BY THE COMMISSION:

On August 10, 2015, SourceGas Distribution, LLC (SourceGas Distribution), SourceGas Holdings, LLC (SourceGas), both of Golden, Colorado, and Black Hills Utility Holdings, Inc. (Black Hills), Papillion, Nebraska, filed a joint application seeking the necessary authorizations and approvals for Black Hills Holdings, Inc. to acquire SourceGas Holdings, LLC.

On August 14, 2015, a Petition for Formal Intervention was filed by Public Alliance for Community Energy (ACE) and the Nebraska Municipal Power Pool (NMPP). Additionally, on August 19, 2015, a Petition for Formal Intervention was filed by the Nebraska Public Advocate. The Commission finds that the Petitions for Formal Intervention shall be granted. Based upon the information filed with the Commission, an updated Service List for the above-captioned docket has been attached hereto as Appendix A.




O R D E R


