OPINION AND FINDINGS

On December 12, 2000, an application was filed by Peoples Natural Gas (Applicant) of Omaha, Nebraska, seeking resolution of a dispute pursuant to Neb. Rev. Stat. §§ 57-1302 to 57-1307 (1999 Supp.) and Title 291, Chapter 9 of the Nebraska Public Service Commission Pipeline Carriers Rules and Regulations. In conjunction with its application, the applicant also filed a Motion to Expedite Hearing.

February 7, 2001 - Answers to interrogatories and responses to requests for production are due.

February 21, 2001 - All discovery completed. Final witness list exchanged.

February 28, 2001 - Any stipulations and exhibits will be exchanged by the parties and filed with the Commission.

Finally, the hearing in this matter will be held on March 8, 2001, at 1:00 p.m. in the Sarpy County Courthouse, Sarpy County Board Room, 1210 Golden Gate Drive, Papillion, Nebraska.

Any remaining pre-hearing issues that the parties would like to address should be brought before the Commission prior to hearing.
