On or About March 5, 2013, the Commission entered an order requiring Great Call, Inc. (Great Call) to show cause as to why it should not be fined for failure to file a timely Enhanced Wireless 911 audit report.

Great Call submitted the required report on March 22, 2013. Great Call believed it had complied with the requirement by providing certain information in its NUSF audit report. However, due to a typographical error, certain notices to Great Call indicating that it had not complied were not received.

In light of the circumstances, the Commission finds that the Order to Show Cause should be dismissed and the hearing previously scheduled for April 16, 2013 be cancelled.




