OPINION AND FINDINGS

As part of its regulatory authority pursuant to the Enhanced Wireless 911 Services Act¹ (the 911 Act) the Commission has adopted requirements to verify the accuracy of Nebraska Universal Service Fund remittances. The Commission may require an audit of any wireless carrier's books and records concerning the collection and remittance of any amounts collected, pursuant to the 911 Act.²

Consistent with this statutory requirement, on July 31, 2012, the Commission adopted an amended audit policy. As required by that Order, remittance audits are to be performed by an independent third party, with audit results for a randomly selected audit period. In addition, consistent with that Order, the remittance audit was due on or before December 31st in the year the Commission notified the company of the audit requirement.

The company listed below either failed to timely file a complete audit report or failed to file an audit report altogether. Accordingly, the Commission finds it appropriate to initiate a Show Cause proceeding requiring:

Great Call, Inc.

to appear before the Commission at 300 The Atrium Building, 1200 N Street, Lincoln, Nebraska on **April 16, 2013** at 1:30 p.m. central time, and Show Cause why it failed to timely comply with the Commission's audit filing requirement and why the Commission should not impose administrative penalties against it pursuant to Neb. Rev. Stat. § 75-156 (2009) for failing to timely comply with the Commission rules and orders described herein.
