OPINION AND FINDINGS

The Nebraska Public Service Commission (Commission) opened this docket on its own motion June 6, 2006, seeking to establish audit requirements related to the Wireless Enhanced 911 Fund. On April 10, 2007, the Commission entered an Order adopting remittance policies and establishing a waiver mechanism for certain qualifying carriers. On July 31, 2012, the Commission entered an Order amending the audit policy and waiver mechanism with respect to the Enhanced Wireless 911 Fund.

This Order addresses the audit waiver requests received by the Commission for the audit due on December 31, 2018 from the following entities:

Mobius Communications Company
Pierce Telephone Co., Inc.
PNG Telecomm
Cause Based Commerce, Inc.
Google North America, Inc.
Ting, Inc.
GreatCall, Inc. dba Jitterbug

The Commission finds that Mobius Communications Company, Pierce Telephone Co., Inc., PNG Telecomm, Cause Based Commerce, Inc., and Google North America, Inc. have met all criteria established by the Commission in its July 31, 2012 order. The Commission therefore finds that the audit waiver requests of these entities should be granted for the E911 remittance audit otherwise due on December 31, 2018.

The Commission further finds that Ting, Inc. and GreatCall, Inc. dba Jitterbug, do not meet all criteria established by the Commission in its July 31, 2012, order. The Commission therefore

finds that the audit waiver requests of those entities **should be** denied for the E911 remittance audit due on December 31, 2018.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the waiver requests filed by Mobis Communications Company, Pierce Telephone Co., Inc., PNG Telecomm, Cause Based Commerce, Inc., and Google North America, Inc. related to the E911 remittance audit, due on December 31, 2016, are granted.

IT IS FURTHER ORDERED that the waiver requests filed by Ting, Inc. and GreatCall, Inc. dba Jitterbug related to the E911 remittance audit due on December 31, 2018, are denied.
