BY THE COMMISSION:

By written request for funding received from Scottsbluff County, Public Safety Answering Point, Gering, seeks funding from the Enhanced Wireless 911 Fund (Fund) for implementing and providing enhanced wireless 911 service.

In its application, Scottsbluff County seeks costs in the amount of **\$18,985.00** for five (5) years of maintenance of GeoLynx software for the period of August, 2007 through August, 2012, paid in annual installments. Scottsbluff County has entered into a contract with GeoComm, Inc. (GeoComm) for the maintenance of the software and has provided a copy of the contract with its request for funding.

The Enhanced Wireless 911 Advisory Board considered Scottsbluff County's request at its November 26, 2007 meeting and recommended that the Commission approve payment in the amount of **\$18,985.00** in annual installments over a five-year period. All amounts requested are consistent with GeoComm's response to the Commission's RFP. In its contract with GeoComm, Scottsbluff County authorizes the Nebraska Public Service Commission to remit payments directly to the vendor.

O P I N I O N       A N D       F I N D I N G S

This request for additional funding is being processed pursuant to Neb. Rev. Stat. §§ 86-442 to 86-470. (Cum. Supp. 2006), 291 Neb. Admin. Code, Chapter 1, Section 5, Progression Order No. 5 in Commission Docket No. 911-001, entered July 16, 2002 and the Interim Policy established in Progression Order No. 1 in Commission Docket No. 911-017/PI-116, entered February 13, 2007 (Interim Policy).

Costs requested are eligible under Neb. Rev. Stat. § 86-465 (2006 Supp.). All costs have been incurred or will be incurred for the provision of Phase II wireless enhanced 911 service.

The Commission finds that payment should be made to GeoComm in the amount of **\$18,985.00** paid in annual installments of **\$3,737.00** over a period not to exceed five years pursuant to the terms of the contract.

The Commission reserves the right to modify any costs associated with this funding request consistent with amendments to the Interim Policy or the establishment of a permanent funding mechanism. Any sums not paid by the Commission are the responsibility of the PSAP.

If the Nebraska Legislature fails to appropriate or authorize the expenditure of sufficient funds to provide for the payment of costs from the Fund or, if a lawful order issued in or for any fiscal year during the term of the contract reduces the funds appropriated or authorized in such amounts as to preclude making the payments from the Fund, the Commission will not be responsible for any costs not reimbursed by the Fund.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request for funding of Scottsbluff County shall be granted.

IT IS FURTHER ORDERED that the Commission shall remit to GeoComm from the Enhanced Wireless 911 Fund **\$18,985.00** paid in annual installments of **\$3,737.00** for a period not to exceed five (5) years subject to the limitations set forth herein.
