BY THE COMMISSION:

By written requests for funding received from Boone County, Albion, seeks funding from the Enhanced Wireless 911 Fund (Fund) for implementing and providing enhanced wireless 911 service.

In its application, Boone County seeks non-recurring costs in the amount of \$38,550.00 for the purchase and installation of software necessary for enhanced wireless 911 service. Boone County has entered into a contract with GeoComm, Inc. (GeoComm) for the purchase, installation, training, and one-year maintenance of GeoLynx software and has provided a copy of the contract with its request for funding.

Boone County also seeks reimbursement in the amount of \$38,550.00 for expenses already incurred for the purchase and installation of the software. Boone County has provided sufficient documentation to demonstrate that the expense has been incurred.

The Enhanced Wireless 911 Advisory Board considered Boone County's request at its March 23, 2007 meeting and recommended that the Commission approve payment in the amount of \$38,550.00. All amounts requested are consistent with GeoComm's response to the Commission's RFP.

OPINION AND FINDINGS

This request for additional funding is being processed pursuant to $\underline{\text{Neb}}$. $\underline{\text{Rev}}$. $\underline{\text{Stat}}$. $\underline{\text{SS}}$ 86-442 to 86-470. (Cum. Supp. 2006), 291 Neb. Admin. Code, Chapter 1, Section 5, Progression Order No. 5 in Commission Docket No. 911-001, entered July 16, 2002 and the Interim Policy established in Progression Order No. 1 in Commission Docket No. 911-017/PI-116, entered February 13, 2007 (Interim Policy).

Costs requested are eligible under $\underline{\text{Neb}}$. $\underline{\text{Rev}}$. $\underline{\text{Stat}}$. § 86-465 (2006 Supp.). All costs have been incurred or will be incurred for the provision of Phase II wireless enhanced 911 service.

The Commission finds that payment should be made to Boone County in the amount of \$38,550.00 pursuant to the terms of the contract for non-recurring costs. Boone County may request that payment be made directly to GeoComm.

The Commission reserves the right to modify any costs associated with this funding request consistent with amendments to the Interim Policy or the establishment of a permanent funding mechanism.

If the Nebraska Legislature fails to appropriate or authorize the expenditure of sufficient funds to provide for the payment of costs from the Fund or if a lawful order issued in or for any fiscal year during the term of the contract reduces the funds appropriated or authorized in such amounts as to preclude making the payments from the Fund, the Commission will not be responsible for any costs not reimbursed by the Fund.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request for funding of Boone County shall be granted.

IT IS FURTHER ORDERED that the Commission shall remit to Boone County from the Enhanced Wireless 911 Fund \$38,550.00 for non-recurring costs as described herein.
