BY THE COMMISSION:

By written request for funding dated February 7, 2007, Nuckolls County, Nelson, sought funding from the Enhanced Wireless 911 Fund for expenses for implementing and providing enhanced wireless 911 service. On May 8, 2007, the Commission entered an order approving funding in part in the amount of **\$91,830.40** and denying costs in excess of the vendor's response to the Commission's request for proposal (RFP) associated with labor in the amount of **\$9,537.00**, Miscellaneous Materials in the amount of **\$1,649.60** and Shipping in the amount of **\$1,823.00**.

Pursuant to the order, Nuckolls County notified the Commission in writing **within fifteen (15) days** that it wished to be heard regarding the portions of the funding request that were denied and hearing on the matter was held on June 12, 2007 at which time, representatives from Plant/CML, Nuckolls County's vendor, offered testimony regarding the reasons for the differences between the request for funding and response to the RFP.

Based upon the explanations offered at the hearing on this matter, the Commission finds that the amounts previously denied totaling **\$13,009.60** should be approved for funding.

The Fund shall therefore pay to Nuckolls County, in addition to the amounts previously approved, the amount of **\$13,009.60** consistent with the terms of this order and the amounts set forth in Appendix A. Payments shall be made in accordance with the progress of payments set forth in the contract.

Nuckolls County may request that any amounts approved herein be paid directly to the vendor.

Prior to any payment being made to or on behalf of Nuckolls County, Nuckolls County shall submit to the Commission a copy of its final contract for the equipment and services described

herein. Said contract shall be consistent with the amounts set forth in the funding request and approved herein.

The Commission reserves the right to modify any recurring costs associated with this funding request, including any approved amounts for maintenance, consistent with amendments to the Interim Policy or the establishment of a permanent funding mechanism.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Enhanced Wireless 911 Fund shall pay to Nuckolls County the amount of **\$13,009.60** consistent with the terms of this order and the amounts set forth in Appendix A for the equipment necessary to provide enhanced wireless 911 service.
