## BY THE COMMISSION:

By written request for funding dated January 8, 2007, Nuckolls County, Nelson, sought funding from the Enhanced Wireless 911 Fund for expenses for implementing and providing enhanced wireless 911 service.

In its application, Nuckolls County sought non-recurring costs in the amount of \$16,697.00 for the purchase and installation of equipment and software necessary to implement enhanced wireless 911 service. The PSC 16 upgrade is necessary to allow the PSAP to receive, process and display wireless Phase I and II data.

Nuckolls County has provided supporting documentation for the equipment and associated expenses.

## OPINION AND FINDINGS

This request for funding is being processed pursuant to <a href="Neb">Neb</a>. <a href="Rev">Rev</a>. <a href="Stat">Stat</a>. <a href="Stat">Stat</a>. <a href="Stat">Stat</a>. <a href="Stat">Section 5</a>, and Progression Order No. 5 in Commission Docket No. 911-001, entered July 16, 2002.

Costs requested are eligible under  $\underline{\text{Neb}}$ .  $\underline{\text{Rev}}$ .  $\underline{\text{Stat}}$ . § 86-465 as all costs have been incurred or will be incurred for the purchase, installation, maintenance or operation of telecommunications equipment and telecommunications services required for the provision of enhanced wireless 911 service.

Based upon the request for funding and supporting documentation, the Commission is of the opinion and finds that the upgrade is necessary to process a Phase II wireless 911 call. Therefore, the Commission finds that the request for funding should be granted in the amount of \$16,697.00.

The Fund shall therefore pay to Nuckolls County the amount of \$16,697.00.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Enhanced Wireless 911 Fund shall pay to Nuckolls County the amount of \$16,697.00 consistent with the terms of this order for the equipment necessary to provide Phase II enhanced wireless 911 service.
