O P I N I O N A N D F I N D I N G S

On November 13, 2014, Sue Vanicek, Director of the Nebraska Telecommunications Infrastructure and Public Safety Department of the Nebraska Public Service Commission (NTIPS) (hereinafter "Complainant") of the Nebraska Public Service Commission (Commission) filed a Complaint against Consumer Cellular, Inc., Portland, Oregon (hereinafter "Respondent") alleging that Respondent failed to file its Quarterly Report pursuant to Neb. Rev. Stat. § 86-459(2)(2014) due October 15, 2014.

Since the filing of the complaint, Respondent has filed the appropriate report and signed a stipulation agreeing to the payment of a fine in the amount of \$3,300.00 and administrative costs of \$100.00 for the Complaint. Respondent has paid the fine and administrative costs. Respondent is on notice that should it fail to timely make future filings that additional administrative fines and costs may be imposed.

The Commission finds that the stipulation should be approved and that the Complaint should be dismissed against Respondent. The hearing previously set for **February 10, 2015** at 1:30 p.m. is canceled. Respondent is released from any further proceedings in relation to Application No. 911-030.40.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Complaint in Application Nos. 911-030.40 and it is hereby dismissed and that the stipulation is approved.

IT IS FURTHER ORDERED that the hearing in this matter scheduled for **February 10, 2015** be, and it is hereby, canceled.
