BY THE HEARING OFFICER:

Upon the complaint of Sue Vanicek, Director of the Nebraska Telecommunications Infrastructure and Public Safety Department of the Nebraska Public Service Commission, (Complainant), Cozac Wireless, LLC d/b/a Movida Communications, Kansas City, Missouri (Respondent) is alleged to be in violation of Neb. Admin. Code, Title 291, Ch. 5 § 005.07 as outlined in the departmental complaint. A copy of the complaint was served on Respondent via certified mail on May 4, 2009. No Answer was filed.

A hearing on this matter was scheduled for August 4, 2009, in conjunction with hearings on Docket Nos. 911-030.31 and NUSF-37.189. However, Commission staff is currently working with Respondent to settle any and all complaints.

Therefore, the hearing officer finds that the hearing should be continued to **September 22, 2009 at 1:30p.m.** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska. This hearing will be held in conjunction with hearings on Docket Nos. 911-030.31 and NUSF-37.189.
