BY THE COMMISSION:

Upon the complaint of Sue Vanicek, Director of the Nebraska Telecommunications Infrastructure and Public Safety Department of the Nebraska Public Service Commission, (Complainant), Cozac Wireless, LLC d/b/a Movida Communications, Kansas City, Missouri (Respondent) is alleged to be in violation of Neb. Admin. Code, Title 291, Ch. 5 § 005.07 as outlined in the departmental complaint. A copy of the complaint was served on Respondent via certified mail on May 4, 2009.

The complaint alleges that Respondent failed to file Wireless E911 remittance worksheets or remittance payments to the Nebraska Telecommunications Infrastructure and Public Safety Department by the 60th day following the end of the remittance period(s), for **July, 2008; October, 2008; November, 2008; January, 2009, and February, 2009** pursuant to Neb. Admin. Code, Title 291, Ch. 5 § 005.07. Further, the complaint requests that the Commission impose on Respondent civil fines and administrative costs. To date no Answer has been filed.

Respondent should be ordered to Show Cause why the Commission should not assess penalties and administrative costs pursuant to Neb. Rev. Stat. § 75-910. Furthermore, the matter should be scheduled for hearing on **August 4, 2009, 2:00 p.m.** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska. This hearing will be held in conjunction with hearings on Docket Nos. 911-030.31 and NUSF-37.189.

IT IS FURTHER ORDERED by the Nebraska Public Service Commission, that a hearing be held, on this matter on **August 4, 2009, 2:00 p.m.** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska. This hearing will be held in conjunction with hearings on Docket Nos. 911-030.31 and NUSF-37.189.
