On January 17, 2018, David A. Sankey, Director of the Nebraska State 911 Department (hereinafter "Complainant") of the Nebraska Public Service Commission (Commission) filed a Complaint against Flash Wireless, LLC, (hereinafter "Respondent") alleging that Respondent failed to timely file its wireless E911 remittance worksheets or remittance payments to the Nebraska State 911 Department for February, 2013, March, 2013, April, 2013, May, 2013, June, 2013, July, 2013, August, 2013, September, 2013, October, 2013, November, 2013, December, 2013, January, 2014, February, 2014, March, 2014, April, 2014, May, 2014, June, 2014, July, 2014, August, 2014, September, 2014, October, 2014, November, 2014, December, 2014, January, 2015, February, 2015, March, 2015, April, 2015, May, 2015, June, 2015, July, 2015, August, 2015, September, 2015, October, 2015, November, 2015, December, 2015, January, 2016, February, 2016, March, 2016, April, 2016, May, 2016, June, 2016, July, 2016, August, 2016, September, 2016, October, 2016, November, 2016, December, 2016, January, 2017, February, 2017 and March, 2017 pursuant to Neb. Rev. Stat. § 86-442 et seq.

Respondent has filed the appropriate worksheets and/or payments. Since the filing of the Complaint, Respondent has signed a stipulation agreeing to the payment of a civil penalty and administrative costs. Respondent has paid the civil penalty and administrative costs. Respondent is on notice that should it fail to timely make future filings, that additional administrative fines and costs may be imposed.
