BY THE COMMISSION:

The Nebraska Public Service Commission opened the present docket on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service for Dodge County.

On or about April 5, 2013, the Dodge County 911 Board (Dodge County) filed a request to use wireless enhanced wireless funds for the purchase of a new enhanced wireless 911 equipment including a VIPER system at a total cost of \$158,793.16, a logging recorder at a cost of \$21,065.35, and a UPS at a cost of \$16,315.00. Dodge County seeks to use its set aside funding in the amount of \$143,204.55 and an additional advance against future funding in the amount of \$49,542.81 to cover 79% of the total cost consistent with its wireless/wireline call ratio for the 2012-2013 funding year.

The Commission finds that this matter should be set for hearing on **May 22, 2013 at 10:00 a.m.** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln. The Commission finds that the hearing shall be held immediately following the hearing on Washington County's request.


