O P I N I O N      A N D      F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 2, 2010, Clay County filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. Clay County further supplemented their application on April 26, 2010.

Clay County, which services the areas of Clay County, is eligible for funding in the amount of \$28,306.04 for the 2010-11 funding year. Clay County has indicated that it anticipates using the funding provided for the following purposes: sixty-eight percent (68%) of its 911 trunking charges payable to Windstream; sixty-eight percent (68%) of its service agreement with Wahltek for Communications Recording Systems; and five percent (5%) for training costs and, plans to set aside the remainder of its funding for future equipment and software upgrades and purchases.

Prior funding commitments in the amount of \$13,466.64 were previously approved and must be deducted from the allocation.

Based upon the above, the Commission finds that funding request for Clay County in the amount of \$14,839.40 should be approved consistent with the allocation determined in Docket 911-019/PI-118.

Pursuant to Docket 911-019/PI-118, Clay County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than

October 15 following the close of the funding year. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for Clay County is hereby approved as set forth herein in the amount of \$14,839.40.

IT IS FURTHER ORDERED that Clay County submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with the terms of the order approving the permanent funding mechanism and process in Docket 911-019/PI-118 entered on February 23, 2010.
