O P I N I O N      A N D      F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.<sup>1</sup>

On April 9, 2012, Kimball County filed its application for funding with the Commission pursuant to Neb. Admin. Code Title 291, Ch. 15 § 007.01. Kimball County serves Kimball County.

Pending resolution of the issues currently being considered in Docket No. 911-019/PI-118<sup>2</sup>, Kimball County is eligible for interim funding in the amount of \$22,845.52 for the 2012-13 funding year. This amount reflects the deduction of pre-existing commitments totaling \$3,000.00. Kimball County has indicated that it anticipates using the funding provided for the following purposes: upgrades to 911 telecommunications equipment and mapping and the maintenance of the equipment. The County does not plan to set aside any portion of its funding for future equipment and software upgrades and purchases.

Based upon the above, the Commission finds that funding request for Kimball County in the amount of \$22,845.52 should be approved consistent with the allocation previously approved by the

All PSAPs are subject to audit.
