O P I N I O N A N D F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.¹

On April 13, 2012, Saline County filed its application for funding with the Commission pursuant to Neb. Admin. Code Title 291, Ch. 15 § 007.01. Saline County serves Saline County,

Pending resolution of the issues currently being considered in Docket No. 911-019/PI-118², Saline County is eligible for interim funding in the amount of \$36,653.29 for the 2012-13 funding year. This amount reflects the deduction of pre-existing commitments totaling \$4,236.00. Saline County has indicated that it anticipates using the funding provided for the following purposes: support contracts for hardware, software and GIS software, mapping updates, 911 hardware and software, training and telephone service. The county plans to set aside 75% of its funding for future equipment and software upgrades and purchases.

Based upon the above, the Commission finds that funding request for Saline County in the amount of \$36,653.29 should be approved consistent with the allocation previously approved by the Commission in Application No. 911-019/PI-118³. Saline County shall receive monthly payments in the amount of \$3,332.12 until

All true-ups will be made retroactively to July 1, 2012.

Saline County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

O R D E R
