O P I N I O N       A N D       F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On May 10, 2010, the Fillmore County Sheriff's Office (Fillmore County) filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. The deadline for the filing of all applications for funding was April 23, 2010.

Fillmore County, which services the areas of Fillmore County, is eligible for funding in the amount of \$27,721.32 for the 2010-11 funding year. Fillmore County has indicated that it anticipates using the funding provided for the following purposes: recording system and tower maintenance, and plans to set aside about seventy-five percent (75%) of its funding for future equipment and software upgrades and purchases.

Prior funding commitments in the amount of \$6,404.40 were previously approved and must be deducted from the allocation. Furthermore, the Commission finds that due to the late filing of its application, Fillmore County's total annual allocation should be reduced in an amount equal to one month's payment in the amount of \$1,776.41. The monthly payments shall be recalculated based upon the reduced annual allocation. Such a reduction is necessary as a matter of fairness to those PSAPs who filed applications in a timely manner.

Based upon the above, the Commission finds that funding request for Fillmore County in the amount of \$19,540.51 should be approved consistent with the allocation determined in Docket 911-019/PI-118.

Pursuant to Docket 911-019/PI-118, Fillmore County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for the Fillmore County Sheriff's Office is hereby approved as set forth herein in the amount of \$19,540.51.

IT IS FURTHER ORDERED that Fillmore County submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with the terms of the order approving the permanent funding mechanism and process in Docket 911-019/PI-118 entered on February 23, 2010.
