O P I N I O N      A N D      F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.<sup>1</sup>

Seward County began receiving interim funding in the amount of \$28,644.96 for the 2012-13 funding year. This amount reflected the deduction of pre-existing commitments totaling \$15,444.00. Interim payments were made with the understanding that any adjustments made as a result of issues being considered in Docket No. 911-019/PI-118<sup>2</sup> would be retroactive to July 1, 2012.

On September 18, 2012, the Commission entered an order in Docket No. 911-019/PI-118 resolving the outstanding issues resulting in adjustments to PSAP funding.<sup>3</sup> Based upon those adjustments and the modification of certain pre-existing payments for some PSAPs, the Commission finds that Seward County is approved for a total funding amount of \$74,278.89 for the 2012-2013 funding year. An adjustment was made in the amount of \$5,208.18 to account for amounts already received for the current funding year. Additional adjustments were made to reimburse the

PSAP for \$2,574.00 withheld as a pre-existing commitment for the 2010-2011 funding year and \$15,444.00 withheld as a pre-existing commitment for the 2011-2012 funding year. An adjustment was made in the amount of \$12,231.50 to reimburse the enhanced wireless 911 fund for an advance to purchase equipment and/or software. Calculations for individual PSAPs are available via the Commission's website.

Therefore, Seward County shall receive a total of \$74,857.21 to be paid in monthly installments in the amount of \$8,317.47 for the remaining nine (9) months of the 2012-2013 funding year.

Seward County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding for the Seward County is hereby adjusted as set forth herein.

IT IS FURTHER ORDERED that Seward County must submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008.

IT IS FURTHER ORDERED that Seward County must submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008.
