O P I N I O N A N D F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.¹

On April 12, 2012, Thurston County filed its application for funding with the Commission pursuant to Neb. Admin. Code Title 291, Ch. 15 § 007.01. Thurston County serves Thurston County.

Pending resolution of the issues currently being considered in Docket No. 911-019/PI-118², Thurston County is eligible for interim funding in the amount of \$24,953.41 for the 2012-13 funding year. This amount reflects a deduction for pre-existing commitments in the amount of \$6,000.00. Thurston County has indicated that it anticipates using the funding provided for the following purposes: maintenance contracts and training. The county plans to set aside any remainder of its funding for future equipment and software upgrades and purchases.

Based upon the above, the Commission finds \$24,953.41 should be approved consistent with the allocation previously approved by the Commission in Application No. 911-019/PI-118³. Thurston County shall receive monthly payments in the amount of \$2,268.49

All true-ups will be made retroactively to July 1, 2012.

Thurston County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.
